The day's proceedings began with recitation from the




Tofael Ahmed (AL-Bhola) said the matter was a very important national issue. He said Menon had rightly raised the issue in an appropriate time.

Samad introduced the 11th Constitution (Amendment) Bill, 1991 in the House.

As the Speaker announced that the bill was introduced in the House, Samad sought permission of the Chair to speak on the amendment bill, But the Speaker wanted to know under which rule of the rules of procedure Samad wanted to speak.

Samad took the floor and started saying some thing but he was interrupted, on a point of order by State Minister for Food Najmul Huda. There was a Pandemonium in the House and most of the opposition members rose to draw attention of the Chair.

The Speaker gave the floor to Tofael Ahmed for a short comment.

Tofael Ahmed, terming the day historic and memorable, said that Samad introduced a long-cherished amendment bill for which the entire nation was waiting. He said, we got this occasion following a long struggle in which many people had to make their supreme

Tofael Ahmed said, the day before yesterday, the Leader of the House Prime Minister Begum Khaleda Zia had introduced a historic constitutional amendment bill. The Speaker had than allowed Begum Zia to make a statement prior to introducing the bill. Not only that, Tofael said, the Speaker

allowed a long discussion on the bill as it was very important for the nation.

Tofael Ahmed said, exactly for the same reason the bill placed by Samad at the Sangsad Thursday is equally important for the nation. Considering the importance of the occasion, he sought permission of the Chair to allow Samad to speak something on the bill.

The Speaker gave the floor to Abdus Samad Azad with a request to make a brief statement on the bill.

The Deputy Leader of the Opposition thanked the Speaker and greeted the Law Minister for the gesture he had shown. He also thanked the members of the Treasury Bench and leaders and members of all the parties for allowing him to introduce the bill without any objection.

He said, "we don't want to rack up the past, but want to move forward." He said care was taken to avoid inclusion of controversial matters in the

Abdus Samad Azad said it Chowdhury said the subject was not only the three alwalks of life including students and workers who took part in the anti-autocracy movement.

He said it was the joint declaration of the three alliances that the power would be trans ferred to a sovereign Parliament elected through free and fair elections to put an end to the politics of conspiracy and killing and keep up the spirit of the liberation

He said it was expected that the ruling party would take the initiative first for the constitutional amendment to go back to the Parliamentary form of government, but to no effect.

He said the Leader of the Opposition deserved praise for her role in taking up the move for the required constitutional change to go back to parliamentary democracy.

Abdus Samad Azad said the submitted Constitution Amendment Bill at the Parliament secretariat first on April 14 this year. He said the Acting President also approved it. He said, "ours was the first Constitution Amendment Bill after the tenth amendment

He said after crossing all the impediments we have reached a position. He said the BNP has also at last brought the constitution amendment bill seeking to replace the Presidential form with the Parliamentary system. He said although the constitution amendment proposed by us should been allowed to be introduced first in the House,

but it was not done so. He said today is a great day and democracy must be ensured in the country. He said people want the establishment of democracy in Bangladesh adding that some people were also at work to undo it. He said we must work unitedly to foil

all these conspiracies. In this connection the Deputy Leader of the Opposition referred to the statement of Col (Retd) Faruk Rahman and said the self-confessed killer Faruk, who is still living in this country, expressed their support to retain the existing presidential system. He said, "we must be on guard to frustrate this sort of conspiracy.

He said Sheikh Hasina proved her greatness by working relentlessly for the introduction of the Constitution Amendment Bill by knowing perfectly well that it was not she but Begum Khaleda Zia who will be the Prime Minister of the country's majority party leader.


After the lunch break when the House resumed in the afternoon, the Speaker gave his ruling regarding the serial number of the Constitution Amendment Bill introduced to the House by Abdus Samad

In his ruling the Speaker said that he had examined the views of Law and Justice Minister Mirza Golam Hafiz to the effect that the Amendment bill brought by Abdus Samad Azad should be serialised as the 13th instead of 11th Amendment Bill.

The Speaker said, two bills entitled 11th Amendment and 12th Amendment had already been introduced to the Sangsad on July 2. Hence the bill submitted today by Abdus Samad Azad should be serialised as the 13th and not 11th Amendment Bill. He further said this correction would be applicable to all relevant places of the bill submitted by

Samad said, the bill he had introduced today had been submitted two and a half months earlier then the government bill. Moreover the House select committee and the Ministry of Parliamentary Affairs and the Ministry of Law and Justice also cleared the bill as 11th amendment. Finally the Acting

Samad said, in any case only one bill would be passed. The question of serial number would come next. Samad said, we will sit together in this House and would take a historic decision on this vital point of constitutional amendment.

Delwar Hossain

Taking the floor next Chief Whip of the House Khandkar Delwar Hossain said that placing of different bills under a same serial was not permissible on Constitution ground. He also cited some provisions of the Constitution to this effect.

Hossain said, we have reached a national consensus for switching over to parliamentary form of government and we should not do anything before reaching that goal which could disrupt the pro-





first to submit the Constitution Amendment Bill on April 14 for switching over to parliamentary system in fulfillment of our pledge to the people. But the Treasury Bench submitted a similar bill much later using the title of ours. Our bill had been processed by the Law Ministry as 11th Constitution Amendment Bill. The select committee had okayed it under the same title. The Acting President had also recommended it the same way and even it has been introduced before the House in the morning sitting Thursday as the 11th Constitution Amendment Bill, she added.

She further pointed out that the Constitution Amendment Bill of the ruling party was introduced before the Sangsad on July 2 in only two days notice although the rule required atleast seven days' notice. We could question this irregularity, but we did not. Under the Constitution, each of the 330 members of this Sangsad could bring in various amendments to the Constitution under the

same title, she said. But the Speaker disagreed with her observation.

Sheikh Hasina argued that the title of any amendment could not be changed before its adoption. She said the opposition was keen to create a congenial atmosphere and a climate of understanding in the House to fulfil the hopes and aspirations of the people.
