When the House re-assembled after Asr prayer with Deputy Speaker in the chair, Law and Justice Minister Mirza Gholam Hafiz said the select committee entrusted with the responsibility of studying the seven Constitution amendment bills had not yet been able to complete its work though it was to submit its report to the House today. He, therefore,

sought the permission of the House to extend the time limit for submitting its report by another four days. Deputy Leader of the Opposition, Abdus Samad Azad, supported the proposal of the Law Minister and it was carried out unani-Soon after Awami League

leader Tofael Ahmed pleaded for sending the bill of Awami League member Salauddin Yusuf seeking separation of the judiciary from the executive to the select committee. But the Deputy Speaker said how a bill which had not yet been introduced in the House could be sent to the select committee. A decision on this bill could be taken only after its introduction in the House, he added. Gonotantree Party Leader.

Suranjit Sengupta, supported the contention of Tofael Ahmed. So did Awami League member Asaduzzaman.

Salauddin Quader

National Democratic Party leader, Salauddin Quader Chowdhury, said five private members bills had been sent to the select committee by suspending the rules. He wanted to know from the chair which rules had been suspended for this purpose. He said many of the opposi-

tion members including himself had submitted amendments to the bills and wanted to know whether their amendments would be sent to the select committee.

Chief Whip Khandker Delwar Hossain said the House had unanimously decided to the seven constitution amendment bills to the select

committee. There was no scope now to question how the private members' bills had been sent to the select com-

In this connection, he referred to the Rules 25 and 316 of the Rules of Procedure. At this stage, the Deputy Speaker said the matter was disposed of by the Speaker.

Kh Delwar Hossain

Continuing. Khandker Delwar Hossain said it would be illegal to send a bill to the select committee which had not yet been introduced in the House.

Major (Rtd) Hafizuddin (Ind-Bhola) said he had submitted a constitution amendment bill which is similar to that of Rashed Khan Menon. "May I expect that my bill will be introduced in the House in a few days," he said.

The Deputy Speaker told Hafiz that this bill would be considered if it went through all formalities involved.

Thereafter several 'opposition members stood up at a time to submit their points of view. The Deputy Speaker told them that these all would be futile efforts and unnecessary

Shahjahan Siraj

JSD leader Shahjahan Straj called for sending his amendments to the bills to the select committee.

The Deputy Speaker said his proposal would be considered if there was provision.

Salauddin Yusuf

Awami League member Salauddin Yusuf said he had submitted a notice of a bill seeking the separation of the judiciary from the executive in keeping with the pledge of the three alliances and aspirations of the people. He pleaded for the introduction of his bill by suspending rules and sending it to the select committee. If it was not possible, the chair should see to it that his bill was introduced in the House next Thursday - the private members' day.

Taking the floor, CPB leader Shamsuddoha said the members had proposed

amendments to the seven bills which had been sent to the select committee.

He expressed the hope that even if there was limitation of time, the members would be allowed to discuss them in the

Speaking next, Moulana Abdus Sobhan (Jamaat-Pabna) said the Law Minister had stated that the members would be given the opportunity to participate in the discussion on the bills after the discussion in the select committee.

Mohiuddin Ahmed

BAKSAL leader Mohiuddin Ahmed referred to the amendments on the bills and wanted to know the present position from the Law Minister.

Abdus Samad Azad

Taking the floor Deputy Leader of the Opposition. Abdus Samad Azad referred to the bills sent to the select committee. He said the opposition did not know the viewpoints of the Treasury Bench on them.

The chair then asked the Law Minister if he had anything to say.

In reply to the queries from the opposition about the proposed bills, Mirza Golam Haftz said he wanted to abide by the rules of procedure. He, however, said that

there would be no problem as a friendly understanding between the Treasury and Opposition Benches had already developed in this regard.

Mirza Hafiz said all the bills. as referred by the opposition members, were private members' bills and those would come before the House in accordance with the rules of procedure.

M K Anwar

As the Law Minister resumed his seat. Shipping Minister M K Anwar with the permission from the chair made a brief statement replying a part of a question that remained unanswered during the question hour on July 10.

Going back to the order of the day, the Deputy Speaker disposed of the adjournment motion notices and admitted one of them as a call attention notice under Rule 68 of the

Rules of Procedure submitted by Syed Najibul Bashar (AL-Chittagong) on the aftermath of the report of the inquiry commission on the situation in the Chittagong University.

The Deputy Speaker said he had received 40 call attention notices Sunday of which one was accepted.

The Deputy Speaker urged the members not to submit any notice on adjournment motion and call attention to facilitate general discussion on the national budget for fiscal 1991-

He said during the current session, 10 call attention notices were disposed of through discussions in the House while another eight were yet to be brought before the House.

The House was then adjourned for the Maghreb

Abdur Rahman Biswas

As the House resumed after the Magreb prayer, Speaker Abdur Rahman Biswas moved an obituary reference on Khan Saheb Sheikh Mosharraí Hossain who died on July 12 at Gopalgani at the age of 87.

Moving the obituary refer ence, the Speaker said Khan Saheb Mosharraf Hossain became a member of the then East Pakistan Provincial Assembly in 1962 and was elected to the Provincial Assembly for the second time in 1970 on Awami League ticket.

The Speaker said late Mosharraf Hossain discharged his responsibility as member of the Constituent Assembly after independence. He was a member of the Faridpur District Board during the British period and was the President of the Tungipara Patgati Union Board consecutively for long 25 years.

Biswas said late Hossain was also the Vice-Chairman of the then Red Cross and Chairman of Bangladesh Samabaya Samity. He was awarded the Khan Bahadur title by the British government for his outstanding social welfare works. He said Hossain also played an active role in the Liberation

The Speaker said at the death of Khan Saheb Sheikh Mosharraf Hossain, the country had lost an eminent politician. a Freedom Fighter and a parliamentarian.

The Jatiya Sangsad prayed for the peace of the departed soul and expressed sympathy to the members of the bereaved family.

After the House unanimously accepted the Speaker's obituary reference, he said a copy of the condolence motion would be sent to the members of the bereaved family of late Mosharraf Hossain.

One-minute silence was also observed as a mark of respect to the deceased and a munatat was offered seeking divine blessing for the peace of the departed soul. Moulana Motiur Rahman Nizami led the muna-

Syeda Begum Sajeda Chowdhury (AL-Faridpur) thanked the Speaker for having moved the obituary refer-

Rashed Mosharraf

On being asked by the chair, Haji Rashed Mosharrai (AL-Jamalpur) moved his call attention notice on "deception. by spurious organisations in giving employment to the unemployed youths."

Mosharraf said the unemployed youths are being deceived by spurious organisations which grew like a mushroom. He said these organisations, taking advantage of the sense of frustration in the educated and half-educated youths, exported money from them in the name of providing them with jobs. But, he said after realising huge amounts of money from them these fame organisations wind up their business abruptly.

He said some organisations under the garb of agro-fisheries, Sido and socio-economic organisations were engaged in this heinous activity for long. He said reports on their activities and stories of misappropriation of money by them were being regularly published in newspapers.

Tariqul Islam

In reply to the motion, the State Minister for Social Welfare and Women Affairs Tarigul Islam said although the matter was linked with the Ministry of Home he would reply to the queries of the mem-

He said warrants of arrest were issued against 13 people connected with Sido and five people were put under detention for 120 days. He said these people were later released by the High Court.

Taking the floor again, Haji Mosharraf said, the poor and the unfortunate youths were passing their days in utter dismay after losing Taka five to ten thousand each.

The State Minister firmly said actions against the spurious organisations would be taken after identifying them.

Initiating the discussion of the national budget, Harun-ar-Rashid (BNP-Brahamanbaria) congratulated the Finance Minister for presenting an "unprecedented" and "the best budget in post independence Bangladesh. "It is a new type of budget," he stated.

Minister for placing the national budget before Sangsad which was the result of nine years of struggle against the autocracy. But he regretted that there was no new path finding in the budget and said. the Finance Minister had thrown the entire nation into deep confusion by introducing the controversial "VAT" sys-

Terming the national budget, an important event of national life, Maulana Sobhan said, in the budget there was

no endeavour to get rid of the mis managements and errors of the past government.

He said, the law and order situation had fallen at such a level that total anarchy was prevailing in the country. The country is being run by the whims of the bureaucracy instead of the spirit of the oath we had taken, he regretted. The social life had became miserable with over vendalism by herotn-takers and mastans.

Maulana Sobhan was critical of the remarks of the Education Minister in Sunday's session regarding the

wine-shops of the country. Demanding construction of Ishwardi-Nagarbari rail link he said, the scheme was under taken former Communication Minister Mansur Ali who along with other national leaders were killed in Dhaka Central Jail.

He also demanded an Agriculture University at Ishwardi and recommissioning of the Islamic Education and Research Centre.

Selina Rahman

Mrs Selina Rahman (BNP-Barisal-Jhalakati-Pirojpur) said the hopes and aspirations of the people had been reflected in the budget.

She said industrialisation of the country would be accelerated following introduction of the market economy. She said it would also play a key role in implementation of the dream of Shaheed President Zia and achieve self-reliance.

The proposed budget had called for realisation of overdue loans and reduction of trade deficit.

Sheikh Selim

Sheikh Fazlul Karim Selim (AL-Gopalganj) said the Budget placed by the Technocrat Finance Minister' could not fulfil the hopes and aspirations of the people. He termed it as a "foreign-aided budget".

Selim said it was regrettable that our Finance Minister would "seek help from door to door like a beggar." It was not desirable for a sovereign and independent country, he said adding that 86 per cent of the budget was dependent on foreign aids and loans. He said so far Bangladesh

had taken loans amounting to Taka 40,000 crore. He wanted to know from the Finance Minister as to how he would

repay them.

The Awami League MP demanded of the government to take steps for the trial of the killers of Bangabandhu Sheikh Mujibur Rahman, four national leaders, Shaheed President Ziaur Rahman, Col Taher, Maj Gen Manzoor Hossain, Maj Gen Mosharraf Hossain, and others and punish them.

Referring to the law and order situation prevailing in the country. Sheikh Selim said terrorism had compelled the authorities to close down many educational institutions

throughout the country. He said situations on the campuses now remind us of the days in the Ayub regime when a man like Professor Abu Mahmud was manhandled on the campus. He regretted that in recent time former Vice Chancellor of Dhaka University Prof Abdul Mannan was also

manhandled in the same way. Sheikh Selim referred to the incidents of violence on the campuses and said "those who commit crime and those who give them shelter were the culprits of the same na-

He welcomed he government initiative to stop violence in the educational institutes

but warned that such inftiative should not be a mere eye-wash. Shamsul Huq

The Awami League member called for apprehending the identified terrorists, as the Awami League member completed his speech the Speaker gave the floor to Shamsul Huq (AL-Mymensingh).

Huq said he had submitted a call attention notice on the alleged corruption in the national sports arena during the last autocratic regime. He said crores of Taka were
