54 hurt, 50 hostel rooms set ablaze

Rajshahi students fight gunbattle

RAJSHAHI, July 24: At least 54 people were injured, 14 seriously and about 50 residential hall rooms set on fire in protracted gun battle between the student activists of ruling BNP and other groups here since Tuesday night, reports UNB.

The fighting in and around Rajshahi University campus spilled over to the city areas and sparked off clashes between the activists making the situation tense.

Twelve of the seriously injured were admitted to the Rajshahi Medical College Hospital (RMCH). Three of them suffered bullet wounds. Stx others were admitted to private clinics.

Of those admitted to RMCH,

8 were named Arif Hossain (23), Mohammad Shilpi (24) Ashraful (24), Badal (23) Swapan (27), Rajibul Islam

CLARIFICATION

With reference to the Honourable Finance Minister's reply to a question in Parliament which was widely reported in the national press on 23 July 1991 regarding borrowings of Directors of private sector banks from the nationalized banks, Mr. A.S.F.Rahman, Chairman, Beximco Group and Vice Chairman, IFIC Bank and Mr. Salman F.Rahman, Deputy Chairman, Beximco Group and Vice Chairman, Arab Bangladesh Bank have to clarify the position as follows for the information of the general public and in order to dispel any misgivings which may have arisen.

- 1. Mr. A.S.F.Rahman and Mr. Salman F.Rahman in their personal capacity either singly or jointly have not taken any loan or any other credit facility whatsoever from any bank or any financial institution.
- 2. Companies in which they have interest as shareholders and/or Directors in the normal course of their business have borrowed from various banks and financial institutions. However each such company is a separate and independent legal entitiy in its own right.
- 3. Moreover all borrowings by such companies are adequately secured through mortgage of fixed and current assets of the respective companies, as per the existing norms established by the Bangladesh Bank from time to time. In some cases in addition to the prime security Mr. A.S.F.Rahman and Mr. Salman F. Rahman in their capacity as sponsor directors have also furnished their personal guarantees as an additional security.
- 4. However under the existing laws of the country it cannot be said that these borrowing constitute borrowing by the shareholder or Director. In fact many of the companies are public limited companies having more than 20,000 individual shareholders. It may also be mentioned that Beximco Companies employ over 12000 persons.
- 5. For over long twenty years such companies have been successfully engaged in the pursuit of genuine business which they have conducted legally and ethically. Such companies have regularly paid dividends to their shareholders and their dues in the form of customs duties, sales tax, excise and income tax to the National exchequer. They have thus a long and satisfactory relationship with their respective bankers. None of these companies are defaulters with any of their respective banks.
- 6. It is unfortunate that the name of Barrister Rafique-ul-Huq also appeared as a borrower. Barrister Rafique-ul-Huq is neither a sponsor Director of Arab Bangladesh Bank Ltd. nor is he a sponsor of Beximco Group of Companies. He represents the public shareholders on the Board of Arab Bangladesh Bank Ltd. and Beximco Pharmaceuticals Ltd. Barrister Rafique-ul-Huq has not taken any loan from any bank nor has he given any personal guarantee for any loan taken by Beximco Group Company.
