ATPs to fly again in this month

The government has decided to put the two ATP aircraft, grounded for over seven months, into operation.

The aircraft are expected to be pressed into Biman's domestic routes within

The British made aircraft were inducted in Biman's fleet late last year, but both were grounded on December 28 following frequent engine faults. An engine of one of the ATPs caught fire while landing at Rajshahi Airport.

Bangladesh Biman bought three ATPs last year from British Aerospace at a cost of 50 militon US dollars.

Two ATPs were delivered to Biman in October last year while the other was scheduled to reach Bangladesh sometime in December last.

At the same time Biman also disposed of its three F-27s and continued domestic flight operations depending on the newly procured ATPs.

But after the Rajshahi incident and other mechanical faults with the aircraft, both

Khabar Group withdraws writ petition

river Gumti is likely to remain unchanged. The river was flowing 38 cm above danger level Monday morning, despite considerable fall overnight.

The Deputy Commissioner of Comilla told UNB over telephone standing crops on nearly 7,000 acres had been damaged in Burichang and Muradnagar upazilas in flash flood caused by water gushing through severe breaches in the WDB embankment at Jatrapur.

In the Ganges basin, river Ganges itself will swell at all points during the next 24 hours ending 6 pm Tuesday, but will be flowing below danger level.

The flood situation in Feni, Chittagong, Banderban and Cox's Bazar districts is expected to continue improving, the Centre forecast added.

Road communication between Cox's Bazar and rest of the country remained disrupted, but officials said it might be restored shortly on completion of reconstruction of the collapsed bridge.

Roads and Highways Department men are working on the bridge round-the-clock to restore the road link.



Since the ATPs were grounded, negotiations between Biman and British Aerospace continued. The Bangladesh side insisted on returning the two ATPs and cancelling the order for the third

Bangladesh also proposed procuring jet-146 aircraft from British Aerospace in place of the ATPs.

But British Aerospace did not accept the Bangladesh proposal and insisted on putting the ATPs back into operation.

British Aerospace took the stand to maintain its reputation in the international aviation market.

While the two sides were engaged in negotiations for a long period, the domestic as well as the regional operations of Biman had to suffer a lot.

The national airlines had to depend on its two F-28 aircraft to operate flights on six domestic routes and also on the regional route to Calcutta. The shortage of aircraft caused a dislocation in these

After a long parley, Biman authorities agreed to operate two ATPs with some extra technical facilities provided by British Aerospace.

According to an understanding reached between the two sides, British pilots will serve Biman for six months to ensure smooth operation of the ATPs.

The British pilots will also provide recurrent training to Biman pilots essential for renewal of their licences. British pilots will also look after the technical maintenance of the ATPs during their stay here. The British Aerospace au-

thorities also agreed to accept Biman's cancellation order for the third ATP still lying in the However, Biman will have to

pay about US dollars 1,82,000 as compensation for cancella tion of the order. The compensation includes

hanger charges for keeping the third ATP in the UK for over seven months.

Now Biman will have to pay for only two of the aircraft. Mode of payment is being re-

Shops shut to protest extortion of money

Some 400 businessmen owning shops in the Science Laboratory area have become hostages to 12 hooligans who frequently extort money at gunpoint from them.

In a press conference at the National Press Club on Monday four of the owners said the businessmen of Ahmed Mansion, Ruma Mansion, Kuddus Bhaban, Dhanmondi Bhaban, Alpona Plaza, Zahan Mansion and Elephant Road decided to keep their shops shut for three days from Sunday to protest the state of

The owners present at the press conference were so scared of the hooligans that they repeatedly requested the reporters not to identify them

in any news item. They said that the thugs belong to a student organisation threatened the businessmen not to open their establishment in the next one month as a "punishment" for their

If they can identify us they will kill us," one of the owners

They said the businessmen refused to pay the 'subscription' by saying that there is specific government order against extortion of money

They also said that their harassment increased before the election of a nearby college

They alleged that five cases have so far been lodged with Dhanmondi police but the police remained inactive in taking any action. Rather the police were favouring the armed

That is what I had said during my party's extended meeting. There was no need to create the atmosphere of a crisis that

the ruling party did." To the question on what caused the crisis, the PM's visit to the Acting President or her speech, the Leader of the Opposition said: "I was only pointing out the shortcomings of the bill. The bill, as proposed by the Select Committee, is a compromise. bill, and like all compromise documents, it does not reflect

the totality of our views." But does it not create the impression that after agreeing during the negotiations of the Select Committee the AL is trying to raise new issues ? "No, if you examine the bill that we had put forward in the first place it will be clear that what we are saying is not new

Sheikh Hasina, however, said that the bill did not reflect the Awami League's views fully and as such she would work to improve it further.
