sands of young people protesting Indonesia's annexation of East Timor clashed with troops in the East Timor capital Tuesday, and the Indonesian official said about 40 youths were killed, reports

The Indonesian military in East Timor, however, said only four of the demonstrators and two security officials were injured in the clashes. There were no deaths, said Lt Colonel Tompodong.

He said the demonstrators used the current visit of a United Nations human rights delegation to stage a demonstration to embarrass Indonesia.

The clashes erupted after a church service to commemorate two other youths killed in a clash with police last month in East Timor's capital, Dili.

Thousands of East Timorese youths gathered at a cemetery and then marched through Dili's streets, carrying anti-Indonesia banners and shout ing slogans against Indonesia's annexation of the Portuguese colony in 1976.

Women's quota in JS undemocratic, HC Div told

The Writ Petition questioning the legality of the 10th Amendment of the Constitution, which provides for 30 seats in the Parliament to be reserved for women and to be elected by the 300 members previously elected in the general election, came up for hearing before a Division Bench of the High Court Division comprising Mr Justice Mohammad Abdul Jalil and Mr Justice Naimuddin Ahmed on Tuesday.

Dr Ahmed Hussain, a senior Advocate of the Supreme Court challenged the Constitutional validity of this Amendment mainly on the ground that it has violated the principle of democracy to which the Constitution is pledged and is discordant with Article 122 (1) of the Constitution which enjoins for the elections to Parliament to be held on the basis of adult franchise. In support of his contention he extensively quoted passages from the Anwar Hossain Chowdhury's Case known as 8th Amendment Case, which declared Amendment to Article 100 ultra vires of the

Disqualification of Indian MPs for crossing floor upheld

NEW DELHI, Nov 12: India's Supreme Court today held constitutionally valid a 1985 ruling which disqualifies members of federal parliament or state assemblies who defect from their parties, lawyers said, reports AFP.

But the 3-2 ruling also held that the anti-defection law, as it is known in India and which was challenged in court by a group of disqualified MPs, was subject to judicial review.

The law bars MPs from changing parties after they have been elected- but not from crossing the floor on a vote - if they constitute less than one-third of the members of the party they quit.

If the breakaways constitute more than one-third of they party, the breakaway is considered legal.

Kenyan FM was slain for opposing corruption

KISUMU (Kenya), Nov 12: Foreign Minister Robert Ouko, whose burned body was found last year, was killed because of his opposition to government corruption and differences over the issue with a Cabinet colleague, a British investigator testified, reports UNB.

John Troon, a retired Scotland Yard investigator who led a probe of Ouko's killing, told an inquiry in the case that Kenya's chief of police cut short the case when it became clear Troon wanted to interview senior officials.

It was Troon's fourth day testifying before the threejudge panel investigating Ouko's Feb 13, 1990 death. The panel has heard testimony since late last year in this western town, the late foreign minister's home district.

An Indonesian official, speaking on condition of anonymity, said they started to throw stones at a police station and attacked police and troops trying to break up their demonstration.

The youths attacked police and troops with stones, sticks and knives, injuring one soldier seriously, added the official, who is very close to both East Timor and military authorities.

The outnumbered police and soldiers fired in the air to stop the attack, he said. Troops continued to patrol the area after the clash, making arrests and questioning young people, the official said.

Indonesian Foreign Minister Ali Alatas told reporters recently that "Portugal wanted the visit and they postponed it," he said the two sides had agreed that each had the right to veto journalists wanting to accompany the mission.

Alatas said it was up to the United Nations to reschedule the visit on terms acceptable to both sides.

The angry people today ransacked Sarail Upazila office and damaged several vehicles, including the car of Upazila Education Officer, protesting the alleged police assault of Pathan.

They also held a protest rally at the upazila headquarters in the afternoon.

According to law enforcement officials, gunmen opened fire at around 7 am at four children when they took a herd of cattle for grazing in a field near the Babuchara village under Dighinala upazila of Khagrachhari district.

Chonchola (10) and Polash (11) died on the spot while Nurul Islam (12) sustained serious bullet injuries, security officials said. The other person managed to escape unhurt. Security measures were re-

enforced in the area, district administration officials said.

Meanwhile, two more Shanti Bahini men surrendered along with arms in Rangamati on Monday, district administration officials said.

179 tolas gold seized: one held at ZIA

A 179 tola gold plate worth Taka 15 lakh was seized and one person was arrested by customs officials at Zia International Airport from a Chittagong-bound passenger arriving on a Biman flight from Dubai Tuesday afternoon.

Customs officials said the gold plate was found by the customs surveillance team on duty at the airport while electronically scanning the luggages of the incoming passengers of the Biman flight BO-026 coming from Dubai.

The gold plate was covered with black rexine and pasted along the inside frame of a suitcase, customs officials said. The gold plate weighed 179 tolas and is estimated to be worth around Taka 15 lakh, they added.

One-man hunger strike for campus peace

"What pains me most is the continued violence and terrorism in the educational institutions in the country which has almost stifled the hopes of thousands of students," said Arif Khan Yousufzi a small businessman who began a hungerstrike unto death on Tuesday afternoon in front of National Press Club.

Son of a library businessman who died in 1979, Yousufzi came to Dhaka from his village Salimabad of Nagorcot upazila under Tangail district on Sunday to stage the hunger-strike in protest against campus.

The gunbattle in Jagannath University College in July which claimed two lives. first struck me and I pondered protesting it and finally decided to sacrifice my life for campus peace after the October 27 incident in the Dhaka University," he said adding that he hoped the Jatiya Sangsad would take effective measures to curb terrorism.

The October 27 clash between workers of the BNP-backed Jatiyatabadi Chhatra Dal (JCD) and the Awami League-backed BCL (S-A) left four persons dead and many injured.

le said that the village people lost faith in and have strong apathy towards the political parties only because of their breaching promises and their students wings as armed cadres.

Yousufzi who completed his schooling in 1977 worked for Khetmajur Samity for four years in his locality but severed relation with the party out of frustration.

He said that if the JCD, BCL (S-A), Ganatantrik Chhatra Oikkya and other student organisation jointly convened a grand conference in Dhaka and swore publicly to stop violence and to restore peace in the educational institutions, then the problem could be solved.

An estimated one and a half lakh Rohingya Muslims are yet to be taken back by Burma as per 1978 agreement with Bangladesh. Disclosing the figure the

not satisfied with the outcome of the "Operation Nagamin". They are letting loose a reign of terror and tension in Arakan in a most savage manner with the sinister motive of expelling all Rohingyas from their ancestral homes," Islam said in the
