Defence accused of threatening witness

leader Delawar Hossain Sayedee accused the defence of intimidating him at his home in Pirojpur.

"They [defence counsels] went to my house and threatened me," said 14th witness Abdul Halim Babul, pointing his finger at the defence counsels of Sayedee.

"Some 300 to 400 people went there and intimidated me," said the 55-year-old village doctor when he was being cross-examined by the defence lawyers after he had testified before the tribunal.

"We were tortured in 1971 [during the Liberation War]. Even now [they] are intimidating me."

The defence counsels were silent in court after the witness made the claim.

Later, before journalists, they denied the allegation.

Lawyer Tajul Islam, a defence counsel who visited Pirojpur to prepare for the case, said the allegations are "not true". He claimed that in

December Babul had misbehaved with them when they went to his home to make a map of the location.

"We have the footage to prove it," he said. Meanwhile, prosecutor

Rana Dasgupta told The Daily Star that the allegation made by the witness was true. He said a group of

defence lawyers with 300 to 400 activists of Jamaat-e Islami and its front organisations visited some parts of Pirojpur to collect information to defend Sayedee before the trial began.

"We came to know that they also went to the houses of some prosecution witnesses and threatened them," he said.

The state is providing protection to the witnesses and victims of crimes against humanity as per constitutional obligations, he said.

The three-member tribunal headed by Justice Nizamul Huq finished recording the deposition and cross-examination of

Babul yesterday.

It prematurely adjourned yesterday's proceedings at 12:10pm, as the next witness could not be produced due to his illness. The tribunal is supposed to record the testimony of the 80-year-old witness today.

Sayedee has been accused of committing crimes against humanity during the Liberation War in 1971. He was present in the dock during yesterday's proceedings. He is among six Jamaat leaders, including former Jamaat-e-Islami chief Ghulam Azam and two BNP leaders, facing charges of crimes against humanity before the tribunal.

Babul in his sevenminute testimony told the tribunal that Sayedee along with other collaborators and Pakistani soldiers looted and torched his house in Pirojpur on June 2, 1971.

He was standing on the street in front of his house in Nalbunia village when he heard that Pakistani soldiers

approaching towards the area, he said.

"We used to live in fear of the Pakistani soldiers and Razakars [collaborators]," said Babul, "I entered my home and told everyone to leave.

"They [family members] went into hiding. So did I."

From a distance, they saw Delawar Hossain Sayedee, Danesh Mollah, Moslem Moulana and some other armed collaborators and Pakistani soldiers entering his house.

"They looted the house and set it ablaze," he said.

Later, the Pakistani soldiers and collaborators, including Sayedee, went to the nearby village of Sankarpasha and set fire to the houses of Khasru Miah and Amir Khan.

"I also heard that they went to Hindupara of Umedpur village, torched many houses and killed people," said the witness.

and collaborators were deposition at 10:47am, defence counsel Mizanul Islam began crossexamining the witness.

Judge AKM Zaheer Ahmed, a tribunal member, then told the counsel, "Do not ask any scandalous questions."

Then, Mizanul asked the witness whether he had secured bail in a theft case filed by one Aklima Khatun from Nalbunia village.

Babul responded that it was not true.

Mizanul then read out the lier filed. details of the case, including its number (CR-1160, 1982).

At that point, Babul became agitated and stood up in the dock. He sought permission to say something to the tribunal.

Babul said the case had been filed against him to avenge a case he had filed

against Aklima in connection with assault on him, which left hack marks on his body.

The witness told the court he could show the marks.

It was then that the witto ask some unpleasant ness told the court he had been intimidated by the defence counsels.

> Babul said the lawyers went to his house in seven or eight cars along with hundreds of people without any prior notice and intimidated him.

The tribunal then asked Babul to sit down and recorded the fact that the witness had received bail in the theft case against him but that the case was a counter to a case Babul had ear-

Defence counsel Manjur Ahmed Ansari concluded by saying that Babul, a supporter of the Awami League, had made a false statement against Sayedee on the instructions of his party leaders. Babul denied the accu-

sation.

Terming the Shishu Hospital as one of the best hospitals and academic institutes, Hasina said its expansion, establishment of child cardiac centre, and opening new branches at Gazipur and Rajshahi will help improve the quality and scope of treatments.

Health and Family Welfare Minister AFM Ruhal Haq, Adviser to the premier Prof Syed Modasser Ali, among others, spoke on the occasion.

Bibiyana bid draws plants and private sector gas

venture of Japanese Marubeni and Korean Hyundai, and a joint venture of Hel-Etern-CCCC.

Earlier, Chinese bidder CMC-ZGPT dropped a proposal with financing to set up a 150MW plant in Kodda of Savar for a joint venture company comprising the PDB and Rural Power Company Ltd.

Other tenders, expected to be opened within a month, are: Ghorashal 300-450MW combined-cycle plant, Shahjibazar 300MW, Bhola 225MW and Barapukuria 250MW second unit coal fired power plant.

A top power board official said the government was looking into all kinds of options to ensure power generation, from rental power plants for short term solution to public sector dual-fuel

and coal based plants. The idea of inviting bids

from contractors, who would arrange for the funding to set up a plant for the government, was new and it freed the government from the stress of finding project finances. "Besides, we have been hearing criticism that we have awarded too many private power contracts. We hope this bid would create a balance between public and private sector power generation," said the top power board official.

Happy with the response in the Bibiyana third phase bid, he added that the power board aims to sign the contract within the next six months. The PDB also aims to launch the power plant partially within 20 months of the deal signing and launch the full combined cycle plant

within around three years. The new move of floating

tenders, where bidders take care of finance, came after the failure of a private sector bid in Bhola to generate 225MW and uncertainty looming over financing of three large private projects awarded to local Summit Group

Summit is supposed to complete financial arrangement for the first two phases of Bibiyana power plants and another in Meghnaghat within February. But so far, the government remains unsure about completion of this arrangement. However, Summit chief Muhammad Aziz Khan told The Daily Star that his company has made an "interim" financial closure of the Meghnaghat project and by February 16, it would close both the Bibiyana power projects.

FROM PAGE 1 which would have been the showpiece of India-Bangladesh relations after the Ganges accord in 1996 (when the then West Bengal Chief Minister Jyoti Basu had played a key role in facilitating the Ganges water-sharing agreement) Sarkar generously offered 100MW of power from Tripura's quota of 196 MW from ONGC's Palatana project in the state, provided the central government approves of it. The 726MW power project will start generating electricity in a few months and Sarkar is too well aware that its construction was facilitated by the Hasina government through allowing use of Ashuganj port to ferry equipment for the project in a shorter time. Sarkar made the offer in the presence of Hasina in Agartala and the Bangladesh would get the nod of the shortage of electricity.

104MW Monarchak power project in Tripura would start generation soon and a portion of that power could be sold to Bangladesh. The Tripura chief minister has clearly made the right moves to enhance India-Bangladesh relations for which power is going to be a key driver.
