

# 7 Hizb-ut Tawhid men arrested in Barisal

Jihadi books, CDs, leaflets seized

Rapid Action Battalion (Rab) arrested seven members of Islamist outfit Hizb-ut Tawhid along with jihadi (on uprising) books, CDs and leaflets in the district on Monday night. Rab-6 sources said a patrol team of the elite force arrested Abdur Rob Mistri, 52, Shafiqul Islam, 22, Zahurul Islam Tuku, 23, and Hanif Hawlader, 55, along with 25 jihadi books, 18 CDs and 23 leaflets at Chowdhurhat in

Roy of Uzirpur police station said the arrestees were sent to court yesterday noon. On their confessional statement, the elite force conducted a drive early in the morning and arrested Alamin Mollik, 40, Sumon Mollik, 22, and Khushi Akter, 24. During the raid, Rab recovered 360 jihadi books, 45 CDs and 300 leaflets from regional leader Alamin Mollik's house at Gausia Road at Rupatoli in the city.

# RU students want shifting of their dept to campus

Boycott classes, threaten tougher agitation

Students of crop science and technology department at Rajshahi University (RU) yesterday boycotted their classes demanding shifting of the department from Narikelbaria outer campus to the main campus of the university. Over 200 agitating students of the department took out a procession on the main campus and then held a rally to press for the demand. At the rally, the students said only the academic activities of crop science and technology department out of a total of 49 departments are conducted at Narikelbaria outer campus, 5 kilometres off the main campus. They said most of the students of the department reside at the dormitories on the main campus. "We attend the classes on the

outer campus at Narikelbaria and return to the main campus in a university bus that plies the dilapidated road, risking accident," the students alleged. Nine students of the department were injured on Monday after a Dhaka-bound bus hit the university bus from behind on the road near Rajshahi Railway Station. The injured are now undergoing treatment at Rajshahi Medical College and Hospital (RMCH) and the university medical centre. The students of the department also threatened to go for a tougher agitation, including class boycott and strike, if the demand was not met. Later, they met Vice Chancellor Prof Abdus Sobhan and requested him to take immediate steps to shift the department to the main campus. The VC assured the students of taking necessary steps in this regard.

# 10 hurt as BCL, police clash

Moulvibazar BCL chief held, case against 62

At least 10 people, including president of district Chhatra League (BCL) and a police sub-inspector (SI) were injured in a clash between BCL activists and police at an Urs in the town on Monday night. The incident allegedly followed teasing of women and collection of tolls at the Urs. According to Moulvibazar Sadar police, Monday was the day of 671st Urs Sharif of Hazrat Shah Mostafa (R) in the town. A large fair arranged on the occasion. Police said they arrested a youth while teasing a woman at the fair at about 9pm. As police were taking the youth to a police van, a group of BCL leaders and activists tried to snatch him away. This triggered a clash between police

and BCL activists. Panic-stricken people at the fair began to run helter and skelter. In the clash, so far 10 people including police SI Anwar Hussain, police van driver Shafiqul Islam, district BCL president Zakariya Ahmed, and a visitor at the fair Md Nasir, were injured. Injured van driver was admitted to Moulvibazar Sadar Hospital, while Nasir was sent to Sylhet Osmani Medical College Hospital. During the clash, a police van and 10 to 15 shops at the fair were vandalised. At one stage the BCL men put up barricade on Dhaka-Sylhet highway leaving a huge number of vehicles stranded on both sides of the road. To control the situation, police charged baton and fired 30 rounds of short gun bullets and arrested 21 people

from the spot at about 10pm. Leaders of district BCL later claimed that police confined one of their activists as he protested toll collection by police at the fair. The BCL president alleged he was assaulted by police when he tried to settle the matter. Abu Zafar Md Saleh, officer-in-charge (OC) of Moulvibazar Model PS said, some youths were disturbing women at the fair. On duty police detained one of the youths but a few BCL activists tried to snatch him away, he said. They also attacked police injuring a sub-inspector and a police van driver. The van was also vandalised, he added. "SI Anwar Hussain has filed a case against 62 people including district BCL president Zakariya Ahmed in this connection," the OC further said.

# Imam's body recovered

Body of Imam of a mosque was found floating in a pond at Beridbil village in Goainghat upazila on Monday. The victim was identified as Moynuddin, 40, Imam of Beribil Mosque and son of late Gani Miah of Sandaura village in Companyganj upazila of the district. Nandigaon union parishad Chairman Mamunur Rashid Shahin said locals found Moynuddin's body floating in the pond at about 8:00am and informed police. Later, the law enforcers recovered the body at about 9:00am.
