Eight-party, Jamaat leaders absent from ceremony

### Khaleda sworn in as PM

BNP chief Begum Khaleda Zia was sworn in as Prime Minister at Bangabhaban by Acting President Justice Shahabuddin Ahmed on Wednesday. Eleven cabinet ministers and 21 ministers of state were also sworn in.

The simple ceremony, held at the Darbar Hall of Bangabhaban, was attended by Members of Parliament, political leaders, diplomats, high civil and military officials.

Begum Zia is the first woman Prime Minister of Bangladesh, and the second woman Prime Minister of the modern Muslim world. She is the eighth Prime Minister of Bangladesh.

She came into focus following the assassination of her husband President Ziaur Rahman on May 30, 1981 and joined politics following the overthrow of the BNP government of President Justice Abdus Sattar in a military coup on March 24, 1982.

#### 11 Cabinet Ministers, 21 State Ministers

"I was not in politics when power was snatched from BNP on March 24, 1982, but when I joined the people on the streets I promised to organise resistance against injustice", she told newsmen after the swearing-in.

Begum Zia looked elegant as she entered the Darbar Hall at 3-07 pm. Then bugles were played to announce the arrival of the Acting President in the hall, a mute witness of many ups and downs of history.

Besides the ministers and the state ministers designate, BNP members of parliament, Rashed Khan Menon, MP of Workers Party and other Five-Party Alliance leaders — Khalequzzaman Bhuiyan,

Hasanul Huq Inu, A.F.M. Mahbubul Huq, Moinuddin Khan Badal and Kazi Kader of Muslim League were present at the function.

Members of parliament belonging to Awami League and other components of the 8-Party Alliance abstained from the function. MPs belonging to Jamaat-e-Islami which has given total support to BNP in parliament did not attend the function.

Only Mizanur Rahman
Manu, and Awami League MP,
was present. He was possibly
unaware of the party decision.

was Awami League chief
Sheikh Hasina's husband Dr.

# First task is to rebuild economy, restore law and order: Khaleda

Prime Minister Begum Khaleda Zia said on Wednesday the first task of her government would be to rebuild the shattered economy and restore law and order so that the people have two square meals a day and can live in peace.

Talking to newsmen immediately after taking oath as Prime Minister at Bangabhaban she called upon all to work hand in hand for restoration of democracy.

Restoration of democracy is not the responsibility of the government alone, she said adding: The people have reposed responsibility on others also by voting for them.

The Prime Minister said her government would try to fulfil the commitments made to the people during the election.

Elaborating she said, the economy and all institutions were destroyed during the last

nine years. Her immediate task would be to salvage the cconomy and rebuild the institutions.

Replying to a question she said her party was committed to establish a corruption free government.

Begum Zia told another questioner that the people through their movement restored democracy which had been snatched away in 1982.

She said she was not directly connected with politics in March, 1982. But when I joined the people on the streets I vowed to organise resistance against injustice, she said.

She said, I was confident that the people of the country would build resistance against injustice, as they had done in the past. The people were with us and with their cooperation we have achieved today's victory, she said.

# Ershad charged for amassing wealth

Deposed President Ershad was formally charged in the Special Judge Court on Wednesday for acquiring property beyond his known sources of income.

The charges also included non-deposit of gift items to the government Toshakhana (Treasury).

On hearing the charges

against him Ershad pleaded not guilty as he had done the previous day (Tuesday) during the arms case trial which was chaired by the same Judge.

Ershad said. "I am not guilty

Ershad said, "I am not guilty and I want a fair trial." The hearing was adjourned

till April 21.

The Special Judge Court is housed in the same compound where the Special Tribunal has

been set up.

Sessions Judge Mohammad
Habibullah who is chairing the
Special Judge Court set up to
try Ershad rejected two
petitions of the Defence
Counsel Shahadat Hossain, who
prayed for quashing the case.

#### Securitymen obstruct Attorney General

Security forces at the Special Judge Court premises on Wednesday obstructed entry of Attorney General Aminul Haque into the premises delaying the start of Ershad's trial by about two hours.

"You have taken Ershad's

"You have taken Ershad's money and that is why you are obstructing us," the Attorney General screamed at the Assistant Superintendent of Police (ASP) who had ordered securitymen to let no transport other than that of the Judge to enter the Court premises.

The ASP later said that he

At one stage in the arguments, the Judge of the Special Court came out of his chamber and told the securi-

In securitymen later allowed the Attorney General's transport to enter the Court premises after being ordered to do so by their higher ups.

Aminul Haque refused to attend the Court and insisted that the matter be settled atonce by higher security officials.

policemen, you thrive on
