JAMMU. Mar 20: Kashmir was paralyzed today by a gencral strike called by anti-Indian Muslim militants to protest a security crackdown in the troubled valley, officials and witnesses said, reports

The strike forced the closure of shops, schools, banks and private and public sector businesses.

Vehicles stayed off roads, deserted except for security patrols, and officials in Kashmir's winter capital said absentecism at government offices was high.

The strike, sponsored by several outlawed secessionist groups, also diverted attention from the withdrawal of a daytime curfew imposed by security forces in downtown areas of Srinagar on Saturday.

Srinagar is a centre of secessionist activity and massive house-to-house searches by police and troops during the curlew, which preceded the beginning of the Muslim holy

Tension mounts further on DU campus as Ashim Ukil chased

Tension further mounted in the Dhaka University campus on Wednesday following an incident of chasing Ashim Kumar Ukil, General Secretary of Chhaira League (BCL)

A large number of students, driven out of their halls, were still staying outside.

Campus sources said, around two thirds of the residents of Sir Salimullah Hall left their rooms due to lack of security. Most of them are not directly involved in politics, the sources added.

Leaders of the All-Party Students Unity (APSU) as per the decision of Tuesday's meeting were supposed to take measures for the return of the driven out students to their respective halls.

month of Ramzan, turned up more than 1,000 suspects. But officials in the state administration said most were released after questioning, and only 265 suspects were still being held.

Militants, who also called the strike to protest the alleged rape of several village women by security forces last month used the occasion to mourn Ishfaaq Majid, a prominent Muslim militant killed in a gunbattle with police exactly one year ago.

Violence connected to the nearly three-year-old secessionist campaign has left more than 2,100 people dead since January 1990 in Kashmir, the only Indian state with a Muslim majority.

Reuter adds: The Indian Defence Ministry described the rape charges, the latest and most dramatic of atrocity allegations against the thousands of Indian security men fighting a separatist campaign, as "malicious and untrue."

The strike was called in response to a report by Human Rights activists on charges by women in Kunon Poshpora that 500 drunken soldiers invaded the village and gang raped women last month.

The activists, led by retired Chief Justice Musti Bahauddin Farooqi, said they interviewed 53 women who alleged they had been raped on the night of February 23.

His team, accompanied by reporters, was told the troops arrived late at night, herded the village men into a granary and raped women aged between 18 and 80.

He said that the officials who passed the order should be called at once, but they did not turn up until 11.45 a.m.

KAMPALA, Mar 20: A legislator Wednesday said an outbreak of meningitis had killed over 120 people in his northern Uganda constituency. Ambrose Okullu, a member of Par liament from Kitgum, said health clinics had a shortage of medicine with which to treat the disease. The region is adjacent to southern Sudan where another outbreak of meningitis was reported early this month, reports AP.

10 killed in Beirut

BEIRUT, Mar 20: Ten people were killed in a car-bomb attack today that targeted Lebanese Defence Minister Michel Murr, officials said. Mr. Murr was among 20 people injured in the blast, which occurred in a Christian suburb north of Beirut, reports AFP.

Soviet spy deported from NZ

WELLINGTON, Mar 20: New Zealand has deported a Sovict secret agent who arrived on a forged British passport and tried to establish a new identity using the name of a dead man, Prime Minister Jim Bolger said today. Soviet Ambassador Yuri Sikolov said the case, the third time a Soviet citizen has been thrown out of New Zealand since 1980, was purely a misunderstanding over a man trying to emigrate illegally, reports Reuter.

Census in Pakistan postponed

NEW DELIII, Mar 20: Pakistan has indefinitely postponed the 1991 census due to begin this month in view of a highly explosive political situation in Sindh. The government faces a dilemma with major political parties accusing it of inflating population figures in the initial head count, reports PTI.

China executes 32 criminals

BEIJING, Mar 20: A city in southern China executed 32 criminals in a two-month period, leaving its residents "elated", a local newspaper received here today said. Authorities in Shaoyang, in Hunan province, uncovered 1,063 criminal cases, broke up 67 gangs and arrested 837 criminals from mid-December to February, the official Hunan legal news said, reports AFP.

US downs Iraqi plane violating truce

WASHINGTON, Mar 20: President George Bush today vowed that any more Iraqi planes guilty of violating the temporary ceasefire in the Gulf will be shot down, but said he did not expect future incidents, reports Reuter.

"If other planes violate the agreement they will be shot down," Bush said while posing for pictures with visiting Polish President Lech Walesa. don't expect that to happen", Bush said .

A US warplane shot down an Iraqi jet fighter near Saddam Hussein's home town of Takrit earlier today. The downed aircraft was one of a pair of Soviet-supplied SU-22s

that took off in violation of provisional ceasefire terms under which the United States and its allies suspended offensive action against Iraq on February 28. Bush, chatting with the Polish leader, refused to

respond directly to reporters'

questions about the air action near Takrit but told Walesa, one of the Iraqi planes violated the agreement and it was shot down". White House spokesman

Marlin Fitzwater said the incident did not mark a resumption of the Gulf war, temporarily halted by Bush after six weeks of fighting.

Sheikh Hasina in the chair in a resolution said the Joint Declaration issued by the three alliances pledged for transfer of power to a sovereign parliament. Formation of the Council of Ministers with members from a particular party simply bypassed the framework of the Joint Declaration and the national

The meeting expressed its firm belief that the issue of transfer of power to sovereign parliament was not the demand of Awami League alone. Rather, the responsibility of ensuring transfer of power to a sovereign parliament and taking initiative for necessary constitutional amendment in this respect lies with the party having ma-

jority, the meeting observed. The resolution said Awami League was determined to block for good the chances of the revival of autocracy and for this it was reminding all par-

ties concerned the pledge given to the nation by the three alliances including

Awami League and BNP. The meeting held that those who took oath on Wednesday as ministers from the Acting President as members belonging to majority party would perhaps have formed the government after ensuring the process of transfer of power to a sovereign parliament. Consequently, the nation would have acquired the system of accountability saving democracy from the apprehension of being overtaken by

autocratic rule, it stressed.

The meeting said by

sovereign parliament it meant parliamentary form of government. Under the system, the government would be compelled to remain accountable to the parliament, as well as the people. Until a sovereign parliament was established, this Council of Ministers would not be compelled to be accountable to Parliament, rather it would be responsible to the

The meeting still hoped that good sense would prevail on the concerned party. It further expressed the hope that the concerned party would take necessary constitutional
