The constitution of a commission should not be used as a pretext by the Treasury Bench to postpone any discussion in the House on such a matter of wide public concern, he added.

Supporting the GP member. Deputy Leader of the Opposition Abdus Samad Azad wanted to know from the Speaker whether the members of the House will be allowed to discuss the jail situation in its en-

Speaker Abdur Rahman Biswas reminded the House that the statement by the Leader of the House on the situation at Dhaka Central Jail was made under Rule 71 of the Rules of Procedure. He requested the Leader of the Opposition to nominate only one member to raise a question on the statement by the Leader of the House. This is allowed under Rule 71 of the Rules of Procedure, he said.

At this point, Leader of the House Begum Khaleda Zia. who is also in charge of the Ministry of Home Affairs requested the Speaker to allow a general debate on the issue. The Treasury Bench has no objection to any discussion on the issue, she said.

The Speaker later decided that the situation in Dhaka Central Jail will be taken up by the House for discussion today. He noted that there was no time for discussion on the matter on the day because the House would be adjourned soon, he added

The Speaker later an nounced the adjournment of the House till 11 am today.

Earlier, the House witnessed an uproar in its morning sitting on the admissibility of several adjournment motions tabled by the opposition members on the situation prevailing in the Jails.

The Speaker disposed of a number of adjournment motions on the jail situation, stating that such motions were related to an 'on-going situation and not concerned with any specific matter, warrant ing adjournment of the House to discuss the issue by-passing its normal business.

The Speaker's ruling caused an uproar in the House. Several Opposition members including Salahuddin Quader Chowdhury of National Demo cratic Party (NDP). Rashed Khan Menon of Workers Party, Abdur Razzak of BKSAL, Mohammad Nasim, Chief Whip of the Opposition, Shamsuddoha of CPB. Asaduzzaman of Awami League and Maulana Mattur Rahman Nizami of Jamaat-e-Islami, were restive. They pressed for an adjournment of the House to discuss the jail riots describing the issue as a matter of vital public concern.

The Opposition members said their adjournment motions on the issue were specific in nature and concerned the incidents which took place in Dhaka Central Jail on Mon-

The Speaker said he had not disposed of all adjournment motion which were tabled on the jail riots. The motions for which notices were received on Tuesday morning had not been disposed of, and would be taken up for consideration on Wednesday.

He said the members would be free to discuss the general situation in the jail in course of their deliberations on the vote of thanks on the Acting President's address to the Jatiya Sangsad.

Education Minister Prof Badruddoza Chowdhury, taking the floor, informed the House that the Prime Minister would make a statement in the Sangsad on the day. He suggested that discussions on the prevailing situation in the jails including that in Dhaka Central Jail could take place after the Leader of the House made her statement.

But, the Opposition members were not satisfied and they pressed for an adjournment of the House to discuss the situation.

The pandemonium in the House dominated its proceedings for most of its first sitting

on the day until 1 pm. When the Speaker proceeded with the lagislative business of the House, Leader of the Opposition Sheikh Hasina took the floor and announced that she would like the discussion on the jail situation to be continued under Rule 71 of the Rules of Procedure. The Rule relates to a call attention, providing for a statement by the concerned minister on the issue and only one question relates to that statement, she said.

The Speaker ruled out the

matter and proceeded with the next agenda for business by the House for the day. The Opposition under their leader Sheikh Hasina staged a token walk-out in protest. The members belonging to Jamaate-Islami and also the independents MPs joined walk-out. The entire opposition however came back to the House after about 10 minutes. By that time, the legislative business was on in the House.

BSS adds : Begum Khaleda Zia told the Jatiya Sangsad on Tuesday the situation in Dhaka Central Jail was under full control of the government.

The Leader of the House said the government was quite aware of the situation.

She told the House one prisoner died Monday while trying to escape by scaling the wall of Dhaka Central Jail. Quoting jail administration the Prime Minister said 13 prisoners had escaped from Dhaka Central Jail.

She said two deputy jailers. four jail warders and six prisoners were also injured.

The Prime Minister said some prisoners tried to escape from Dhaka Central Jail at 3 p.m. on Monday by creating terrorism through bursting of handbombs. Armed with different kinds of sharp weapons and sticks they obstructed the jail warders in performing their duties and indulged in clashes, she added.

She informed the House two were detained while attempting to flee by scaling the boundary wall of the jail. One of them died from injuries while trying to escape, she said.

The Prime Minister said two Deputy Jailors, four Jail Warders and six prisoners were injured during search operation which was conducted inside the jail in cooperation with the police and BDR to bring situation under control. The injured persons had been sent to hospital for treatment, she added.

She further said a huge quantity of sharp weapons and sticks have been recovered from the prisoners.

Tracing the background of incidents in different jails of the country from time to time. Prime Minister said the autocratic regime of deposed President Ershad had let loose a reign of terror and repression on the people during its nineyear rule and sent many to prison. Though Dhaka Central Jail had a capacity to accommodate two thousand prisoners, five thousand prisoners had been lodged inside it. After the fall of the autocratic regime the Acting President ordered the release of 4,500 prisoners (from different jails) Of them 1000 prisoners were released from Dhaka Central iail. About four thousand pris-

The Prime Minister told the House that many of the prisoners interned during the autocratic regime had been nursing the feeling that their detention was illegal. This caused resentment among many prisoners. The incidents in jails were the outburst of pent-up resentment and demand for their release, she said.

oners still remain in Dhaka

Central Jail, she added.

The Prime Minister blamed the autocratic government for its failure in maintaining proper administration. This, coupled with the accumulated resentment of the prisoners. gave rise to incidents in jails. she said adding a certain quarter was involved in it to realise its political motive.

She held out the assurance that the designs of the certain quarter in this respect would not be fulfilled and that the situation would remain under the control of the government. In this connection, she pointed out that the responsibility of the Home Ministry was assigned to her only on April 7.

The Leader of the House told the Sangsad that prisoners of Dhaka Central Jail made an appeal to Acting President and the Divisional Commissioner on April 2 to consider their demands. Their appeal is now under consideration, she

She further said employees of prisons had been facing great difficulties in discharging their duties in face of threats and unruly behaviour of pris-

The Prime Minister said, Shaheed Ziaur Rahman had constituted a Jail Reforms Commission. Though the commission had submitted its report for jail reforms Ershad government did not implement the recommendations of the report properly. As a result resentment, was created among he prisoners. The reason behind the violence in jails was the result of accumulated resentment, she said.

As regards Farakka issue, Salauddin Yusuf maintained that Awami League government ensured due share of Ganges water, but after the killing of Bangabandhu in 1975, the situation deteriorated and all the governments who ruled the country during last 15 years failed to realise due share of water from India while the flow of water in Ganges reduced alarmingly. He called upon the government to take adequate measures to solve the problem.

He alleged that the History of Liberation was being distorted and said that none can deny that Bangabandhu Sheikh Mujibur Rahman was the architect of Bangladesh who brought independence after 23 years' struggle. "We don't deny that late Ziaur Rahman gave a declaration of independence on 27 March of 1971 on behalf of Bangabandhu", he said.

He regretted that a certain quarter was engaged in propaganda against Awami League. He said it was a fact that India helped us during our Liberation War, but due to initiatives of Bangabandhu, Indian Army returned home only after three months of the victory in the Liberation War. "There is no such instance in the world that the foreign troops left a country so quickly."

He deplored that past government had failed to solve the problems of Tinbigha and Talpatty.

State Minister of Labour and Manpower Barrister Rafiqui Islam thanked Acting President for his speech and stressed on maintaining political stability in the country. He said that members of both the

Treasury Bench and the Opposition fought unitedly to bring an end to autocratic regime. "Now, we have to work unitedly to build the country". he added.

He said that it was late President Ziaur Rahman who reestablished democracy based on multi-party system. He mentioned the critical economic situation of the country as described in Acting President's speech and said "we have to overcome this sit uation for which we should be ready for any sacrifices".

Ansar Ali of Jamaat-e-Islami stressed on setting up parliamentary form of government and sovereign parliament accountable to the people. He appreciated holding of a fair election under the neutral government of Justice Shahabuddin and said that in future, free and fair election should be ensured.
