Prof. Chowdhury said fire service ambulances from Dhaka and Narsingdhi immediately responded to the call and rushed to the spot.

He said the accident occurred due to explosion in the carbondioxide cylinder and Amonia Plant but no fire was caused.

He said Industries Minister Shamsul Islam Khan and high officials of the Ministry were on the spot now.





Azad said the bill passed through the select committee, Sangsad Secretariat and the Election Commission very quickly after fulfilling the requirements, but it got stuck up in the Law Ministry for the last three days from where it was to go to the President for his

He said national consensus was needed on the important national issues like the constitution, law and order and the campus situation for the existence of the nation. Rashed Khan Menon (Workers Party-Bakerganj) said, we need a na tional consensus on important national issues and under standing of the two national leaders.

He said we supported the bill prepared by Awami League and included some supplementary points of our bill.



Participating in the discussion, Nurul Islam Moni (Ind-Barguna) called for reaching an understanding between the Bangladeshi and Bangalee nationalism. He said, we have to reach a national consensus on vital national issues.

Moni said he had filed a constitutional amendment bill with the relevant quarters on March 28 but knew nothing about its fate though three months had already passed.

Referring to the increase of age limit for government service, he said the door for employment still remained closed. He said the Treasury members off and on mentioned the success of the mass movement but they were doing everything but short of implementing the objectives of the movement.

## Hafiz Uddin Ahmed

Major (retd) Hafiz Uddin Ahmed (Ind-Bhola) said he had given notice under Article 33 of the constitution for amending the Public Safety Act but no action was taken so far by a government that had been installed through mass upsurge, In a civilised world, there

was no law under which a man could be put behind the bar without trial. Such a law is only found in this country which should be abrogated immediately, he added.

Major Hafiz demanded of the government to repeal all black laws including Printing Presses and Publication Act and Special Powers Act.

He said when the whole nation was demanding repeal of all black laws, the government had passed another black law that permits, the administration to arrest, convict, and sentence anyone to seven years imprisonment for criticising the President and the Prime Minister.

As the House resumed its sitting after the break for Asar prayer, the Deputy Speaker asked Chief Whip of the Opposition Mohammad Nasim to take the floor.

#### **Mohammad Nasim**

Nasim said he did not have much to say except that the opposition expected to hear something concrete from the Treasury Bench on the Opposition's Constitution Amendment Bill.

"We do not want to take part in any meaningless discussions on the issue and as such are looking forward to meaningful discussions on this," he said. The Opposition Chief Whip

said the opposition would decide its next course of action after hearing from the Law Minister. Law and Justice Minister

Mirza Golam Hafiz then took the floor and explained indetails government's position on the bill submitted by the opposition and its own bill on the

The Minister said he had taken the bill to the Acting President today and brushed aside opposition criticisms that government dragged its feet on the issue. "We took it to President despite your noncompliance with the formalities involved with such bills." He said sought opposition cooperation in dealing with the

## Abdus Samad Azad

Deputy Leader of the Opposition Abdus Samad Azad said, "we have fulfilled all the conditions for bringing the Constitution Amendment Bill

He thanked the Law Minister for his exercise to facilitate the introduction of the said bill in the Sangsad. But Azad at the same time wanted to know why it was taking so much time to send the bill to the President for his recommendation.

The Deputy Leader of the opposition said we thought the amendments we proposed to the constitution would involve no expenditure. He wondered why the Constitution Amendment Bill could not be sent to the President so long when the Select Committee had okayed it.

Azad said the Law Minister had just now informed the House that he went to meet the President in connection with this bill, but he did not tell the House whether the

President has given his recommendation to it. He wanted an explanation from the Law Minister as to how the Law Ministry stood as a barrier between the Sangsad and the President. He pointed out that the Law Minister had no right whatsoever to create any im-

pediments and block the bill. Pressing the urgent need for bringing the bill to the Sangsad, the Deputy Leader of the Opposition said Leader of the House Begum Khaleda Zia had explicity stated that her party would abide by the decision of the Sangsad with regard to the implementation of the outline of the joint declaration of the three alliances: It is beyond my comprehension where lies the snag in bringing the bill the Sangsad and who is blocking it, he added.

Azad said the Law Minister, in his speech, admitted that he had to work in a very subtle way to process the constitution amendment bill. This aspect merited close scrutiny as to why the Law Minister had to conduct in this manner to bring this bill to the Sangsad elected by the people.

Azad further said the Law Minister must have to state in clear terms what he had taken to the President and what the latter had given him. He hoped that the Law Minister would inform the House whether the President had given his recommendation to it. He also hoped that their bill would be accepted.

After Azad concluded his speech, several members stood up at a time to speak on the issue under discussion.



Suranjit Sengupta, who was

given the floor by the Deputy Speaker, said the statement of the Law Minister was full of sound and fury but its produced nothing. He castigated the ruling party for the inordinate delay in bringing the bill to the House saying none had the right to squander tax payer's money by wasting time. He described the delay as an act of irresponsibility and said it also involved the question of accountability.

The Gonotantree Party

leader said the responsibility of bringing the bill in the Sangsad squarely lay with the ruling party. So the ruling party, he said, must own the responsibility for the delay in bringing the bill to the Sangsad. In this connection. he pointed out that this Sangsad was the result of the mass upsurge that was built up on the basis of joint declaration of the three alliances. There was a conspiracy in a section of the ruling party to foil the pledge given to the nation through the joint declaration. But the young MPs of BNP had foiled the conspiracy by expressing themselves strongly in favour of parliamen-

tary form of government, he said and congratulated the young members in the ruling party for this.

Suranjit Sengupta regretted that though the ruling party had been speaking about parliamentary form of government from different platforms it was reluctant to say so on the floor of the House. He said that none could ignore and bypass the joint declaration announced on November 19,1990. The movement launched on the basis of the joint declaration by both sides in the House ousted the autocratic regime and brought them to this Sangsad, he said.

He once again said it was the responsibility of the ruling party to bring the bill to the Sangsad. We have not come here to hear about technical legality and procedural snag, he added.

Gupta said the country was now being run by dual government but the dual government is not government. The country was now witnessing violence in the campus. Law and order had deteriorated sharply and prices of essentials had shot up. All these phenomenon are the results of dual government, he said.

He said the contents of the constitution amendment bill were clear and straight. Such a simple bill could only be brought by those who have political honesty and sincerely believe in it, he said.

The Ganotantree Party leader expressed the hope the ruling party would announce a definite date for bringing their own bill in this respect. They must say, he went on to add, whether they would bring it on June 26 or June 27. Cooperation of all sides would be needed for the adoption of the bill, let us talk heart to heart to create history in the establishment of unalloyed democracy. Let us give something to our posterity for upholding the principles of democracy and setting in motion the democratic spirit, he
