The Jatiya Sangsad resumed its sitting at 11.15 am with Speaker Abdur Rahman Biswas in the chair. Day's proceedings began with the recitation from the Holy Quran, reports BSS.

In the question hour only five questions were asked and all related to the Ministry of Finance and Planning. The concerned minister. Saifur Rahman, replied to a volley of supplementaries about a question concerning the country's Third Five-Year Plan.

The question hour over, a number of members, particularly from the Opposition benches, strongly objected to the inclusion of only five questions in the day's proceedings while leaving a total of 56 questions unanswered.

Awami League member Col (Retd) Sawkat Ali also supported the views of Rahmat All and demanded a ruling of the Speaker in this regard.

At this stage the Finance Minister took the floor and assured the members that he would personally look into the issue and henceforth most of the questions scheduled for a day would be answered. The Speaker Abdur Rahman Biswas also urged the Treasury Bench to ensure that the members' questions are duly answered.

Munirul Huq Chowdhury

Later the Speaker rejected two seperate privilege motions moved by the two Jatiya Party members. The motions moved by the Jatiya Party members -Munirul Huq Chowdhury and Advocate Fazle Rabbi - sought measures against the Attorney General for his alleged "misbehaviour" to the former President Hussein Muhammad Ershad, who is being tried in a corruption case. The Speaker rejected the motions on the ground that any discussion on the issue would be "subjudice" because the incident referred to was held in a court of law.

Abul Hasan Chowdhury

Taking the floor Abul Hasan Chowdhury (AL-Tangail) drew the attention of the Chair to the suspension of operations of the BCCI in Bangladesh and said this suspension at the directive of the Bangladesh Bank came as a surprise.

He said India, Pakistan and Sri Lanka did not follow suit when some western countries suspended operation of the said Bank because they would decide on the operations of the Bank by their own experience and not by the experience of other countries.

The Opposition member demanded a statement from the Finance Minister on the subject.

He said the law and order situation in the Chittagong University and the Jagannath University College was bad and demanded a full-dress discussions on the matter.



It would also go against the conception of rule of law, he said, adding that administration would lose its dynamism.





The Opposition Bench in Parhament on Sunday demanded constitution of standing committees of Parliament as required under the Rules of Procedure.

The Rules of Procedure of Parliament provides for the setting up of a standing com-· mittee for each ministry and about half a dozen other regular committees. The present Parliament has so far constituted only a few committees.

Opposition leaders who demanded constitution of the committees are : Abdus Samad Azad, Deputy Leader of the Opposition, Mohammad Nasim. Chief Whip of the Opposition, AL MP Tofayel Matia Chowdhury (AL-Sherpur) said the bill should be sent to elicit public opinion. She argued that people in our society normally become weak and






