

'Postal officials carried out Home Ministry order to censure letters'

The Jatiya Sangsad resumed its sitting Monday at 4.10 pm with Deputy Speaker Sheikh Razzak Ali in the chair, reports BSS.

The day's proceedings began with recitations from the Holy Quran.

Before the start of the question and answer hour, the Deputy Speaker wanted to know from the Law and Justice Minister Mirza Golam Hafiz as to who will answer the question on behalf of Health and Family Welfare Minister Chowdhury Kamal Ibne Yusuf, who was not present in the House at the time.

Taking the floor, the Law Minister looked at the Shipping Minister M K Anwar.

The Deputy Speaker said the chair should be informed in advance who was to answer questions on behalf of a concerned Minister if the Minister remained absent from the House. That he expressed the hope in future things should be done in the proper manner.

No sooner than the Deputy Speaker completed his statement, the Health and Family Welfare Minister entered the House and took his seat. He then answered the questions relating to his ministry.

After the question and answer hour, the Deputy Speaker adjourned the House for 20 minutes for the Asr prayer.

On resumption of the House after the Asr prayer, the Deputy Speaker disposed of all the call attention notices except the one table by Rahmat Ali (AL-Gazipur) on the situation arising out of the closure of the Bank of Credit and Commerce International (BCCI) in Bangladesh.

Rising on point of order several members demanded a statement from the Finance Minister on the closure of the operation of the BCCI. The Members who demanded such a statement were Shajahan Siraj, Shamsuddoha (CPB-Nilphamari) and Moulana Motiur Rahman Nizami.

Saifur Rahman

Speaking briefly on the situation, the Finance Minister, Saifur Rahman said the statement on the situation in the BCCI was published in the newspapers in Monday.

The operation of the bank was suspended keeping in

view the interests of the public. He said the operation of the bank was stopped Monday in Manila and it was done in India Sunday.

The Finance Minister said in Hong Kong a subsidiary of the BCCI had also been closed Monday.

He said the government had written to the owners of the bank in Abu Dhabi for protecting the interests of the depositors in Bangladesh.

He assured the House that the government had taken all possible legal steps to protect the interests of all depositors here.

He said the House could thoroughly be informed as soon as details on the situation were available.

Fazle Rabbi

At this stage, Fazle Rabbi (JP-Gaibandha) rose on a point of order saying that right from the beginning of the session none of the Jatiya Party members got any scope to move any motion under rules 71 and 164. He said the chair did not accept any motion from the JP members so far.

Rabbi alleged that they were being discriminated in the House and demanded an immediate end to this partisan outlook.

The Deputy Speaker, appeared to be helpless as at least a dozen members rose to their feet's to make their points or order.

Matia Chowdhury

He then gave the floor to Begum Matia Chowdhury (AL-Sherpur), who informed the House that two of her notices under Rule 68 and Rule 71 were pending in the Parliament Secretariat on the suspension of the Asst Post Master General of Rangpur by the government.

Elaborating her point, Begum Matia Chowdhury said that postal officials of Rangpur had only carried out the written order of the Home Ministry for censoring the letters of some opposition leaders. She said the decision of the government to suspend the officer was illegal.

As soon as Mrs Matia Chowdhury took her seat, the chair requested Deputy Leader of the House to move for the formation of various Parliamentary Standing Committees.

Prof Badruddoza Chowdhury then proposed an eight-member committee on government assurances. In the proposal, Treasury Bench Member A S M Hannan Shah was chosen the Chairman while the Deputy Leader of the Opposition Abdus Samad Azad came in the second place of the list.

The composition of the committee was strongly protested by Suranjit Sengupta who argued that it was not in order. Sengupta said, a government party member should not head a committee which is to deal on government's assurances.

Chief Whip of the Treasury Bench Khandakar Delwar Hossain then took the floor and said the names for the committee were given by the Opposition Chief Whip and it was completely in order.

Rashed Khan Menon

But his view was strongly objected by opposition member Rashed Khan Menon and Tofael Ahmed, who argued that for the sake of giving democracy an institutional shape, the Treasury Bench should place the name of the Deputy Leader of the Opposition in any committee with proper honour. Tofael also urged the government party to drop the name of the Deputy Leader of the Opposition or to give him a proper place to honour the spirit of democracy.

The Deputy Leader of the House Prof Chowdhury at this stage requested the chair to allow him to withdraw the proposal on the committee for further consultations.



Moudud Ahmed
Barrister Moudud Ahmed, the Jatiya party leader, then

took the floor to say that the Treasury Bench should further consult with the opposition parties to make these committees flawless. He argued that the present difficulties in forming the committees would be removed if the Treasury Bench held further consultations with the opposition.

The chief Whip of the ruling party again took the floor and said that the names of the members had been included in the committee after proper consultations with the opposition Chief Whip.

B. Chowdhury

Prof Badruddoza Chowdhury, then proposed a 10-member standing committee on privileges with the Speaker as chairman. The list included Prime Minister and the Leader of the Opposition, in the second and third places. But the proposal was promptly protested by the Jatiya Party member Advocate Fazle Rabbi, who said since it was an important committee, one of his party member should also be included in it.

Barrister Moudud Ahmed then stood up and regretted that although the Jatiya party was the second biggest party in the opposition, none from the party was included in this important committee. Moudud also urged the Treasury Bench to take at least one member from his party in the committee. But Prof. Chowdhury said that the composition of five other committees would be announced later. The Jatiya Party members would be included in those committees, he said.

Following the reluctance of the Deputy Leader of the House to accept Jatiya Party members in the privileges committee, all the Jatiya Party members rose to their feet and started shouting in favour of their demand. Moudud said that for the greater interest of democracy, the second biggest opposition party in Parliament must not be ignored.

He also said that if this 'genuine' demand was not accepted the Jatiya Party would have no alternative but to leave the House.

He then asked the Deputy Leader of the House under which principle the committee was being formed.

Prof. Chowdhury then took the floor and said the Jatiya

Party members had been included in almost all other committees.

Salahuddin Quader

Salahuddin Quader Chowdhury (NDP-Chittagong) then suggested that the House suspend the formation of the committees till today (Tuesday). He also said that he was not consulted either by the opposition Chief Whip or by the Treasury Bench on these issues.

Mohammad Nasim, the Chief Whip of the opposition, taking the floor promptly said that Salahuddin Quader Chowdhury was not consulted because they knew that he was an 'automatic choice of the Treasury Bench.

Prime Minister Begum Khaleda Zia entered the House when the Treasury Bench Chief Whip Khandakar Delwar Hossain was refuting the allegations of the opposition members on the formation of the committees referring to a 22-member list supplied to Parliament Secretariat by Moudud Ahmed. Khandakar Delwar Hossain said this list of the Jatiya Party did not include any name for the privilege committee.

Begum Matia Chowdhury (AL-Sherpur) then rose on a point of order saying that Rule 267(4) stipulated that no member should pass between the chair and any member who was speaking. Begum Chowdhury referred to Prime Minister Begum Khaleda Zia who entered the House when the Chief Whip Khandakar Delwar Hossain was on his feet.

The House burst into a big laughter when the Leader of the House Begum Khaleda Zia took the floor and called Mrs Matia Chowdhury as 'Musammata Matia Chowdhury'. The Prime Minister jokingly said that Mrs Chowdhury had already learnt parliamentary practices 'but I could not as yet.'

The long debate on the formation of the parliamentary standing committees came to a close when the Deputy Leader of the House, Prof B Chowdhury proposed withdrawal of the formation of the committee.

When the House resumed its sitting after the Magreb prayers with Deputy Speaker Sheikh Razzak Ali in the chair, deputy leader of the House

Prof Badruddoza Chowdhury announced the names of the members of the committee on public undertakings headed by Mian Dr Mansur Ali (BNP-Chuadanga).

Prof Chowdhury also announced the composition of the standing committee on public accounts with L K Siddiqui (BNP-Chittagong) at the head.

Suranjit Sengupta

Ganatantri Party leader Suranjit Sengupta said according to convention, the standing committee on public accounts was to be headed by the leader of the opposition. In 1979, veteran politician Ataur Rahman Khan became the Chairman of this committee. We expected that this committee would also be headed by the Leader of the Opposition or a veteran opposition MP to be nominated by the Leader of the Opposition, he added.

He further said, accountability is essential to give democracy an institutional shape and stamp out corruption.

Delwar Hossain

Joining the issue, Chief Whip Khandakar Delwar Hossain said records showed that from 1973 onward, the Chairman of the Standing Committee on Public Accounts had been selected from the Treasury Bench. Atauddin Khan was Chairman of the Standing Committee on Public Accounts in 1979. Ataur Rahman Khan was made Chairman of this committee after Atauddin Khan became Minister, he said, adding Ataur Rahman Khan was not in the opposition at that time.

Abdus Samad Azad

Supporting the contention of Suranjit Sengupta, Deputy Leader of the Opposition Abdus Samad Azad said his submission merited consideration. He pleaded for keeping the composition of the committee in abeyance for arriving at a consensus on its formation through further discussion.

Deputy Leader of the House Prof Badruddoza Chowdhury informed the House that in 1973 Zahurul Qayum was chairman of the standing committee on public accounts. In 1979 Atauddin Khan had been its chairman. After

Atauddin Khan became Minister, Ataur Rahman Khan was made its Chairman. Hence, it was not true that the Chairman of this committee had always been chosen from the opposition, he added.

Nurul Islam Moni (Ind-Borguna) said since the government spent money from the national exchequer it was not desirable that the Chairman of the Standing Committee on Public Accounts was selected from the Treasury Bench. The convention of all democratic countries in the world was that the Chairman of this committee was appointed from the opposition side, he said.

Hafizuddin Ahmed

Maj (Retd) Hafizuddin Ahmed (Ind-Bhola) said all irregular acts or practices of the past should be discarded and all that was good should be accepted. He said three independent members in this House had formed a group and it had its own identity. He pleaded for including the name of Nurul Islam Moni in the Standing Committee on Public Accounts stating that he had the experience of working with this committee in the past.

Prof Badruddoza Chowdhury to be the floor again and said more committees would be formed in future. Any women members would be included in some of those committees.

Then the House adopted the Committee on Estimated Accounts unanimously.

The Deputy Speaker then gave the floor to Mr Mohammad Abdus Shahid to table his call attention notice on matters or urgent public importance.

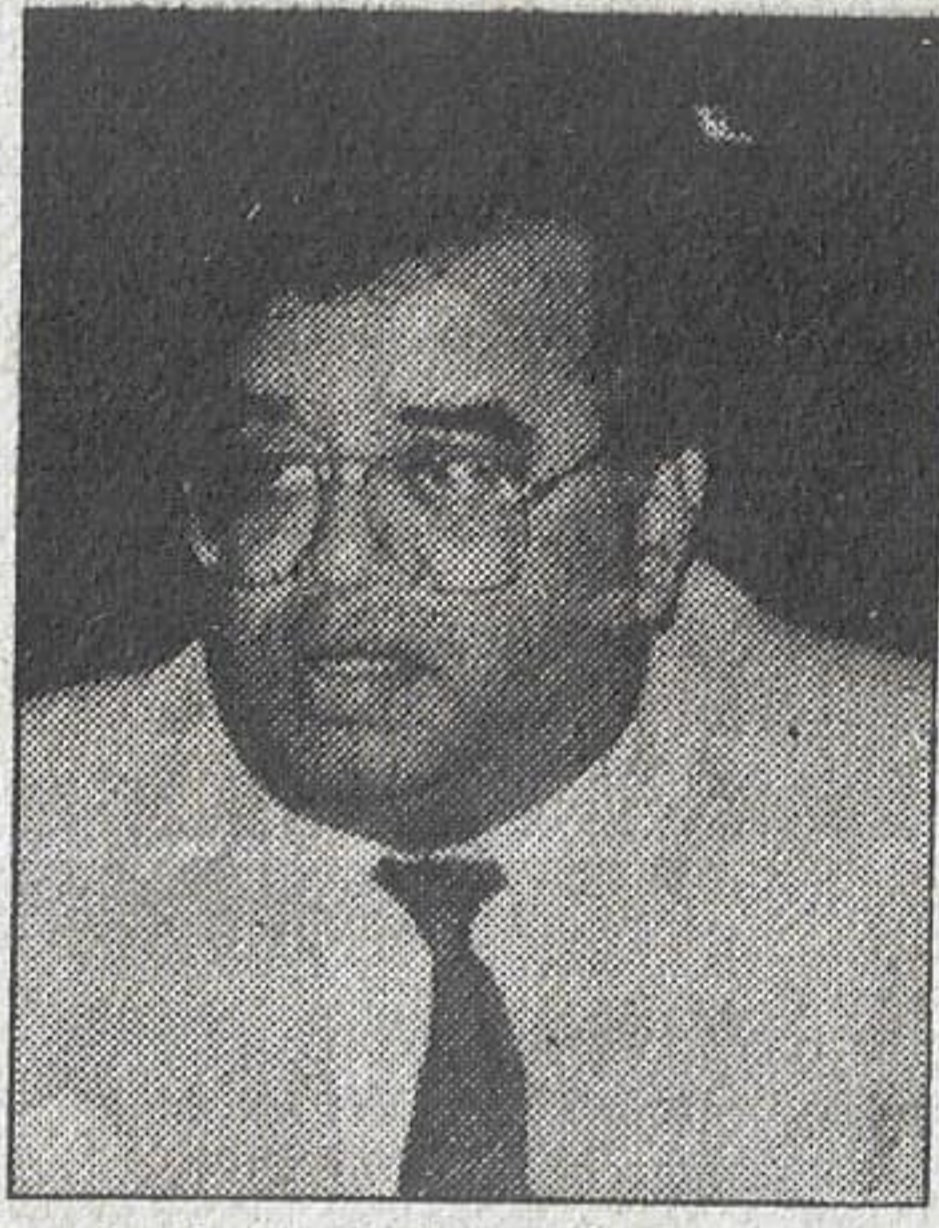
Kamal Ibne Yusuf

Health and Family Welfare Minister Chowdhury Kamal Ibne Yusuf gave a brief reply on the call attention notice.

After disposing of the Call Attention Notice, the chair gave the floor to Chief Whip of the Treasury Bench Khandakar Delwar Hossain.

Delwar Hossain said the government would give more thought on the proposed Value Added Tax Bill, 1991, and hence it would not be moved today. He said he on the advice of the Leader of the House and Prime Minister Begum Khaleda Zia, he was proposing to adjourn the House till 4 pm tomorrow.

The Deputy Leader of the Opposition gave his consent on the proposal and the Deputy Speaker adjourned the House at 8.25 pm to meet again at 4 pm today (Tuesday).



Nazmul Huda

Participating in the debate, State Minister for food Mr Nazmul Huda refuted the contention of Nurul Islam Moni. He said he was pained at the propensity of some opposition members to oppose the selection of a member as Chairman of a committee when his name was announced. It amounted to an aspersion on a member whose name had been announced as a Chairman of a particular committee but later opposed by some one, he said.

Literacy of women necessary for development: Badruddoza

Minister for Education and Cultural Affairs Prof AQM Badruddoza Chowdhury laid emphasis on literacy of women for development of human resources of the country, reports BSS.

The Minister was speaking as chief guest at the inaugural ceremony of a 10-day national workshop on development of curriculum for skills based literacy programme for women held under joint-sponsorship of UNESCO and UNDP in Dhaka Monday morning.

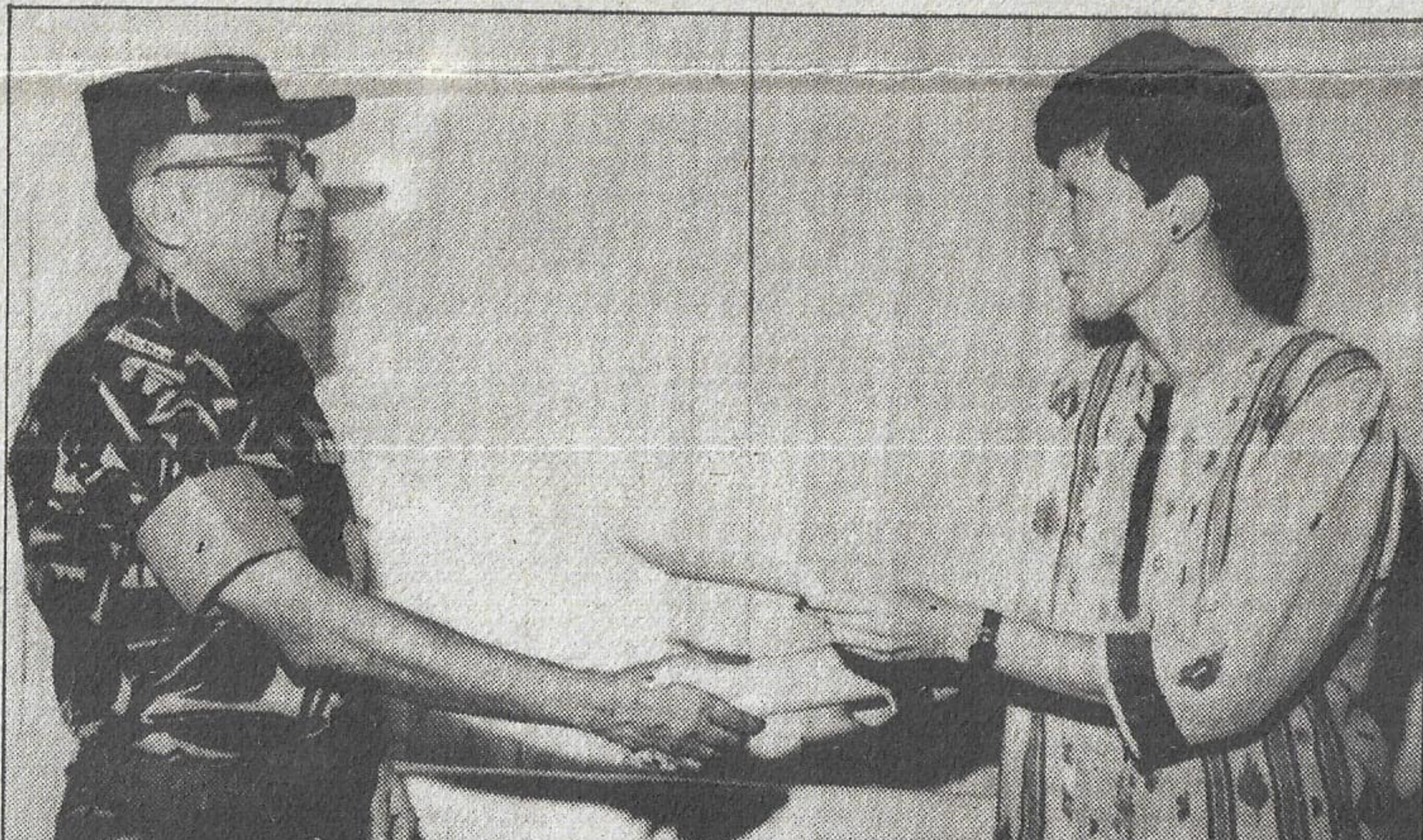
Organised by Dhaka Ahsania Mission, the inaugural function was addressed by Education

Secretary ANM Eustuf and UNDP Resident Representative Charles H Larsimont as special guests. President of the mission Al-Haj Md Selimullah presided.

The Education and Cultural Affairs Minister said the BNP government has strong political commitment for launching a mass literacy programme for spreading education among the common masses. He said since the women-folk constitute about half of our population, they will be given priority in the mass education programme. The people must be given functional education for

eradication of poverty, malnutrition and unemployment under the programme for developing human resources, he added.

Prof Chowdhury said female education is an imperative for building a prosperous society. He also laid stress on development of curriculum of female education for achieving higher literacy rate among women. He called upon the representatives of different NGOs working in this field to put in their best efforts for making the mass education programme a success.

Tk 60 lakh BSRS loan recovered against Tk 535 cr

State Minister for Finance Mujibur Rahman on Monday paid a surprise visit to the Head Office of the Bangladesh Shilpa Rin Sangstha (BSRS). He was accompanied by Joint Secretary of Finance Division Abdur Rob, reports BSS.

During the visit, the State Minister saw the BSRS documents and found that the progress of its loan recovery was not desirable. The Sangstha recovered Taka 60 lakh only during the last six months out of the outstanding loan of Taka 535 crore and 71 lakh.

The BSRS has provided loan for projects of frozen fish, cold storages, jute mills, carpet mills, distilleries, textiles mills

engineering industries and chemical industries. It was found in the BSRS documents that most of the projects had been non-functioning since their inception which proved that the investment was not done properly.

The Sangstha had realised Taka 13 crore and 61 lakh out of outstanding loan of Taka 62 crore and 22 lakh by selling the properties of 12 projects in January last.

Later, the State Minister at a meeting with the officials asked the BSRS officials to take stringent legal measures against the willful defaulters for recovering the outstanding loans in the overall national interest.

Students asked to boycott AL-backed BCL
