# Hunt for DUCSU polls candidates

Some prospective candidates of different student or ganisations may not be able to contest the July 31 DUCSU and hall union elections since the DU authorities banned participation of irregular students in the election from this

A number of would-be candidates chosen by their respective organisations were learnt to be pursuing the DU Vice-Chancellor to withdraw

the ban. Meanwhile, major student organisations including the pro-BNP Jatiyatabadi Chhatra Dal (JCD) and Awami Leaguebacked Chhatra League (S-A) were pressing for withdrawal of the ban. They had a long discussion with the Vice-Chancellor and other high officials of the university at a meeting of the DU Education Atmosphere Council (DUEAC) Monday. But the meeting ended without any result.

In the previous years including 1990, most of the candidates nominated by the student organisations for the DUCSU and hall unions polls were irregular students: Passed out several years back. the aged student leaders used to contest the polls after readmission to some diploma courses under certain departments including the library science. After abolition of diploma courses from certain departments, such leaders got enrolled in some institutions under the university. Leading candidates in the 1990 polls were enrolled in such institutes as the Institute of Food and Nutrition. A Syndicate meeting of the

university held on June 17, 1991 had banned participation of the irregular students through amending the constitution of the DUCSU and hall

The amendment was made following a proposal by the DU Teachers Association.

The amendment to the constitution, says : "now therefore, in exercise of the powers conferred by the Article 16 of the DUCSU Constitution read with Article 24 (1) of the DU Order, 1973 it is hereby provided that the provisions of Article 4 of the DUCSU Constitution shall remain suspended and inoperative for the purposes of the DUCSU and hall union elections with effect from the election of 1990-91 and only the following categories of students/examinees shall be deemed to be qualified for voters for the said elections

1) All regular and irregular students of degree (hons). preliminary, masters' degree. degree pass in industrial arts.

3) All students of pre-degree BFA. MPhil and PhD courses shall be treated as vot ers but shall not be eligible to be candidates in the elections. These amendments shall come into effect immediately for the purposes of the DUCSU and hall union elections and Article 4 of the DUCSU Constitution and Article 14 to 16 of the hall union constitutions shall be deemed to have been amended.

#### Implementation of Wage Board award demanded

Three federations of the journalists, press workers and working employees of the newspapers and news agencies and Dhaka Union of Journalists (DUJ) Tuesday demanded immediate full implementation of the Fourth Wage Board award and pay ment of all arrears, reports in a joint statement

President and Secretary General Bangladesh Federa Union of Journalists (BFUJ) Reazuddin Ahmed and Amanullah Kabir, President and General Secretary of DUJ Zahirul Haq and Ruhul Amin Gazi, President and Secretary General of the Bangladesh Press Workers Federation Musharraf Hossain and Bazlur Rahman and President and Secretary General respectively of Bangladesh Newspapers Employees Federation Jahangir Kabir and Mir Mozammel Hossain said that the remuneration of al journalists and employees are determined by the legally constituted Wage Board award

But after formulation of the Fourth Wage Board award Bangladesh Sangbadpatra Parishad had been engaging in various intrigues and procrastination to deprive them of their minimum wages.

After the final rejection of the writ petition of Bangladesh Sangbadpatra Parishad by the Full Bench of the Appellate Division of the Supreme Court there is no alternative to implementing the Wage Board in all newspapers and news agencies of the country, the leaders cautioned.

They reiterated their demand for immediate implementation of the Wage Board award to ensure peace and stability in the newspaper industry and no delay in implementing the Wage Board under any pretext would be tolerated in

From Page 1 Col. 5 authority, constituting the commission of enquiry, is not bound either to accept the report or to publish," Justice Shahabuddin told the delegation. He also said the report was intended to find out certain facts relating to the matter of enquiry.

The Acting President expressed his concern at the situation in which the university remained closed for the last seven months to the great detriment of the students and teachers. He said it was revealed in the report of enquiry as well as an admitted fact that on the demand for resignation of the Vice Chancellor, the teachers were sharply divided which ultimately resulted in the clash between two groups of students on December 22 last year.

Justice Shahabuddin disapproved of the actions of both the groups of teachers who, he said, are the respected scholars. He found that it was primarily a matter of rivalry between the two groups of teachers. The Acting President urged

both the groups of teachers to settle their differences amicably, resume classes immediately and thereby restore normalcy on the campus.

He said after 15 days of normal work in the university he would look into the matter to find out a permanent solution to the problem.

After prolonged discussions, both the groups of teachers present in the meeting promised to follow the advice of the Acting President and resume classes from to-

AMMAN. July 16: Jordan's Parliament was on the brink Tuesday of approving a new, moderate government after the nation's largest Muslim fundamentalist party opposed it. Thirty-nine members of the 80-man Chamber of Deputies had approved Prime Minister Taher Masri's Cabinet by late Tuesday afternoon, when the lower Chamber of Parliament adjourned for the day, reports AP.




