natural disasters. He strongly suggested evolving an international institutional mechanism to tackle natural disasters, promptly and effectively, so that those do not upset development plans of a developing economy, according to a message received here

Saifur said the natural disasters forcing diversion of our resources to relief and rehabilitation create impediments for our basic tasks of poverty alleviation, according to a message received here tonight from the Swiss city.

"Such disasters can no longer be treated as mere humanitarian problem, but need attention for their longer term prevention and mitigation of

consequences."

Saifur Rahman proposed creation of an international institutional framework, under an appropriate UN agency, to further the objective.

A recently prepared Government-UN joint task force report on extent of damage in the April cyclone and on fund requirements for post-cyclone rehabilitation was placed at the meeting.
