Rickshaws create traffic jam in Cox's Bazar

COX'S BAZAR, July 20: A huge number of rickshaws on Cox's Bazar roads and indiscriminate parking of vehicles in the busy areas and occupation of footpaths by small traders create traffic jams obstructing the movement of pedestrians and traffics.

According to pourashava sources, 2,100 rickshaws having valid licences ply of the roads but the number of rick shaws without licences is more than double. Conversation: DU Vice Chancellor

(continued from Page Five) questions. In the first place it will take some pressure off Dhaka University. At the same time, it is likely to create an elitist class, which many among the academics do not like. After all, a university has a social function, and a democratic government perhaps would like to see an egalitarian society to grow. If we are going to have an institution where one can get higher education, just by spending 1,000 times more money than people can afford here at Dhaka University, then that would really be buying education. am sure that in such an institution, definitely the quality is likely to be better. But then, in the long run, this may not be very beneficial to the maintenance of equilibrium in the

Private universities, under certain restrictions of course, can grown but that is an idea of a capitalist society. Since the people of this country are looking forward towards an egalitarian society, that may not be appropriate to the aspirations of society.

DS: But there is another school of thought that if our education was not so cheap perhaps it would be more val ued? For example, if a student was paying certain amount of money as fees, then he might not be easily inclined to miss his classes ...

VC : There is such a school of thought, and I have been told about that by many people. But at the university, the students stay and so I don't know how that can help matters. Institutions in this country which have been run along that line, such as the Cadet colleges, are running better, their management is better, they are spending more money. But I think if you can spend more money even on Dhaka University, we can turn it into a much better Institution. But am not personally against any private university as such, with the slight reservation that I have already stated.

DS : You became Vice-Chancellor during the time of the last regime, of president Ershad, and you saw the transition from one regime to an other. Did you have any problem in adjusting your position to the change that took place? VC: I have not faced any

problems as such. If you forgive me. I shall open up a little personal chapter. I think I was one of the very few, with the widest possible experience of university administration. To give you an example, before I became Vice-Chancellor, there

was not a single statutory body in the university on which did not sit at some time or the other. On top of that, I was the only one who was elected to the Syndicate — which is the highest executive and decision-making body of the university - three times. So served on that body for a very very long period, and I saw through all the intricacies of the administrative machinery here. So, it is absurd to sug gest that it (vice-chancellorship) was given to me on a platter, that would be wrong. DS: Do you sometimes feel that you are sitting on a hot seat? It's a dangerous seat! VC: I would say that it is

but at the same time, I would say that the Vice-Chancellor of Dhaka University enjoys a high social prestige. But, if you would allow me to digress a little bit here. when I was appointed, I came

here with a lot of ideas and imagination, but I found that many problems were left unattended for long, unfortunately. My predecessors were all highly distinguished persons, but at the same time, have a feeling that some of them swaggered into this position only for the fancy of it, and could not or did not really try to do enough for the improvement of this institution. As a result, the problems I inherited were enormous. Let me give you some ex-

amples: for several years, many of the important committees did not meet, and many of the problems remained unsolved, for five, six, seven years; then some of the problems that cropped up with the increase of student population of teachers and needs of the institution, that should have been taken care of, but were not taken care of. For example, the question of land The government took away land from the Dhaka University from time to time by requisition. But very little attention was paid to recover these lands. I have recovered only a little bit of it, and I am trying to recover some more. During the 16 months that I have been in office. I have been grappling with all these and many other old problems which has made my task all the more difficult. But at the same time.

wouldn't say that I am frustrated or that I have given up all hopes. I am still hopeful that things can be made better, and I am looking forward to a better future for the uni-DS: Thank you, Mr Vice-

Delay in school bldg construction affects students
