Describing the budget for the fiscal 1991-92 as propeople one. Ashraf Hossain said preparation of a budget for a country like ours was really a very difficult task. He pointed out that during the nine years of autocratic rule, mills and factories and all productive sectors were destroyed in a planned way.

Tracing the economic condition of the country immediately after the emergence of Bangladesh as an independent nation, he said the then government had nationalised the jute, sugar and textile mills and took over the management of the industrial units of the non-Bangladeshi nationals. These industrial units incurred heavy losses due to mismanagement and corruption, he

He said when the BNP government came to power after the political change-over in 1975 it took certain concrete steps to augment production in these nationalised mills and factories through efficient management. The then BNP government also took many vital steps to boost the national economy. As a result, production in industrial units and agricultural farms started in creasing. In fact, some of the industrial enterprises began earning profit. The country also produced surplus food grains at that time, he added.

The BNP member regretted that at a time when the econ omy of Bangladesh started picking up the autocratic regime usurped state power. The autocratic regime returned many mills and factories to their former owners at almost throw-away prices. These owners of denationalised industrial units took bank loans worth crores of takas in the name of BMR but in turn either squandered this fund or transferred it to foreign countries. Consequently, a large number of mills and factories were closed down resulting in unemployment of workers and disruption of

economic activities, he said. Ashraf Hossain said during the autocratic regime no new mills and factories were set up

in the country. Under the patronage of the autocratic regime, the industrialists used bank loans for personal aggrandisement instead of investing them in industries. Things have come to such a pass that 21 per cent of GDP is now owned by mere five per cent of the upper class people. Again 20 per cent people of the country now shares 46 per cent of GDP while 70 per cent of the country's total population is landless, he added.

He disagreed with those who blamed the workers for losses in mills and factories saying that inefficiency of the persons holding managerial position and their lack of initiative and drive were responsible for losses in these enterprises. He also repudiated the claim that the public sector mills and factories had surplus workers. Citing an example, he said the number of workers in Adamjee Jute Mills is now much less than what was during the Pakistan period. Paying tributes to workers, he said these people had played a bold role during all democratic movements, war of liberation and anti-autocracy movement.

Opposing the investment of foreign capital, Ashraf Hossain said independence of a country was held hostage by foreign donors. Though the foreign investors come to an underdeveloped country with some technology and capital they take away more than what they invest, he observed.

Hossain demanded construction of a bridge over the river Rupsa, establishment of a university in Khulna division, restarting of Khulna Medical College, direct road communication between Dhaka and Khulna and reopening of the fish processing industries and the closed down industries in

Kalyani helps the handicapped get new lease of life

think about further development of their children. Some paediatricians also refer their patients to the school.

When a child is brought for

admission, several tests are done to assess the child in a clinic called Shishu Bikash Clinic, which is situated inside the school. The child is examined by a paediatrician — then psychological tests such as Denver Developmental Screening Tests are done to determine what the child lacks or in other words what can be done for mental and physical development of the child. There are two physiotherapy teachers who were given two years training by physiotherapists of VSO (a British voluntary organisation). They provide physiotherapy to children when it is needed and also train mothers to deal with their wards. There is also one speech therapy teacher who helps children who have The programme is called

difficulties in talking. Mrs Sufia Akhter showed us different parts of the school. There are several small classes situated on the first floor of the building. Instead of the conventional way - the class rooms are identified by the names of flowers such as Komolkoli, Champakoli, Korobi etc. Different classes have different age groups. There were not more than ten students in any class and each class had at least two teachers. The

teacher-student ratio is much higher than any normal school. As we went through differ-

ent classes we found teachers deeply involved with their students. There were different types of students - some with downs syndrome, some were severely mentally retarded and some were physically handicapped. As we passed by we marked that more emphasis is given on physiological as well as mental development rather than the conventional learning. There is arrangement for giving physiotherapy, speech therapy and special education to the cerebral palsy children. We noticed that some mothers were waiting outside while some were inside the classes helping their children. Actually there is a three way approach among the teacher and the student - the teacher and the parent — and the student and the parent.

There is also distance training programme for children who live outside Dhaka. package programme. Parents of handicapped children are trained how to manage their children through booklets. After a certain period reassessment is made and further courses are advised. There are about 650 cases like this spread all over Bangladesh. For this service their is no fixed charges. Parents pay according to their

Kalyani has got another school at Balitha Union of Dhamrai upazila (45 km from Dhaka) where there are arrangements for normal education, vocational training, education for the handicapped and adult education.

We asked Mrs Sufia Akhter how they meet the financial requirements. She said that Unitarian Service Committee of Canada in Bangladesh (USCC) has been funding Kalyani school for years. Besides Bishop Bekkers Foundation, Netherlands, provided them with different educational materials. The school also receives local donations. At times cultural shows are arranged to raise funds. While talking she mentioned about her teachers. Though they are not well paid they seem to enjoy their jobs as they are rendering service to a special kind of children. She mentioned that those teachers are being paid half of the salary for some time as funds of 1990 and 1991 have not been cleared by the concerned local authority.

As we were about to depart we were requested to go upstairs. There we saw all children together having a music session. As some of them were singing chorus — two senior students Shanta and Yasmin Ara Khan were dancing - just like other normal girls. After a short while they had stopped dancing and we started coming back to our office - with a very lively memory - and on the way we were thinking about Kalyani - how it helped those children to get back the rhythm of life.
