20 newspapers, agencies accept WB award

A large number of newspapers and two news agencies in Dhaka have accepted the demand for enhanced salaries for journalists and newspaper employees. The programmes of movement in these newspapers and news agencies have been withdrawn.

A rally in support of the demands of journalists and employees was held on Wednesday noon in the Jatiya Press Club premises with President Reazuddin in the chair. The meeting was addressed by BFUJ Secretary General Amanullah Kabir and M A Aziz and Mafizur Rahman, Convener and Joint Convener of Central Action Committee respectively. The speakers congratulated the management of the newspapers and news agencies which had accepted the demand and called upon others to accept the demand immedi-

Flood water continued to recede from the affected areas Wednesday but waves of diarrhoeal diseases trailed behind

as low as eleven deaths and 712 people attacked, unofficial sources put the figure at manifold higher from the diseases, caused by intake of impure water and adulterated food by the affected people and scarce medicare and relief.

The displaced people now on embankments, railway tracks and other high places and the vast multitude marooned in far flung areas are threatened more where life saving medicine and relief are difficult to reach due to inadequate logistic support.

Officials confirmed 7 deaths in Bogra and another 4 in Pabna and 300 people attacked in each district. Tangail, Manikganj, Jamalpur and Strajgonj were also under the attack of diarrhoeal and intestinal diseases where officials put the total number of attacks at 712. Unofficial sources said 63 people had died of diarrhoeal diseases in Netrokona in the last fortnight.

The flood forecasting centre of Water Development Board in Dhaka said the water level of the major rivers receded substantially.

But, he regretted, those leaders started creating pressure on the authorities to allow special admissions' into the university. Student leaders got admit

ted in the Institute of Nutrition and Food Science of the University under 'special admission' arrangements prior to the 1989 DUCSU elections. But the diploma course of the institute they were admitted was abolished following strong criticism by various quarters including the press, the Vice-Chancellor observed. This year, the special ad-

mission' system was cancelled by the Syndicate following a proposal by the DU Teachers' Association, he said. But the student leaders were adamant about their demand despite being informed of the contro-

versy over the issue, he added. After a number of major student organisations announced their boycott of the polls, a joint meeting of the teachers. Syndicate, members Provosts. Deans, Proctors, and leaders of the associations of the university officials and employees unanimously on July 22 supported the Syndicate decision. The meeting followed submission of separate memorandums to the VC by various student bodies stating their decision to boycott the polls. The Syndicate shifted the polls date from July 31 to August 5. However, the VC said that

some 150 students in a procession Monday evening damaged the offices of the VC and the pro VC and locked the Returning Officer's office at the administrative building. The processionists later

stoned the gates of his official residence. During the incidents, gun-
