6 die in Chittagong house collapse

CHITTAGONG, Aug 4: Six people including a child died in house collapse and over two thousand people were ren-dered homeless by the rain-fed flash flood that overflew the Matamuhuri and Sanghu rivers running down the hills through the district.

Ali Hossain (40) and his wife (40) in Rangunia upazila, Farida Begum (35) and her sixmonth-old baby in Satkania upazila died when their mud houses collapsed due to heavy rain. Two other people who died also in house collapsing in Satkania upazila had not yet been identified, district administration sources said.

Nine out of 14 upazilas in the district are in the grip of flash flood following three days' heavy rain and downhill roll of waters from upper areas. Raujan, Hathazari, Phatikehhari, Rangunia, Fatia, Lohagara, Chandanish, Satkania, and Boalkhali are the worst affected upazilas.

Roara, Barma and Satbaria villages under Chandanaish upazila have been washed away at 106 mm.

Over five lakh people have been affected and transplanted aman crop on vast tract of land have gone under water.

About 70 per cent areas in Satkania, Chandanaish, Lohagora, Raujan, Rangunia, Phatikchhari upazilas have gone under waters overflowing the Matamuhuri river and Shankar and Dhalu canals. Road communication between Chittagong and Cox's Bazar remained snapped by water flowing over the road at Satkania point.

Several shelter centres were opened in the affected upazilas where the displaced people were being given cooked food, officials said. 600 maunds of rice have also been allotted as emergency supplies.

Talking to UNB at her official residence in Dhaka Saturday night Sheikh Hasina further blamed that conspiracies were on to withdraw the Constitution Amendment Bill. "But any such conspiracy will be resisted by the people and our

Asked about allegations made by the Prime Minister that some MPs were obstructing the passage of the bill, as reported in the press, Hasina posed a counter question : How can one blame MPs for obstructing a bill on which discussion was yet to be completed ?

On constitutional compulsion of passing the bill by October 10, the Awami League chief said since we do not believe in presidential system, it is of no consequence to us.

Asked if Awami League sets repeal of the Indemnity Ordinance as a pre-condition for the passage of the Constitution Amendment Bill, Hasina replied in the negative.

She, however, said repeal of the Indemnity Ordinance is a must to ensure true democratic dispensation, justice, human rights and rule of law in the country.

EC to announce schedule for by-elections: Badruddoza

The Election Commission is expected to announce a schedule for the by-elections to 11 vacant seats of the Jatiya Sangsad, Deputy Leader of the House Prof Badruddoza Chowdhury informed the Jatiya Sangsad Saturday, reports BSS.

Prof Chowdhury, who is in charge of the Election Secretariat in the parliament. said the Election Commission informed him by-elections to the Madaripur-1 and 10 other constituencies would not be delayed indefinitely.

Elections to the 10 seats were postponed due to the catastrophic cyclone of April 29. This decision of the Election Commission was unanimously supported by the Jatiya Sangsad, he added.

Atlantis deploys satellite

CAPE CANAVERAL, Aug 3: A 120 million dollar communications satellite was deployed from the US shuttle Atlantis on Friday as it cruised above the Pacific Ocean on the first day of a nine-day space mission. The tracking and data relay satellite, used by NASA to maintain communications between ground controllers and spacecraft, was jettisoned from the shuttle's payload bay by small explosive charges and sent drifting away into space, reports Reuter.


