Hearing of 'stay part' of writ petitions today

Open voting system in parliament is nothing new : Experts

Repeal of the Election of President (Amendment) Ordinance is expected to be published in an official gazette today.

Law Minister Mirza Golam Hafiz arrived in Dhaka from Panchagarh on Friday afternoon to take necessary actions for repeal of the Ordinance. He had a meeting with Prime Minister Begum Khaleda Zia at her Sugandha office at night.

Meanwhile, the Single Bench of the Supreme Court will hear the writ petitions against the Election of President Act and the

Ordinance today at 3 pm. Barrister Amirul Islam who along with other lawyers moved the writ petitions on behalf of Awami League leader Abdus Samad Azad and others told The Daily Star last night that although the Ordinance was being repealed, "its ghost is already in existence within the Act itself."

He said that the whole object of filing the writ petitions was "to protest the policing part of the mechanism under which everybody is going to know who is voting for whom. It's not election but selection".

Another writ petition on the same Act and the same Ordinance filed by Barrister Abdur Razzak and others on behalf of Jamaat-e-Islami leader Sheikh Ansar Ali will be heard by the Single Bench simultaneously.

The government side maintains that the Election of President Act was very much in accordance with the Constitution 12th Amendment Act passed unanimously by the parliament and endorsed in a referendum.

Transport strike called off

The transport workers' strike in the northern districts and the countrywide transport strike called from Sunday have been withdrawn.

The leaders of Bangladesh Road Transport Workers Federation announced the decision Friday night to withdraw the strike following understanding reached with the government and the transport owners after fruitful talks.

The road transport workers of northern districts went on strike on September 27 to realise their seven-point demand that included issuance of appointment letters by the owners. In support of the demand, the Workers Federation also called the countrywide indefinite transport strike from Sunday.

The leaders of Workers Federation also reciprocated by announcing withdrawal of the ongoing strike in North Bengal and also the scheduled countrywide strike.

The federation leaders including Manjurul Ahsan Khan, Habibur Rahman Khan, Ismail Hossain, Abdur Rouf, Shahjahan Khan, Roy Ramesh and others attended the meeting.

The owners were represented at the meeting by Haji Zainul Abedin, M A Kader,

Hasan Imam, Rafiqul Hossain Kajal, Shah Alam, Rostam Ali Khan, G M Siraj, M A Gafur and others.

The road transport workers of Naogaon were on strike for 54 days till Friday in support of their seven-point demands. The strike spread to all the 16 districts of North Bengal from September 27 when the transport workers of these districts joined these in Naogaon.

The Bangladesh Road Transport Workers Federation declared on Thursday that the transport workers all over the country would go on an indefinite strike from Sunday (Oct 6) in support of the 7-point demand of federation's North Bengal unit.

Several rounds of talks between the government and the federation leaders were held since Wednesday.

Earlier, in Friday afternoon, a transport workers' rally was held in front of National Press Club. Organised by Bangladesh Road Transport Workers Federation, the rally demanded immediate issuance of appointment letters to the transport workers. The speakers at the rally also urged the

BSB faces funds crisis

Bangladesh Shilpa Bank (BSB), faced with serious liquidity crisis, is seeking funds on emergency basis from various traditional and non-traditional sources, both internal and external, reports UNB.

Official sources said BSB has recently sought an emergency fund of Tk 100 crore from the Bangladesh Bank to weather the crisis caused mainly because of huge accumulation of overdue loans.

It also asked for fresh line of emergency credits from various traditional multilateral agencies, including the International Development Association (IDA), Asian Development Bank (ADB) and the Islamic Development Bank (IDB).

Fund has also been sought from non-traditional sources, including FMO of the Netherlands and the banking institutions in Japan.

To date, BSB's overdue

loans stood at more than Tk 350 crore while the outstanding loan amounted to about Tk 1000 crore.

The recent recovery drive of the government, BSB sources admitted, hardly yielded any result as the recovery is still going at a pace similar to that of the last 10 years.

Faced with the current liquidity crisis, BSB has been forced to become "too much" conservative in financing new projects, the sources said, and is now pursuing a "go slow" policy.

The fund crisis also put the Bank in serious trouble to meet its debt-servicing liability. According to the sources, the BSB has sought from the Ministry of Finance a five-year moratorium on debt servicing.

Although fund was asked from various sources, officials said, response might not be too positive, at least from the

two of the most prospective multilateral lending agencies — IDA and the ADB.

These two lending agencies stopped new line of credits to BSB and BSRS (Bangladesh Shilpa Rin Sangstha) in 1984 and their suspension has not yet been lifted.

They might not be responsive to the latest BSB appeal for emergency funds, sources apprehend, until their condition of privatizing the BSB and the BSRS is fulfilled.

However, the Bangladesh Bank is learnt to have agreed in principle to provide BSB with the credit it asked. BSB is also hopeful of positive response from the Jeddah-based IDB and FMO of the Netherlands.

Official cautioned that the liquidity crisis of the BSB would have an adverse impact on the overall investment situation, it being the country's only long-term lending agency.

JP, JCD clash, situation tense in Chittagong

CHITTAGONG, Oct 4: At least 10 persons were injured and a number of shops damaged when Jatiyatabadi Chhatra Dal (JCD) and Jatiya Party (JP) activists clashed at Andarkilla in the city this evening amid tension over holding of a public meeting tomorrow.

Both the BNP-backed JCD and the JP have called public meetings at Lalidighi maidan tomorrow afternoon.

The JP has called the meeting to demand release of the party Chairman and deposed president H M Ershad, a programme that precedes its countrywide observance of 'Ershad release day' on October 10. Its Lalidighi meeting will be preceded by the

Y'slav forces bomb Croatian positions

YUGOSLAVIA, Oct 4: Federal forces bombed and battled Croatian positions Friday, while the Defence Minister pledged to halt the offensive, reports AP.

The fighting, which threatened the ancient Adriatic port of Dubrovnik, came before Federal Defence Minister Gen. Veljko Kadijevic promised that his troops would cease hostilities. The promise came in a deal arranged in a meeting chaired by the Dutch Foreign Minister in the Hague, the Netherlands in which Croatia agreed to halt its blockade of federal army garrisons.

The jets destroyed a strategic bridge near the port of Zadar, the Croatian Defence Minister said.

Croatian forces had virtually abandoned the strategic Banija region just south of Zagreb, the defence ministry confirmed. And hundreds of refugees, army clutching just plastic bags of belongings, were fleeing.

The Yugoslav military warned Friday that Croatian forces had retreated into the

medieval walled town of Dubrovnik and were "holding it hostage together with all of its people."

"The army will do everything to spare Dubrovnik, a city of infinite historical and cultural value," said the army statement carried by Tanjug news agency.

"But we have undisputable proof that Croatian units are holding there, and particularly the foreign mercenaries to whom Dubrovnik means nothing, are preparing its destruction in order to blame the Yugoslav army for that act of vandalism," it said.

The statement appealed to the "citizens of Dubrovnik and the international public to prevent this criminal act."

The Croatian Defence Ministry denied its forces had

retreated into the city. It said reinforcements were being rushed to the area, without power, water and communications for a fourth day.

Earlier report said, Yugoslavia's federal army agreed Friday to halt its air, land and sea offensive against Croatia in exchange for Croatia lifting its blockade of federal garrisons, reports AP.

The agreement, which included federal acknowledgement of the republic's right to secede, was announced at a press conference after more than two hours of consultations between Serbian President Slobodan Milosevic, Croatian President Franjo Tudjman and federal Defence Minister Gen. Veljko Kadijevic here.

AL wants 'free and neutral' election to presidency

Awami League leader Abdus Samad Azad Friday made a strong plea for making a free and neutral election to the presidency through withdrawal of the Presidential Election Act, in keeping with the "politics of consensus", reports UNB.

Justice Chowdhury went to meet Golam Azam alone at around 9 pm and had a sitting for about an hour.

Jamaat leader Sheikh Ansar Ali MP and former MP Professor Mujibur Rahman were also present during the meeting.

In a statement Azad, who is also the deputy leader of the opposition in parliament, commented: "The Presidential Election Act, 1991, passed on August 14, is nothing but a black law".

It has curbed the fundamental rights blocking the process of electing the President in a democratic way", he said. He also described a certain part of the Act as repugnant to the constitution.

When contacted Jamaat Secretary General Moulana Matur Rahman Nizam confirmed it and said that Justice Chowdhury sought blessings of Professor Golam Azam for his election as President of the republic.

When asked Jamaat leader Sheikh Ansar Ali told this correspondent that Justice Chowdhury explained to Golam Azam, the background of his being a candidate in the presidential election.

Azad also remarked that the withdrawal of the "undemocratic ordinance" in the face of opposition from the people, the political parties, lawyers and professionals had

CPB central body report under fire

The CPB started its fifth conference in the city on Thursday.

The central committee of the CPB had abandoned the idea of class struggle much earlier with the initiation of 'Glassnost' and 'Perestroika' in the Soviet Union by President Gorbachev. But a very strong section of CPB leaders are still trying to pursue the line of 'class struggle' complying with the Marxism and Leninism.

After the placement of the central committee report which suggested alliance with the patriotic democratic forces on national issues, four central committee leaders participated in the discussion yesterday.
