# Major changes in CPB constitution, structure

The six-day fifth congress of Communist Party Bangladesh (CPB) concluded Tuesday with some major changes in the party constitution and structure.

The congress which began here on October 3, initially dwelt on the report of the central committee presented by party General Secretary Saifuddin Ahmed Manik and the delegates later discussed other matters.

The delegates and the central committee members for six days deliberated on the current national and international scenario with the focus on the recent changes including the 'setbacks' to socialism in some parts of the world.

While polemics over the international communist movement vis-a-vis Marxism and Leninism dominated the deliberations of the delegates, most delegates are learnt to have stressed that socialism is the inevitable outcome of the class struggle in the society and hence the struggle for socialism has to be reinforced.

According to the late night report, the CPB expanded its central committee from 43 members to 77 members.

Till writing of this report, the delegates were voting to elect 77 members of the central committee.

The elected central committee members will elect the party President, General Secretary, Assistant General Secretary, the Presidium and the Secretariat.

Satfuddin Ahmed Manik is expected to be elected as President but Nurul Islam Nahid and Mujahidul Islam Selim would be contestants for the post of General Secretary, party sources said Tuesday night during voting. The result of election would be available Wednesday morning, the sources added.

At a press briefing in the evening (Tuesday) party spokesman Mozammel Hossain termed the congress a total success even amid changed situation in world politics. He said that 'we narrowed our

### Victory procession

The 592 delegates present out of 698 also changed the name of congress. From now on, it will be named as national conference which will be held once in every four

This is for the first time that the CPB adopted a provision of Presidium in its party constitution which would be composed of one-fifth members of the central committee. The provision of the council of delegates has also been constituted at the congress.

Conditions for getting party membership has been relaxed and expression of different opinions inside the party liberalised.

The only Article inserted

in the constitution on recommendation from hardliner Mujahidul Islam Selim was that the ideals Marx, Angels and Lenin would be the basis of

On the concluding day reports of Control Commission. Audit Committee Credential Committee were presented before the delegates and were approved.

During the discussion of Control Commission report Manjurul Ahsan Khan challenged his expulsion order from the central committee last year and demanded voting on the issue. He however later withdrew his voting proposal, a delegate to the closed-door session said. The other two reports were passed smoothly. the source added.

The congress honoured 18 partymen including Rabi Niogi, Ashu Bharaddaj, Santash Banarjee, Hena Das and Shani Datta for their contribution to the party.

The six-day congress cost about Taka five lakh 30 thousand, according to the organ-

Awami League Members of Parliament under the leadership of their Chief Whip Mohammad Nasim had earlier entered the Parliament chamber at 2-15 pm to formally lodge their protest against holding of the presidential election, in the Parliament chamber.

Addressing the Chief **Election Commissioner Nasim** said that his party had been urging the Election Commission not to hold the presidential election in the parliament chamber and an application was submitted to the Commission Tuesday morning by Abdus Samad Azad, Deputy Leader of the Opposition in Parliament.

Mohammad Nasim said that they did not get any reply. Instead election was being held at the chamber. He requested the Chief Election Commissioner to change the venue of the election.

In reply Justice M A Rouf said that the Election of President Act, 1991 provides for holding of election at the parliament chamber, and at this stage it was impossible for him to change the venue. Two cases were also lying with the Supreme Court in this re-

Earlier, Awami League's bid to project Justice Chowdhury as the consensus candidate of the opposition failed because other component parties in the opposition took exception that they were not consulted before the submission of the nomination paper of Justice Chowdhury

Awami League leader Abdus Samad Azad and six others. Jamaat leader Sheikh Ansar Ali and Jatiya Party leader Barrister Moudud Ahmed had filed writ petitions seeking stay of the election and rule as to why the Election of President Act 1991 which provides for open election should not be declared as ultra vires of the Constitution.

A single vacation bench of the Supreme Court of Bangladesh, after three days of hearing, on Monday refused to stay the election. And the election was finally held on schedule.

The gates of the chamber and the lobbies were guarded as usual by Jatiya Sangsad sccurity guards. No visitor was allowed in the galleries.

A large number of policemen, both uniformed and plain-clothes, were posted. There however, was no untoward incident. Instead the Members of Parliament belonging to BNP and Awami League shook hands and exchanged pleasantries inside the chamber. They awaited the announcement of results in their respective benches.

Dr Badruddoza Chowdhury. officially the third in line in BNP's chain of command entered the chamber silently and easting his vote left stlently without exchanging greetings with other leaders,

Talking to newsmen just after casting his vote Abdur Rahman Biswas said that with his party BNP commanding 170 of the 330 seats in the Parliament it was a matter of simple arithmetic to conclude that there was no question of his losing the election.

Replying to a question he said "I am lucky and happy that the representatives of the people are reposing their unconditional confidence in me under the amended Constitution."

"In a democracy the voice of the majority represents the voice of the people. I will do my best to discharge my responsibilities, faithfully and honestly to fulfil the expectations of the people."

Before the start of voting all the major parties and groups including BNP, Awami League, Jaliya Party, Jamaat and Communist Party had meetings in the Parliament building.

Justice Badrul Haider Chowdhury was present at the meeting of AL legislators at the office of the Leader of the Opposition Sheikh Hasina.

Addressing the meeting the former Chief Justice said You have defeated autocrats, but autocracy is yet to be defeated Those who would refrain from casting votes would only push the nation towards complexi-

Thanking those who had proposed and seconded his nomination as presidential candidate he said. 'I shall feel proud even if I get only one vote in addition to those of the proposer and the seconder', he added.

Shamsuddoha, the leader of CPB Parliamentary Party, told newsmen Tuesday morning in the Sangsad Bhaban that his party MPs would not cast vote in the election, according to a party decision taken at its congress. He did not claborate but other party sources said that the decision was taken mainly due to Justice Chowdhury's meeting with Golam Azam which was criticised by the congress.

The Five Party Alliance in a statement while clarifying its position bitterly criticised both BNP and Awami League and alleged that these two parties were engaged in party politics only. The statement said that BNP had no confidence in its MPs which led it to choose open ballot system which was against the fundamental principles of universal franchise.

Five Party maintained that Justice Chowdhury was, in true sense, a party candidate of Awami League but the AL did not discuss with any other party before nominating him.

JSD MP Shajahan Siraj said his party decided to abstain from voting in consultation with other opposition parties because both BNP and AL nominated their candidates without consulting them. The election of the President could be held avoiding all controversies and that was desirable, he observed.

Prof Abdul Hafiz MP of NAP told The Daily Star that his party decided to abstain from voting because Justice Chowdhury's meeting with Golam Azam created confusion and made him controversial.

Moulana Obaidul Haque MP of Islami Oikka Jote said that he abstained from voting since the election was not held on the basis of consensus. He also opposed the open ballot sys-

Jatiya Party, Jamaat and other smaller opposition parties virtually made him an Awami League candidate.

The ruling party candidate Abdur Rahman Biswas got 170 votes of his own party, the BNP and two independent members, hailing from his home district.

The scenario unveiled the weakness of both the BNP and the Awami League. Both the parties are alienated from their former allies mainly due to their go alone policy.

The smaller partners of both the parties alleged that they were ignored in decisionmaking specially in nominating the presidential candidate. The Jamaat-e-Islami, which

lent its support to the ruling party in forming the government in March and in the election of a Speaker, felt hurt as BNP government did not fulfil any of its demands including the granting of citizenship to Prof. Golam Azam, implementation of the judicial inquiry report on Chittagong University and action against those who assaulted Jamaat leader Matiur Rahman Nizami on the Dhaka University campus. Besides, Jamaat leaders were aggrieved as BNP leaders did not apprise them of the situation arising out of the promulgation of the Ordinance and the subsequent developments.

The promulgation of the controversial ordinance by the BNP also influenced the Jamaat decision to abstain although Jamaat leaders were consulted befores nominating Abdur Rahman Biswas.

Political analysts see Jamaat's stand on the election as a tactical move to maintain its opposition stance without harming the BNP. The Jamaate-Islami helped the ruling party through abstention, an

But one thing that has become very clear from the alienation of the two major parties from their allies is that both the big parties maintain a big brotherly attitude towards their smaller partners. The process of consultations which is an essential requirement in a parliamentary democracy has not been given due attention by both the BNP and the Awami League.

Although the election of president, the titular head of state under a parliamentary system, generated a lot of heat over the last two weeks. One encouraging aspect was that the two major parties took part in the elections.

Participation in the election by the Awami League despite ferent aspects of the election law made the democratic process lively and credible. Those who boycotted should have protested by casting their votes against their rivals.

The overall atmosphere in parliament was jovial. The BNP and the Awami League members were exchanging pleasantries on the floor.

Prime Minister Begum Khaleda Zia after casting her vote remained in the House for over an hour while the Leader of the Opposition Shetkh Hasina left the House immediately after casting her vote.

The presidential election, otherwise thought to be an uneventful occasion turned out to be a significant one due to the ruling party's mishandling of the election.

The promulgation of the Ordinance regarding presidential election was the biggest blunder committed by the BNP.

The ruling party saved the situation by rescinding the Ordinance. But it will perhaps take some time for the wounds to heal.

### A pass for a newspaper

By Staff Correspondent The Press Information Department (PID) miserably failed to issue entry passes to journalists to cover the president election at the Sangsad

The PID is generally responsible for issuing passes to journalists covering government functions, particularly those in parliament. But this time the PID issued only a few passes to journalists - due to reasons unknown.

When contacted the Acting Principal Information Officer Moqbul Ahmed said that they tried to issue one pass for each newspaper and to correspondents in Dhaka representing the foreign news media.

He said there were only 80 scats for journalists in Parliament and the PID issued 80 entry passes.

But it was observed that more than one-third of the total seats in the press boxes were empty during the presi-

dent election. The Acting PIO further said that the Election Commission gave 80 passes for journalists among the PID officers, radio and television staff and journal-

When asked how they fixed the priority in distributing passes, PlO Moqbul Ahmed said that he distributed the passes assessing the priority among the media and gave one pass to each newspaper irrespective of its being a daily or a weekly.

According to sources the Principal Information Officer did not inform the Information Minister Nazmul Iluda about the quantity of passes required for newsmen who always cover Parliament. However, when the matter

was brought to the notice of the Information Minister Nazmul Huda he rang the Acting Principal Information Officer to know about the matter.

But it was too late and many journalists who usually cover Parliament failed to get the passes.
