3 killed, 28 injured in road accidents

Three persons were killed and another 28 injured, eight of them seriously, in four seperate road accidents in the city and at Torarhat Near Manikganj Saturday.

Nur Muhammad 15, a student of the Lati Bawant School, was seriously injured while on his way to school when a speeding truck hit him near Konapara at around 9am. He succumbed to the injuries while being taken to the Dhaka Medical College Hospital, po-

A case was registered with Demra police. The driver managed to escepe from with the truck (Dhaka-At-484).

Babul (8), died on the spot while trying to cross the road when a speeding truck hit him on the Dhaka-Aricha highway near Barbaria at around 2pm. The driver managed to flee from the scene of the accident along with the truck.

Jasimuddin (30), a rickshaw puller, was scriously injured when his rickshaw was hit from behind by a speeding bus near Dholairpar at around 6:30 am.

He succumbed to the in-

juries while being taken to the Mitford hospital: a case was registered with Demra police. The driver escaped with the bus (Dhaka-Cha-1661).

At least 28 persons were injured, eight of hem seriously. when a Bogra-bound passenger coach plunged into a road-side ditch on the Dhaka-Aricha highway near the Torarghat bridge about four miles from Manikganj town.

According to fire service officials here, the driver of the coach lost control while crossing a speed-breaker at top speed near the bridge over the Kaliganga river at around 10:50am. The coach plunged into the ditch water.

Fire service personnel from Manikganj rescued 28 passengers from teh submerged coach. All the injured passengers, including two women and a child, were taken to the Manikganj sadar hospital.

Eighteen of the injured were admitted at the hospital while the rest were released after first-aid. Condition of eight persons was stated to be

No govt response to Ershad's parole plea

Tajul tampered with JP register: AG

Attorney General Aminul Huq yesterday pointed out in the court trying deposed President Ershad that the register of the Jatiya Party was tampered with to show collection of party funds, reports UNB.

"It's full of interpolations, each page of the register has been interpolated," Hug told the court during cross-examination of defence witnesses Tajul Islam Chowdhury which resumed for the sixth day yesterday.

Tajul, Jatiya Party Office Secretary, who produced the register to the Court laying the claim that Tk 1,90,81,565 found at Ershad's former official residence belonged to the party, denied the charge of interpolations.

Those are corrections, the clerk has recorded and I received the money It (Jatiya Party) is not a commercial firm and hence we did not look at it that way," the Defence witness

Ershad also chairman of the Jatiya Party was charged with amassing wealth beyond known sources of income. He was already sentenced to 10 years' imprisonment for keeping illegal arms and faces three more corruption cases.

The prosecution was tough. "This (register) is very a important document. He (Tajul) is to prove each and every entry in it. If he can't, he is liable to prosecution," the Attorney General said.

In one of the entries, the prosecution said, the figure Tk 5,000 was interpolated to Tk 1,15,000. Similar interpolations are evident at 65 places in the register.

The defence witness denied but said "the original figure was not Tk 5,000 as suggested by the Attorney General, it was Tk 1,10,000 corrected to Tk 1,15,000." The defence claimed more

than Tk 2 crore was raised from within the Jattya Party during August-November 1990 for buying the Dhanmondi party central office and the money was kept with party chairman Ershad. This included Tk 1,46,42,800 collected through sale of primary membership tickets and the rest raised through subscriptions and donations from party leaders.

The prosecution however refuted the claim saying collection of so much money was not possible during that period when the anti- government movement like strikes, hartals, demonstrations and processions had gripped the entire

country. Tajul refuted the prosecution contention. "Anti-government movement was evident only in Dhaka," he said.

When the prosecution laid newspaper files before the Defence Witness in support of his contention, Tajul said, "It is in the newspapers but I'm not aware of the movement outside Dhaka."

Questioned about his wife, Tajul termed as "a downright false" that his wife Shamsunnahar Begum divorced him in

"Here you see a certified copy of the document which says your wife Shamsunnahar Begum divorced you and it was registered in the Kazi Office of

Goran on November 2, 1984, the Attorney handed over a

paper to the defence witness. "It's downright false," reacted Tajul, "may be in black and white. Allah knows, I failed to understand." Tajul and Shamsunnahar are living as husband and wife.

Tajul denied he received the notice of divorce by his wife. "It is absolutely false, my wife is with me."

The cross-examination of Tajul by the prosecution will continue today (Sunday).

Meanwhile, the Chief Defence Counsel of deposed President Ershad in jail said the government had not responded to his client's petition seeking release on parole for going to the "famine-stricken" area of his home district

Advocate Sirajul Haque however, could not say when Ershad applied and for how many days' parole.

Talking to reporters outside the court where the former President faces trial on corruption charges, Advocate Haque said he believed release of Ershad on parole would not harm the government for "he (Ershad) does not want harm to the government."

The former president has informed "me that he is mentally tortured" in jail and advised to move with the authorities to ensure facilities for him as allowed in the jail code, Advocate Haque said.

"We are examining the jail code and if the former President is deprived of due facilities, we may move the higher court," he added.

Advocate Haq said he is not allowed to consult his client in a free atmosphere. He visited Ershad in jail about two months ago and that, too, in presence of 4-5 security offi-

Chiluba new Zambian President

LUSAKA, Nov 2 : Frederick Chiluba, a 48-year-old trade union leader, was sworn in today as Zambia's President following the election defeat of veteran President Kenneth

Kaunda, reports Reuter. Chief Justice Anel Silungwe administered the oath of office in front of the two-storey red brick High Court House in

Lusaka. Chiluba, a diminutive figure standing only five feet (1.5 metres) tall, swore into a lowered microphone to uphold the Constitution and the law

"without fear, favour or ill will." The swearing-in, watched by thousands of euphoric Zambians, took place at noon (1000 GMT) as a cooling breeze* swept the normally sweltering southern African

Hours earlier, Kaunda conceded descat in a graceful broadcast in which he also said he intended to continue working in the opposition.

Kaunda is the most senior African statesman to have been ousted from power by popular vote - in elections he made possible by abolishing 17 years of one-party rule late last year. True to my word, I would

like to congratulate President Frederic K Chiluba sincerely," Kaunda said. Thousands of jubilant Zambians flashing the thumb-

and-forefinger sign of Chiluba's Movement for Multi-Party Democracy (MMD) witnessed in the swearing-in ceremony. Kaunda, 67, and his United National Independence Party

(UNIP) had held uninterrupted power since independence from Britain in 1964. "As I leave state house to leave for my farm (in northern province)..... I would like to

thank all Zambians who made it possible for me to serve them in many capacities before and after independence," Kaunda said in his broadcast. "I tried to do my best for Zambia and if I failed in any way it is not because I did not

try to do my utmost for the people of the nation," he said. Commonwealth observers brought in to monitor Zambia's first multi- party elections for 23 years said on Friday the voting had been fair and free from signs of corruption or coer-



Even though the government begins food-for-work programmes from mid-September every year, this year in many districts of the northern region the local administration has not even schemed the test relief operations as yet.

It is reported that in Lamonirhat, Kurigram and Rangpur districts most of the MPs belonging to the Jatiya Party wanted to get involved in the scheming of the test relief operations. But there was a tussle between the MPs and the local administration particularly with the chairmen of the upazilas who did not want the JP MPs in test relief opera-

The people in these areas are surviving with general relief. In most cases members of the local union parishads are not lifting test relief as it has become difficult to misuse the relief materials in presence of the army, said a local political

Because of the acrimonious political relationship between the local MPs, most of whom belong to the Jatiya Party and the BNP government, the political leadership there remained silent and in many cases provoked the people not to participate in food-for-work

programmes. A Magistrate of Rangpur told this correspondent that some people engaged in foodfor-work programmes refused to continue their work at one stage saying that all the relief goods were coming for them and those should be distributed without their doing

any work. However, before the visit of the Awami League chief Sheikh Hasina the army managed to involve a section of the people to participate in a food-forwork programme to repair the road cum-embankment on the river Teesta from Gangachara upazila headquarter to Alambidhitor and Naohali — the two unions, much talked about for their vulnerability to river erosion. However since the last two weeks test relief operations have been launched in different areas under the direct supervision of the gov-

The BNP Secretary General of Faridpur district Rezaur Rahman Sarkar Rana said that the government did not hesitate to intervene in the situation as soon as possible. He however regretted that the test relief alloted by the administration was not even lifted by the local UP mem-
