The nation today celebrates the first anniversary of the people's triumph over the autoeratic regime of Lt Gen Hussain Muhammad Ershad.

The nearly nine-year-long regime of Ershad collapsed before the might of the masses with the transfer of power to the Chief Justice Shahabuddin Ahmed on this day in 1990.

The success of the people's struggle against Ershad's illegal rule heralded a new era of enormous opportunities for the nation's return to democracy. Though brief in duration, the ceremony of transferring power to the Chief Justice by Ershad at the President's Secretariat in the afternoon of December 6 will remain everfresh in the memories of the people who eagerly followed the occasion on the television

screen. Indeed, the whole nation bunt into profound jubila tion, almost ecstatic with this first ever constitutional change-over in the country.

The three alliances of the mainstream opposition political parties had earlier unanimously chosen Justice Ahmed as the Vice-President of the Republic to whom Ershad would tender his resignation. The formalities involved Vice-President Moudud Ahmed resigning to President Ershad who then appointed Justice Shahabuddin to the post, under the provisions of the Constitution. Soon after wards Ershad resigned to the newly appointed Vice-President as per the constitutional provision of Article 51 (3).

as the Acting President according to the Article 55 of the Constitution, also headed the interim government which conducted the general elections on February 27 this year.

The liaison committee of the three alliances which formulated the modalities of the power transfer, held long parleys to name a consensus vice president after Ershad had announced his decision to resign with immediate effect on the night of December 4, 1990 over radio and television.

Sinking all differences, the leading politicians, particularly the BNP chief Begum Khaleda Zia and the Awami League president Sheikh Hasina, agreed to nominate the Chief Justice after day-long discusmeeting on Dec 5.

The national consensus on the nomination of Justice Ahmed was made public that evening. The jubilant masses across the country rallied behind the idea of the Chief Justice as the Acting President, confident in the belief that they would be able to exercise their democratic rights under his impartial stewardship leading to the election of the true representatives of the people to power.

Ershad's dramatic Dec 4 declaration to quit in the wake of one and a half month's intensive mass movement, fuelled by the killing of Dr Shamsul Alam Khan Milon on Nov 27, delighted the masses who thronged the streets and public venues throughout the Justice Ahmed, who acted sions in the liaison committee country even late into the the general rejoicing that

Cheering people started dancing and singing songs of joy and victory.

The city of Dhaka witnessed a series momentous events in that night and the following day. Some, infuriated by the excesses of the illegal Ershad regime, chose to give vent to their frustrations by attacking the residences of top Jattya Party leaders and associates of the regime, ransacking and setting on fire the Allahwala Building in Motifheel where the main offices of the then ruling Jatiya Party were housed. Sporadic armed clashes were also reported elsewhere in the city. But the fury and the wrath of the masses were overshadowed by

gripped the entire city duringthe course of Dec 5.

The "people's dias" erected at the Purana Paltan-Topkhana Road crossing where cultural programmes and victory celebrations attracted hundred of thousands of people from every walk of life, was the focal point of the popular celebrations.

The final phase of the mass upsurge had begun on October 10 when the mainstream opposition political parties lay demonstration demanding

Since then, until Ershad's eventual fall, the days had been filled with high political drama, apprehension and expectations leading to the triumph of people's power.

four months of fiscal 1991-92 stood at Taka 2286 crore compared to Taka 2034 crore in the corresponding period of the last fiscal year. The increase was mainly due to improved earnings from garment sector. Other major export items like jute faced 6.7 per cent, frozen food 13.5 per cent and leather 29 per cent decline.

The depressed economic activities also resulted in a decline of money supply by over 9.5 per cent compared to June, 1991. The contraction in outstanding credit was mainly responsible for the decline in money supply, the MCCI study said.

The import also declined by 21 per cent during the July-September, 1991 compared to the corresponding period of

During the first quarter of 1991-92, the imports in terms of Letter of Credits (LCs) opened amounted to Taka 2578 crore. The figure was Taka 3276 crore for the same period of last fiscal year.

In Dollar terms, the figure was 24 per cent lower for the current fiscal year. The major items which faced a decline in import were milkfood, soybean oil, liquid petroleum oil (POL) cement and industrial machin-

ery and raw materials. The import for industrial machinery and raw materials fell by the highest 42 per cent. The reason was due to the go slow of the industrial sector.

The foreign exchange reserves position improved during the period due to import contraction and increased foreign aid disbursement. Improved export and remittance earning also contributed to the increased reserve position. In October, 1991, foreign exchange reserves increased to 1130 million US Dollar compared to 880 million US dollar in June 1991.

As an impact on the economic situation, the revenue receipts of the government fell short of its projection by Taka 16 crore.

The economic activities were also hampered by a restrained flow of domestic credit. The total domestic credit as on October 10 declined by 3.14 per cent compared to June 30, 1991. Total domestic credit during the July-September period was Taka 24,570 crore compared to Taka 25,368 crore in June 1991. Credit to private sector also declined by 3.61 percent during October compared to June 1991.

One case had been filed against Kazi Zafar Ahmed for abuse of power as a minister regarding import of sugar at a higher rate causing financial loss to the government.

Another case concerned violation of the detention order under Section 7 (B) of the Special Powers Act.

The trial began on May 13 against Kazi Zafar in absentia as he had remained a fugitive from law and justice since December 26, 1990.
