Massive potato farming plan

Dec 14: A massive scheme has been taken up to bring 4250 hectares of land under potato cultivation in 11 southern districts during the current winter season, reports

According to official sources, of the total, 550 hectares have been brought in Barisal, 850 hectares in Pirojpur. 100 hectares in Jhalakathi, 900 hectares in Bhola, 100 hectares in Borguna, 100 hectares in Patuakhali, 250 hectares in Rajbari, 250 hectares in Madaripur, 450 hectares in Faridpur, 400 hectares in Gopalganj and 300 hectares in Sharlatpur, the sources added.

At least 34,450 metric tons of potato are expected to be produced in these districts during the season.

Buyer, seller indifferent to fish fry consumption

RAJSHAHI, 14: Defying the government order the fish fry are being caught indiscriminately in different parts of the district.

It is reported that, a section of fishermen in Sadar. Poba. Moharpur, Tanore and Godagari upazilas of the district are catching fish fry of ruhi, katla, mrigel, magur and

singht from rivers and canals. Everyday a huge quantity of different varieties of fish fry are being sold in different markets, hats and bazars of the

districts. It is leant that some of the fishermen are using current nets for catching these fish fry.

The government has banned the catching of fish fry below nine inches to implement its open water fish production programme.

It is alleged that, law enforcing agencies are often play a stient role to take any stringent action against the illegal catching of fish fry.

If indiscriminate fishing goes on unabated, it is apprehended that the quantity of fish in the district will be de-

Obscene films

Obscene films are being exhibited through VCR and VCP's in different parts of the district for long time without any hesitation.

A section of dishonest video shop-owners of Rajshahi city have been exhibiting obscene and blue films through their mobile unit of VCR and VCP's on the very nose of law enforcing authority of the district. These shows are also arranged in the rural areas.

Local social workers opined that such exhibition of naked films vitiated the social atmo-

sphere in the district greatly contributing eroding moral values of the young boys and girls. Moreover, with the screening of blue-flim, the number of anti-social activities has increased alarmingly in the rural areas of the district, they

further alleged. Besides, the video business has been going on unabated throughout the district includ ing Rajshahi city without licences for years together.

It is alleged that the owners of a good number videoshops have been running their busi ness by paying monthly pay ments to a section of officials of the Customs Department.

As a result, the government is deprived of a huge revenue in this sector from Rajshaht

Protection of migratory birds needed

NETRAKONA. Dec 14: The local and migratory birds are gradually disappearing from this district due to indiscrimi nate hunting and scarcity of fish in the beels and haors, reports UNB.

According to an expert, or about 500 species of birds seen here. 200 are winter birds which migrate from the Siberian region to avoid the biting cold.

These birds locally known as Dighari, Kaldighari, Sarails Balibush, Pankourt, Burt Storcks. Herons. Dahuk and Koa were found abundantly in the beels and haors of the district during the winter season.

But scarcity of fish the main food of these birds, has compelled large flocks to fly else-

BORGUNA. Dec 14 Farmers unable to procure bank credit and carn their living from the small holding are being compelled to sell out their farm land turn destitute. concerned observer said here. reports UNB.

The situation aggravated after the natural calamities lashed the district several times during the year. Farmers who lost crops needed credit support to restart production but unscrupulous elements and corrupt officials stood in the way.

Bangladesh Krishi Bank and other rural credit institutions in Borguna region without proper directions for distribution of credit to the farmers, were either holding up or diverting credit to non-pro-

ductive sectors, they said. Most of the small and marginal farmers are reeling under the rigorous of certificate cases instituted against them.
