# Speaker pulls curtain as Law Minister scolds treasury MP

By Staff Correspondent A ruling party MP's bid to introduce a bill in the Jatiya Sangsad failed Thursday because of stiff opposition from the Law Minister, Mirza Golam

The bill to be introduced in the name of Abdur Rab Chowdhury, an MP from Lakkhipur belonging to the BNP, was the first item of the legislative business on the private members' day. The bill sought to raise the retirement age of government servants to

60 years from 57. When Rab Chowdhury took the fibor and sought teave of the House to introduce the bill, sharp came the resistance from the Law Minister. Amid a battle of words between the Minister and the Treasury Bench MP, Speaker Shaikh Razzaque Ali, presiding over the sitting, abruptly adjourned the House for five days' until January 22.

# No KAFCO project under present terms, JS told

The Karnaphuli Fertilizer Company (KAFCO) project un der joint venture will be implemented if foreign shareholders reconsider certain provisions of the Memorandum of Understanding (MOU), reports UNB.

This was stated by Industries Minister Shamsul Islam Khan in parliament Thursday during the question

The minister made it clear that the 435 million translation project would not be implemented under the existing terms and condition which go against the national interest.

Replying to Nurul Islam Moni (Ind), he said a high powered committee is now reviewing the MOU signed with foreign shareholders, including those from Japan, at the fag end of the Ershad regime.

Certain provisions of the agreement including pricing of gas at 75 cents and guarantee against foreign loans to the project were found contrary to the national interest.

The Minister informed the House that the project would be implemented only if the foreign shareholders agreed to change the anti-national provi-

The original agreement signed in 1981 stipulated gas price at 1.7 dollar per 1000 cft to be supplied to the proposed factory from Bakhrabad gas field . But the price was slashed to only 75 cents in the MOU signed in November

# Disinvestment of industrial units may slow down

Disinvestment of 40 public sector industrial units may slow down because of workers' resistance to the formalities required to expedite the process, concerned sources said.

The government plans to sell 26 units to the highest bidders while 100 per cent shares of eight units and 49 per cent shares of the rest of the six units will be sold to members of the public. The Investment Corpo-

ration of Bangladesh (ICB) has shown interest in buying the 51 per cent shares of the seven holding companies out of the total of eight. To divest the holding com-

panies, some legal procedures like diluting the groupings in the share structure are needed. The holding companies, partly disinvested earlier have three groupings in shares - Group A involving government shares of 51 per cent, Group B-1 involving public shares of 34 per cent and Group B-2 involving workers' shares of 15 per cent. The dilution of the groups needs the holding of an Extraordinary General Meeting (EGM) of the existing shareholders.

To implement an agenda in the EGM requires the support of 75 per cent of the shareholders which, in this case, may come if the group B-1 shareholders representing the public do not oppose. But it is still uncertain whether Group B shareholders will support the dilution of the groupings as the government plans to sell the shares to the ICB at an average market price.

Sources said that Bangladesh Steel and Engineering Corporation reported to the ministry that it had faced resistance from the workers and staff in holding the EGM. The EGM has not yet been

US, Bangladesh joint disaster relief

exercise tomorrow

American and Bangladeshi air force and army personnel will begin a joint disaster relief exercise in the country on Saturday, reports UNB.

The training teams will work in Jessore area using two Bangladesh Air Force AN-32 aircraft and an American C-130 transport plane, said a US Information Service press release in Dhaka Thursday.

The training exercise is being launched in continuation of earlier cooperative efforts in disaster preparedness, it said.

A small group of US army and air force personnel will work with their Bangladeshi counterparts to perfect techniques for providing aid to those stricken by natural calamity, the release said.

In the first such bilateral exercise, in 1990, the crew worked on techniques which were successfully utilised by the Bangladesh Air Force after the April 29 cyclone last year.
