Tyson sentenced to 6 yrs in jail



Indiana, Mar 27 Mike Tyson was sentenced to six vears in prison

for rape and led away to jail on Thursday after prosecutors said the former heavyweight champion would rape again if given the chance, reports Reuter.

The boxer, wearing a dark grey suit, was frisked, handcuffed and then led away to a state prison processing centre near Indianapolis, smiling slightly and carrying his over coat atop his arms.

Judge Patricia Gifford sen tenced Tyson to 10 years on one count of rape and 10 year each on two counts of deviate conduct, but suspended four of the years and ordered the sen tences to run concurrently. She also fined him 30,000 dol-

Tyson's lawyers asked for and were denied an emergency order to release him on bond pending an appeal, and a full hearing on the request was set for today.

Special prosecutor Greg Garrsion told reporters the 25-year-old fighter could be a "marked man" once in the prison system and warned that he could be behind bars for as much as 10 years if he did not behave himself.

Other experts said he could be out in as little as three.

Marion county prosecutor Jeffrey Modisett told the sentencing hearing that Tyson still does not realise the seriousness of his offence and is an "opportunist rapist" who would take advantage of similar situations again.

Tyson, who arrived at the court in a red limousine, slumped slightly behind a desk when the sentence was announced but otherwise was expressionless.

The fighter, who in 1986 at the age of 20 became the youngest man ever to win the it four years later, was immediately led away by guards. His victim, 19-year-old col-



It was not immediately clear where he would be sent to serve his full term, but officials said one of the two Indiana state prisons were the most likely destinations.

The length of the sentence was not a surprise because the six-to-seven-year range in rape cases such as Tysons.

But the fact that Tyson went immediately to jail was not expected. Court observers had suggested that his lack of an adult criminal record would make the Brooklyn-born fighter a safe bet for release on bond pending appeal.

In a rambling 12-minute statement before sentencing. Tyson told the court :"My conduct was kind of crass. I agree." But he added,"I didn't rape anyone. I didn't attempt to rape anyone. I'm sorry. I did something but I didn't mean to . . . my conduct was kind of

Judge known as stern but fair

INDIANAPOLIS, Mar 27 judge who sentenced Mike Tyson to prison on Thursday has a reputation as a fair but stern law-and-order jurist who in her 13 years on a bench has ordered four murderers sent to the electric

chair, reports Reuter. Judge Patricia Gifford, 53, is also a former prosecutor who helped draft an Indiana rape law that prohibits defence lawyers from questioning rape victims in court about their sast sex lives.

As an assistant prosecutor for Marion County she won convictions in 48 of 52 rape trials she handled. She was one of the first women prosecutors in the United States to handle sex crimes.

Over the years she has earned a reputation of being tough but fair.

She has been considered especially tough on men convicted of sex offences - as Tyson was - and has a record of handing out long sentences to sex offenders who attack women and children.

She is the mother of a daughter who is about the same age as Tyson's rape victim, Desiree Washington, 19.

INDIANAPOLIS. Mar 27 : Mike Tyson's attorneys hoped to persuade an appeals panel Friday to

release the boxer from prison while they try to get his rape conviction overturned, reports "A case isn't over until an

appeal is finished," said attorney Alan M Dershowitz, the Harvard law professor known for taking on celebrities' appeals. That lady in the opera hasn't sung yet."

Within an hour after Tyson was ordered to serve six years in prison, Dershowitz asked the Indiana Court of Appeals to intervene on an emergency basis and set the former heavyweight champion free pending

an appeal. A three-judge Court of Appeals panel was to consider the request at a hearing scheduled to start at 1900 GMT Friday.

This is a very, very serious appeal," Dershowitz said. "The great tragedy is if we win this appeal a year down the line and Mr Tyson would have spent that time in prison."

Dershowitz hopes to convince the appellate court that Marion Superior Court Judge Patricia Gifford "was simply wrong" when she decided Tyson should be put in jail immediately after his sentencing Thursday.

Tyson was convicted Feb 10 of one count of rape and two of eriminal deviate conduct. On each count, Gifford handed Tyson 10 years with four years suspended. The terms are to run concurrently.

"Every moment Mr Tyson spends in confinement is a moment of injustice." Dershowitz said. The attorney said Indiana

law allows people convicted of felonies such as rape to be set free pending an appeal. Dershowitz said his client is willing to accept any conditions the appellate panel might want to attach in letting Tyson free on bail.

Darshowitz said it was preposterous to think Tyson might flee.

"If there's one human being on the face of this Earth who couldn't flee, it's Mr Tyson said Dershowitz, noting his client's celebrity status. "He just wants to be vindicated. He wants to appeal, and he wants

to go on with his life." Indiana legal authorities said Dershowitz was using a rare legal maneuver to try to get the Court of Appeals to make its own ruling on whether a person can remain free pending an appeal.

"It's very normal on the part of the trial judge to order a person to jail," said Richard P Good, executive director of the Indiana Prosecuting Attorney's Council. "What she did was what she does in most cases. That's the norm.

"The unusual thing is for the Court of Appeals to get involved," he said.

Good said the appellate panel has the power to make its own ruling on an appeal bond without finding that the trial judge acted improperly or

abused her discretion.

The former champion on Thursday was sentenced to 10 years in jail by Judge Patricia Gifford in Indianapolis, Indiana, for raping a beauty pageant contestant in his hotel room last July. Gifford suspended four years of the sentence and Tyson was immediately led away to begin serving a six-year prison term.

Duva said he felt the heavyweight division would remain exciting in Tyson's absence.
