Libya given last chance, says US

WASHINGTON, Apr 1: The United States, welcoming a UN vote imposing sanctions on Libya, said Tripoli has been given a last chance to help prosecute two men charged with the 1988 bombing of Pan Am flight 103 over Lockerbie, Scotland, reports Reuter.

The aviation, arms and diplomatic sanctions, approved by 10 of the council's 15 members with five abstentions, do not take effect until

"The United Nations Security Council has spoken out for collective action against state-supported terrorism," a senior State Department official told Reuter.

"The resolution is very fair ... it is well-targeted and in view of the concerns of other countries, it gives Libya another chances to complyuntil April 15," he said.

The official, who spoke on condition of anonymity, said the resolution was specifically designed to target the means that Libya has used to support terrorism" - airlines, diplomatic facilities and weapons purchases.

Earlier, at a State Department daily briefing ahead of the UN vote deputy spokesman Richard Boucher dismissed a reported offer by Libyan leader Muammar Gaddafi to meet President George Bush as a last-minute ploy to try to delay the UN Security Council vote imposing the sanctions.

The vote is intended to gain Libyan compliance with the terms of the previous resolution on the subject, resolution 731. Bocher said.

He did not, however, deny that the vote might be used at some point as the legal frame-

work for an armed attack on Libva if Tripoli fails to comply

with the UN order. Britain has reported that in the midst of the controversy some foreigners are having problems obtaining visas from

Libya to exit the country. Boucher said the United States had no reports of Americans experiencing such difficulties. But he admitted that Washington, which has no diplomatic ties with Tripoli, has little accurate information about the country and does not even know exactly how many Americans may be living there.

The official US estimate is 500 to 1,000 most of the Americans are believed to be oil workers.

American passports have not been valid for travel to Libya since 1981 and two weeks ago, when UN negotiations on sanctions were heating up, the State Department warned Americans in Libya to consider leaving.

Women refugees in Dechuapalong and Damdama camps narrated stories of rape, murder and loot when the UN Emissary visited them. Many of the refugees burst into tears while recalling their nightmarish experiences. He talked to some of the refugees through an interpreter and asked them the reasons of fleeing their native land. The refugees said they were forced to flee in the face of repression.

Eliasson said he had very interesting talks with Prime Minister Begum Khaleda Zia, Foreign Minister ASM Mostafizur Rahman and officials of the Foreign Ministry.

State Minister for Relief Lutfar Rahman Khan and Foreign Secretary Reaz Rahman were among others, who accompanied Eliasson on

Meanwhile. The visiting special envoy of the United Nations Secretary General Wednesday held final round of talks with Foreign Minister A S M Mostafizur Rahman on different aspects of the Myanmar Muslim refugee problem.

The first round of talks took place here Tuesday while the final round of the discussions followed the Special Envoy. Jan Eliasson's visit to the camps where the refugees have been sheltered.

According to the report the recent political changes in Bangladesh permit a fresh look at development priorities and constraints. New approaches need to recognize the wide disparities in income and in other indicators of well-being between the urban and rural areas, by gender and by access to resources and to services, the report observes.

Referring to the role of government in economy the report says that it has been a declining one and blames the government for spending a modest part of its resources on the social sectors and on the human development priorities.

But, the report argues, 'in some respects progress was made, but not at rates commensurate with the magnitude of the problems. Efforts are noteworthy which attempt the provision of direct access to employment and income.

On the question of resource scarcity and its utilization, the report observes that for the country resource scarcity reflected by low savings and low taxation levels remains a cructal problem.

The report further observes that more resources are no solution unless ways are worked out to strengthen the implementation and delivery capacity at the grassroots and intermediate levels.

Lauding the cooperation between the government and the

Non-Government Organizations (NGOs) the report says 'there is considerable collaboration between the government and NGOs in the delivery of social services. In education some slow progress is made by the government in the formal part, and more rapid by the NGOs in the informal part. But the report observes "donor assistance grows but the total effort in primary and secondary education falls far short of minimum needs."

The report has identified the highly centralised functioning of the government as a serious handicap to its effectiveness in contributing to human development. The reports says "the role of the government in human development must start from the recognition that there is a complex pattern of social organizations, which can and need to be brought to convergence towards objectives of human development. The government can play a catalytic role in this process and mobilise part of the resources

Observing that human development is emerging as a shared concern of the government, the NGOs, the external donors and the people themselves the report suggests these need to be welded together in a coalition where each contributes according to strengths and experience. The role of local governments in these coalitions is an essential one, as clearly expressed in the country's Constitution."

The UN Special Envoy who arrived in Cox's Bazar Tuesday for an on the spot assessment, moved among thousands of people carrying documents of their Myanmar nationality.

He visited Dumdumia-1, Dumdumia-2 and Dechuapalong-2 camps at Ramu upazila of the district, housing an estimated 95,304 refugees.

Eliasson witnessed resistration of the refugees, the housing facilities, supply of food and halth care activities of the government and other volunteers organisations in the

"It is very difficult task and the problem is humanitarian," he said. "We must try to prevent influx.

When asked if he was convinced that the refugees are Myanmar nationals he said "it is evident that they have come from Burma (Myanmar) ... I have noticed some important documents belonging to the refugees.

Replying to a question whether he would suggest UN economic sanction or use of military action against Myanmar, Eliasson said "it is too premature to suggest such steps at the moment, we are holding talks with both the governments.

The Special Envoy of UN Secretary General returned to the capital this afternoon.

Eliasson arrived Bangladesh Monday at the first-leg of his two-nation tour to resolve the refugee problem between the two coun-

Environment experts said the salinity problem would intensify in the future if the Farakka problem is not solved immediately. They said the residual effect of the salinity would ultimately make the water of the river unusable throughout the year for the

KNM does not have any water treatment plant. When the mill was set up, it was worked out that it would use water from the river obviously overlooking any future salinity problem in the river Bhairab. At present, a water treatment plant for the mill would cost about Taka 20 crore. But the mill does not have the financial solvency to invest in a plant.

To facilitate private sector imports, quarantine procedures should be simplified and made applicable to plant species rather than particular varieties, while all import restrictions should be removed on seeds for 'uncontrolled' crops as well as approved varieties of "controlled" crops.

Registered growers may also import small quantities of seeds of unapproved varieties of controlled crops for testing. Release of new varieties of controlled crops could remain

subject to government testing

and approval, following a streamlined procedure. There should be a gradual elimination of subsidies on BADC seeds- a measure which will be accelerated to allow the private sector to compete in

the seed market. The bank report said among the goals of the new policy were to 'promote balanced development of public and private sectors at all stages from breeding to marketing and simplify import procedures for seeds and varietal material.

BADC has an extensive network of seed farms, processing facilities and sales centres reaching down to the upazila level and, until recently, BADC was the sole supplier of improved seeds for most crops (with exception of jute and certain vegetables).

Many farmers either don't have access to improved seeds, or rely on smuggled varieties from abroad, the World Bank

report said. It said import of improved seeds or germ plasmas for development of new strains had been largely restricted, while the quarantine and approval processes had been cumber-

If one becomes or is made stateless he or she will never be deported according to a judgement of the High Court in 1981 which is printed in DLR 32. He can simply live in a country without enjoying the rights of a citizen.

But the source, a lawyer, said quoting the World Book Encyclopedia Volume Four that "some people become stateless as a result of government action and a government might punish citizens by expatriating them, leaving them stateless."

"In the United States, a stateless person is considered an alien," the source said adding that " unlike other aliens, however, stateless persons have no government from which to ask protection."

According to the lawyers, the Encyclopedia also says, that many aliens have a permit called a 'visa' allowing them to visit or live where they do not hold citizenship. 'lllegal aliens' are non-citizens living in a country without proper papers.

Bhutto told a news conference that government policies were to blame for what she called Pakistans' widening budget deficit and soaring inflation. She gave no details, reports Reuter.

Eight killed as IAF planes crash

NEW DELHI, Apr 1: Two Indian air force aircraft crashed in Punjab Wednesday, killing eight crew members, United News of India reported. UNI attributed the crash to "some technical snag," The agency did not elaborate. The AN-32 planes came down in Punjab's Ludhiana district. The 115,000-marrair force has 701 combat aircraft. Most of them are from the former Soviet Union, reports AP.
