Iraqi, Libyan outputs may dominate OPEC meeting

BRUSSELS, Apr 18:
Uncertainties about oil production from Iraq and possibly
even Libya - both targets of international sanctions — could
dominate a special OPEC
meeting next week, reports

Ministers of the 13-nation Organization of Petroleum Exporting Countries had scheduled the talks in Vienna on April 24 in case of a serious weakening in crude prices in the spring when demand for oil normally drops.

But prices, buoyed partly by unease over Libyan exports, have been stronger than expected, making it unlikely the group will feel pressure for immediate production cuts.

OPEC is a critical supplier of the oil to the industrialized world. Despite the cartel's chronic inability to enforce its own limits on production. OPEC still has an enormous impact on the cost of energy.

Pierre Terzian, Editor of the Paris-based newsletter Petrostrategies, said the anxiety over Libya — and its effect on prices — has masked the continuing excess supply of

"The market is weaker than it seems," he said.

In February, the ministers agreed to restrain production by more than a million barrels of oil a day in a desperate bid to halt a steep slide in prices.

With super-producer Saudi Arabia in the lead, the cartel reduced pumping last month to a total of 23.5 million barrels a day, still above its spring cetting of 22.98 million barrels a day.

AFP adds from Baghdad: Iraq has accused Saudi Arabia and the United Arab Emirates, two leading partners in OPEC, of flooding the market with crude oil in a move that could depress prices.

Oil Minister Ossam Abdel Razzak al-Hitti also reported that foreign companies had offered to participate in reconstruction projects in Iraq, including American firms who announced their willingness to take part in rebuilding the offshore oil terminal at Al-Bakr.

Hitti said Iraq rejected the US offers, saying his country was determined to rebuild its infrastructure — damaged in the Gulf War —without outside help and would turn to foreigners only if it could not handle the job itself.

Ukraine's national income dips by 20 pc

KIEV. Apr 18: Ukraine's national income in the first quarter of 1992 was a fifth lower than in the same period of last year and industrial production was down 15.3 per cent, official figures published on Friday showed, reports Reuter.

National income is roughly equivalent to Gross national Product, the total value of goods and services produced.

Data in the government newspaper Uryadovy Kurier painted a picture of an economy grappling with deep recession as it attempts the transition from communism to the free market.

The paper said that wholesale prices for industrial goods had shot up by 16.5 per cent since the first quarter of 1991 — largely because of the decision to free prices from state control from January 2.

Production of consumer goods had fallen by 21.5 per cent during the past year. Food output was down 34 per cent, and production of non-food items down 12.5 per cent.

Light industrial production had been severely hit by the interruption of raw material supplies from outside Ukraine as the centralised Soviet trade

Russia had delivered only 14.7 per cent of the timber contracted for the first quarter of 1992, and just more than a third of the petrol, the newspaper said.

Tokyo Declaration calls to set up environmental aid for LDCs

TOKYO, Apr 18: A UN Conference on Environment and Development (UNCED) meeting attended by 29 world figures ended here Friday with a call for the industrial countries to step up environmental aid for the Third World, reports AFP.

In a declaration dubbed the Tokyo Declaration on financial global environment and development, the meeting called for the industrial countries to share the estimated 125 billion dollar needed a year to help environmental protection in developing countries.

This sum was "modest in relation to worldwide military expenditures of some one trillion dollars per year", the five-page declaration said, adding such support should be viewed as "essential investment in global environment security."

It said industrial countries should strive to increase their official assistance to account for 0.7 per cent of Gross National Product (GNP).

The statement adopted by the 29 current and former world leaders, including former Japanese Prime Minister Noboru Takeshita, former U.S President Jimmy Carter, former French Premier Raymodn Barre and former Singaporean premier Lee Kuan Yew, will be sent to the "Earth Summit" set for Rio De Janeiro in June."

The three-day meeting was organized by UNCED to discuss how to raise and share costs for environment protection.

The report said rich countries should further open their markets so that poor countries could generate their share of the costs. Industrial nations should also increase private investment and make technology transfers to developing countries while cooperating in solving their accumulated debt

The paper said "new and additional financial resources" would support change for sustainable development with smaller damage to environment and urged "re-orientation of fiscal and taxation policies" to help generate additional resources or to change economic patterns.

"Countries may also wish to consider special taxes and charges in the context of the global partnership being forged at Rio, keeping in mind the impact on international competitiveness," it said,

The declaration made special reference to Japan, saying it held "a remarkable record in combining substantial improvements in its domestic environment with unprecedented levels of economic growth."

This provides the basis for Japanese leadership in global environment and development cooperation commensurate with its growth weight in the world economy," it said.

The declaration also called on industrial countries to shift to 'non-destructive production and consumption patterns,' while urging developing countries to study new strategies to hasten development and deal effectively with environmental concerns.

Also attending the meeting were two former presidents of the World Bank, Barber Conable and Robert McNamara.

TOKYO, Apr 18: Arranging additional aid for non-Russian former Soviet republics is pointless because confusion within the CIS means the initial package has not yet been distributed, a senior Japanese government official said, reports Reuter.

"It seems pointless to agree on additional financial commitment when Japan's previous aid package has yet to be fully disbursed," he said on Friday, declining to be named.

On Wednesday, international Monetary Fund (IMF) Managing Director Michael Camdessus said ex-Soviet republics, other than Russia would need about 20 billion dollar to overhaul their economies.

This is on top of a 24 billion dollar international aid programme for Russia outlined by the United States and Germany on April 1.

"The failure to implement the aid agreed previously is mostly due to lack of a solid structure in the former Soviet Union to receive such aid," the official saio.

in Japan, budgetary strains, caused by falling land and stock prices and sharp declines in tax income, were making policymakers cautious

Russia's seed bank in danger

WASHINGTON, Apr 18:
Just 50 years ago last winter
Dmitry S Ivanov died of starvation at his post during the
siege of Leningrad in World
War II. After his death, workmen found several thousand
packs of rice that he had preserved for one of the world's
biggest seed banks, reports AP.

More than half a dozen others also succumbed. They all refused to eat from any of their collections of rice, peas, corn and wheat. Now their seed bank is in

Now their seed bank is in another kind of crisis, stemming from Russia's shortage of funds for science as it makes the hard transition from Communist rule.

Next month a team sponsored in part by the World

sored in part by the World Bank in Washington will visit St Petersburg — Leningrad's old and new name — to see what help it can give. The bank is working with the United Nations on a 1.5 billion dollar fund to preserve plant and animal species, among other environmental goals.

The story is told in the current issue of "Diversity," a quarterly published in Washington by Genetic Resources Communications Systems, Inc.

The Vavilov Institute of Plant Industry is still one of the world's major sources of genes that researchers use to create better and higher yielding crops.

It was founded in 1890,

long before the Communists
