The Parishad President filed a case in the court of Chief Metropolitan Magistrate accusing seven people, including three Awami League leaders, for their involvement with the killing on January 2, 1975.

The accused are - Mahbubuddin Ahmed, the then Police Super of Dhaka, Abdur Razzaque MP, Tofael Ahmed MP. Mohammad Nasim MP, EA Chowdhury, former IG (Police) and currently the Chairman of Pubali Bank, Sarwar Hossain Mollah, Director of now-defunct Rakkhibahini and currently holding a post of Director in Foreign Ministry and Col (retd) Nuruzzaman Director General of Rakkhibahini and now Ambassador to Sweden.

Replying to a question why they filed the case after long 17 years when anti-Golam Azam campaign was on the peak, the Parishad President said that "We have been waiting for a democratic situation."

"We want trial of Golam Azam but not in the 'so called' Gana Adalat backed by some killers of Straj Sikder," Ahmed said adding that "We want Azam's trial under country's existing laws or by a revolutionary government."

In a joint statement, 54 ulema also urged the pious Muslims not to get their sacrificial animals abnegated by any believer in "Moududism".

Signatories to the statement included Hazrat Shah Sufi Moulana Syed Abdullah Al Chisti, Moulana Yahya Mah mud, Moulana Ruhul Amin Khan and Moulana Mohammad Suffan. "The followers of Jamaat-e-

Islami have already deviated from Islam by misinterpreting the Quran and criticising the prophet and his close associates (sahabas)," they claimed. Jamaat-e-Islami, they al-

leged, is using Islam for their party and personal interest by "bluffing pious Muslims". They are also spoiling the sanctity of different mosques by using those for party purposes. The ulema also urged God

fearing Muslims to keep mosques above all controver sies and party politics. "Build protest against those

imams who will try to campaign politics in mosques," they rugged all.
