Opposition may come back in House today

Police open fire on transport strikers in Khulna: 1 killed

One person was killed in Khulna and at least 15 passengers were injured in the capital as the indefinite transport strike passed its seventh day on Sunday.

A rikshaw-puller was killed when police opened fire on a group of agitating transport workers stoning a caravan of tank lorries at Manik Tala, eight kilometres from the town at around 1-30 pm. The lorry convoy was approaching Khulna town to supply fuel to the petrol pumps.

The passengers were injured in the capital as the striking workers and their hired 'mastans' hurled several bombs at passenger buses at Agargaon, Banani, Mohammadpur, Gulshan and Mahakhali.

Meanwhile, police raided the Mahakhali Bus Terminal and arrested three members of a bomb-making gang with 20 litres of acid.

BUDGETARY RELIEF NEEDED TO SAVE THE EXPORT INDUSTRIES

In an emergent meeting, the representatives of the following Exporter's Associations of Bangladesh, on detailed deleberations on the proposed budget of 1992-93 demanded withdrawal of the following provisions of the budget, detremental to the country's exports:

Deduction of 1% income tax at source on export value.

Mandatory Pre-Shipment Inspection as proposed in the budget for raw material imports of export oriented industries. Reduction of income tax rebate to 50% on export earnings as against 100%

provisions provided for in the existing industrial and Export Policy which have already been approved by the government and widely circulated nationally and internationally.

The meeting further held that while the exporters of the neighbouring competing countries like India enjoy 100% tax rebate, in addition to a number of other incentives, the proposed budget of Bangladesh has taken back all incentives and imposed new burden of taxes making the country's exports incompetitive in the world market.

The meeting further demanded inclusion of the following provisions in the budget for : enhancement of the export earnings of the country:

Full implementation of the incentives provided for Export Oriented and Export linkage industries in CHAPTER XI OF THE INDUSTRIAL POLICY OF 1991 AND IN CHAPTER IV OF THE EXPORT POLICY OF 1991-93.

Non fulfilment of the above demands will extinct the Export led growth of the country and thus losing employment and much needed foreign exchange.
