At this stage, Nurul Islam Moni, who took the floor for the first time after joining the Treasury Bench, drew the attention of the Speaker to the fact that under Rule 144 once a resolution was moved voting on it was mandatory. The Joint Declaration promised to repeal all the black laws of the state made by different ruling parties in the

Terming the ordinance worse than the Special Powers Act. Nasim said the Awami League had to pay dearly for making the Special Powers Act and the ruling BNP would embrace the same fate for its attempt to get the anti-terrorism ordinance passed.

He also said, "Not necessarily the incumbent Prime Minister or the Home Minister himself will abuse the proposed law, but the corrupt law enforcing agencies of the country would take advantage of this anti-people law by using

The proposed law has clearly ignored the civil courts, snatched people's constitutional right to defend them against any charge and interfered with the Supreme Court's jurisdiction to grant bails to the accused, Suranift

Such a law would definitely create a judiciary parallel to the existing one and thus virtually push the nation into a total chaos, Suranjit argued.

The Gonotantri Party leader urged the Prime Minister present in the House to withdraw the ordinance for the sake of the greater interest of the nation.

Ebadur Rahaman of Jatiya Party (JP) termed the ordinance as the blackest of black laws and remarks that people of the country did not expect such a law coming from a democratically elected government. Another JP leader Munirul Hoque Chowdhury commented that it was 'a martial law of an elected govern ment' and appealed the Treasury bench to withdraw the bill without any hesitation.

Shah Mohammad Ruhul Kuddus of the Jamaat-e-Islami said "Sheikh Hasina because victim of the Special Powers Act made by Sheikh Mujibur Rahman, Khaleda Zia was arrested under the same law as Ziaur Rahman failed to repeal it and Ershad faced the consequence of his own failure in repealing the black law by being arrested under its provi-

sion". The Jamaat MP went on to say that it would not be surprising if the ruling party, so eager to get the bill passed fell victim to the law even in the remaining days of the party's tenure to govern the

country. The Jamaat leader hoped that good sense would prevail and the Treasury bench would withdraw the ordinance.

Jamaat-e-Islami Parliamentary Party leader Maulana Matiur Rahman Nizami said that promulgation of the ordinance had created a 'bad precedent'.

At least 15 bodies lay in and around the parliament Monday, one day after rebels withdrew, witnesses said. About 150 rebels surrendered their arms and left the parliament, according to ITAR-Tass and officials at the Tajik Embassy in Moscow, according

US Ambassador Stanley Escudero and his staff were evacuated Sunday by a US military C-141 plane. The State Department said the US diplomats - who took American, British and Swedish civilians with them - left because of heavy gunfire near the hotel that houses the embassy.

The mountain-ringed capital was calmer Monday, but Tajik radio warned that small groups of rebcls still roamed the city. It appeared deserted, with no public transport and no gasoline available.

Violence in Tajikistan, a poor Central Asian country of 5.1 million people, has claimed hundreds of lives in recent months in tribal and land disputes that re-emerged after the collapse of the Soviet Union last year. The rebels who seized the

government buildings Saturday are from the southern Kulyab region, Nabiyev's power base. They have demanded that parliament be convened to discuss whether his ouster in September was legal.
