

North South University (NSU)

The First Private Nonprofit Degree Awarding University in Bangladesh Announces Commencement of the

Academic Sessions from January 1993

BACKGROUND:

The proposal for setting up North South University. the first degree awarding non-profit private university in Bangladesh was sponsored in the latter part of 1988 by the Foundation for Promotion of Education and Research, a non-profit charitable Foundation consisting of academics, business leaders and retired civil servants.

GOVERNMENT PERMISSION:

The Government of Bangladesh headed by Prime Minister Begum Khaleda Zia took the historic decision in March, 1992 to allow private universities to operate in Bangladesh. The Private University Bill was subsequently passed by the parliament on August 5, 1992. The post of the President of NSU was approved by a special order of the Government in September 1992. NSU has already applied to the Government for approval of its Charter.

MISSION:

The main mission of the North South University (NSU) is to impart quality education through teaching, training, research and public service to help individuals increase their intellectual, social and academic potentials. The University will endeavour to develop our country's human resources — the best capital for socio-economic development. NSU will seek to distance higher education from urban politics and attempt to reverse the deleterious brain drain that currently afflicts Bangladesh. While, being fully aware that these problems require a national solution, NSU is confident that it can act as a catalyst towards finding solutions to these problems. Facilities are being designed to foster an environment where motivated students will pursue learning with the help of talented foreign faculty and particularly Bangladeshi faculty now working abroad.

To achieve these objectives, NSU has designed an educational system that is largely based on the American model yet is sensitive to the evolving socioeconomic needs of Bangladesh and aims to fosters excellence in teaching, research and service. NSU is committed to infusing a healthy competition and renewed faith in the arena of higher education. We are dedicated to providing quality teaching in all of our academic programs to meet the growing needs of a rapidly developing Bangladesh in the last decade of 20th century and in the 21st century.

CAMPUS:

The sixth and seventh floor (about 15,000 square feet) of Abedin Tower, Kamal Ataturk Avenue, Banani, Dhaka will presently serve as the campus site. Three more floors will be added next year. SCOPE OF THE UNIVERSITY:

NSU is the first degree awarding Private University in Bangladesh and eventually will provide degrees in all branches of Arts and Sciences. NSU will have major areas of study under three Schools: (1) School of Arts and Social Sciences, (2) School of Business Administration and (3) School of Applied Sciences. However, initially four-year Bachelor's degrees in three areas - (1) Economics and Public Policy, (2) Business (with concentration in Finance and Banking, Marketing, Management, Accounting, International Business) and (3) Computer Science are being offered from January, 1993. In addition, a Master's program in Economics is also being offered simultaneously. Gradually in the future, the University will expand to encompass more disciplines, keeping in view the growing needs of scientific, technological, industrial, agricultural and social development of Bangladesh.

ACADEMIC STANDARDS:

North South University is committed to maintaining high academic standards. Producing graduates who are academically sophisticated and trained to work in leadership positions in the public and the private sector in contemporary Bangladesh in our top priority. Our graduates must excel in order to compete well for the scarce jobs available. An important way we intend to produce such graduates is (a) to give them a well rounded education, instead of the very specialized education graduates receive in Public Universities, (b) to maintain a close relationship between faculty and students through regular advising and close monitoring of student performance in a semester system format. Up-to-date student records with performance in class will be maintained on computer and these will be reviewed by the faculty. Arrangements will also be made to review students records.

ACADEMIC CALENDAR:

The first semester starting from early January 1993 will continue up to the end of April. After a short break, the second semester will commence from early May and end in August. The program for the September-December semester will be announced

later. The students will have to attend at least two academic sessions each academic year. The students will have the option to continue their studies into the third semester or alternatively they may use the time in doing part time jobs with the businesses to gather experience. NSU Students Career Planning and Placement Department will extend all possible help. In the 1993 academic year, NSU has the capacity to enroll a total of 320 students with the following breakdown:

Undergraduate (four year degree) courses

- Economics and Public Policy (BA) 40 students
- Business (BBA) 200 students
- Computer Science (B Sc) 40 students

Graduate Courses

Economic and Public Policy (MA) 40 students

The NSU Admissions Committee will conduct the admissions test and make decisions on admissions keeping in view students overall performance and suitability. The decisions of the NSU Admissions Committee shall be final.

COLLABORATION WITH FOREIGN **UNIVERSITIES:**

To ensure high academic standards, NSU is in the process of negotiating agreements of collaboration with a number of US Universities. The Universities include George Washington University, the University of Illinois (Urbana-Champaign), and Kansas State University. These agreements, once concluded, will have provision for regular consultation on academic programs and academic standards and transfer of credits earned by the students at NSU. The admission test will be held on November 20, 1992 at Titumir College, from 10 am to 12 noon. The applicants must bring their Admission Test Pass (which will be provided at the bank when they deposit their application package). The test will consist of objective multiple choice and some essay questions.

FINANCIAL ASSISTANCE:

Subject to availability of funds, NSU will grant appropriate financial assistance to help talented but financially disadvantaged students. The number of students enjoying such financial assistance shall be initially limited to 5-10% of the total number of students enrolled in NSU. A limited number of merit scholarships to attract top students may also be given.

PLACEMENT SERVICE:

During long holidays the University will make efforts to find summer jobs for deserving students in industries, banks, businesses, educational institutions etc. This will enable them to earn some money as well as gain work experience. The University will have a Students Career Planning & Placement Department which will coordinate and organize interviews for the job seeking students with Industries and Business
