Import policy to be liberalised

Country's import policy transacted through banks. At awaits a radical change with relaxation of restrictions on the trade in line with the current economic reforms, reports UNB.

In a sweeping move to ease procedural tangles facing the import trade, the authorities are learnt to have decided to abolish the provision of pass books for industrial importers who now get some preferential treatment in import of raw materials.

Official sources said pass book would be retained only in case of import of the items on the control list.

As per liberalised import rules, any Bangladeshi expatriate can import permissible port LC. items on direct payment abroad, without permission from the authorities at home. Price limit in such imports will also go. Decision has also been

taken to relax the mandatory use of Bangladeshi flag vessels in import. Export-oriented industries will now be free to choose the transport. Sources said the proposed
