ISLAMABAD, Jan 4: Pakistan said today it would deport all its illegal immigrants a move that could affect many Arab Muslims who fought for the Mujahideen guerillas in the Afghan civil war, reports

Minister of State for Foreign Affairs Mohammad Stddique Khan Kanju told parliament the decision to deport all illegal immigrants was made at a high-level government meeting in Islamabad on Sunday.

No official estimate of the number of illegal immigrants was immediately available, but the daily newspaper The News put the figure at 1.5 million.

Kanju said several methods of dealing with illegal immigrants were adopted at the meeting, but he did not give details.

"The law of the land should be respected and all those foreigners who have been illegally staying in Pakistan should go back," Kanju said.

Only three out of total ten prequalified contractors of Contract No Three and Four of the Jamuna Multipurpose Bridge (JMB) project submitted their bid till Monday, the last day of dropping tender.

These are Samwhan of Korea, China Harbour of China, and STFA of Turkey.

Concerned sources said Samwhan's bid was found to be the nearest to the estimated cost of the contracts.

The estimated cost of the two contracts is 52 million US dollars. The contracts are for east and west approach roads of the bridge.

JMB project has four components namely the bridge, the river training works and the two approach roads.

The tenders for the works were floated on September, 1, 1992. A total of 22 contractors prequalified for the job.

The JMB project would involve about 528 million US dollars. The work of the project would be awarded by the middle of this year and the final work would begin in January, 1994 and end in

NEW DELHI, Jan 4: India condemned today the expulsion by Israel of 415 Palestinians from the occupied territories, describing the action as "excessive and unacceptable," reports APP.

"These protesters, joining from different parts of the country subsequently moved in a procession and forced their way towards Indo-Bangladesh border, breaking three barricades raised by the law enforcing agencies. They also defied the urging of the local administration and political leaders not to move further ahead.

"As the crowd crossed the 3rd barricade at a place near Laozani Check Post under Jhikargachha Police Station, they faced obstruction from the police on duty. A splinter group from among the processionists at a stage turned violent, attacked the police with 'Ramda' and threw cocktails towards them, severely injuring 50 police men including the officers of Sarsha and Jhikargachha police stations.

"The police then resorted to lathi charge and used teargas to disperse the unruly crowd. Later on the police had to open fire in self defence. Two persons died and some others were injured during the encounters. The long marchers then retreated towards Jessore. Situation is now under control.

"Government has ordered an immediate enquiry into the incident to be held by Divisional Commissioner, Khulna, and urged the people to exercise restraint and maintain peace and order."

NEW DELHI, Jan 4: India will carry out the third test launch of its intermediate range ballistic missile 'Agni' (fire) in March this year. The sources said that the third test flight would experiment with 1,000 kilogram payload over a 'longer distance' which they refused to reveal, reports Xinhua.

SOFIA, Jan 4: Heavy snow on three successive days has cut communications, paralyzed traffic and disrupted life in many areas of Bulgaria. The capital, Sofia, and surrounding areas are buried under snow half a meter deep. In the mount Balkan, Rila and Rodopi areas it is a meter deep, reports Xinhua.

> Smuggled aid to deportees dropped

MARJ EZ-ZOUHOUR, (Lebanon), Jan 4: Smuggled aid to more than 400 Palestinian deportees has dropped sharply since Israeli shelling near their camp but food supplies could last a week, the men said today. The deportees claimed that Israeli mortar shells on Saturday targeted a nighttime convoy of mules carrying clandestine supplies to the 415 Palestinians stranded in an icy no-man's land between Lebanese and Israeli lines, reports AFP.

Drug smuggling case

Chief Security Officer of ZIA cross-examined

Five accused persons, four of them foreign nationals, in the sensational drug-case were put on trial in the court of the Second Additional Sessions Judge, Dhaka, Monday.

Out of 33 witnesses, plaintiff of the case, Captain Ekramullah (Retd), Chief Security Officer of the Zia International Airport (ZIA), Dhaka, was cross-examined before the Judge Mohammad Ansaruddin Sikder on the day.

A teenaged American girl Eliadah McCord, was held with 3.27 kg heroin at the anti-hijacking checkpoint at the ZIA before she was due to fly for Zurich, Switzerland on February 25 last year.

Later following a police in vestigation four other persons, Robert Blankson a South African, Ochendu Goddy and Okey Godwin two Nigerians and Abdul Qayum a Bangladeshi were found involved in the heroin trafficking.

Three foreigners who were produced before the court yesterday were earlier arrested and detained in the Dhaka Central Jail while two others Godwin and Qayum are ab-

sconding. While giving deposition, Ekramullah told the court that he lodged the case with Cantonment police on February 26 in connection with haul of 3.27 kg of heroin.

During Ekramullah's crossexamination by the defence lawyer Kazi Abdul Wahab, he said that he was at home during the incident. He was informed about the incident by a security official over telephone and rushed to the airport, he Kazi Abdul Wahab was as-

sisted by Advocate Abdul Maleg Munshi during the crossexamination.

Ekramullah also said that he heard that the accused American girl was searched on suspicion by an airport security superviser, Nighat Sultana, in presence of Mrs Elen, a traffic officer of British Airways and four packets of heroin were found hidden under her attire.

Hafizul Kabir, a customs official of the ZIA tested the scized item and confirmed that it was heroin, said Ekramullah.

Public Prosecutor (PP) Abdur Razzaq and Assistant Public Prosecutor (APP) M Naycemuddin moved the case on behalf of the prosecution while Advocate Khorshed Alam appeared on behalf of absconding co-accused Qayum and

Godwin as state defence. Advocate SK Chawdhury, lawyer for two other foreigners

was absent during the trial. When Blankson and Goddy were asked in the court if they. had something to ask the witness, Ekramullah, both of them replied that the witness was not known to them and they had nothing to ask.

The Judge Mohammad Ansaruddin Sikder adjourned the court until January 16 after one and a half hours examination and cross-examination that ended at 3:25 pm yester-
