Myanmar junta adjourns convention abruptly

YANGON, Jan 11: A massive national convention of some 700 Myanmar men called by the ruling junta to frame a new constitution was adjourned abruptly here today, only two days after it was opened, reports AFP.

There was no immediate confirmation as to whether the adjournment was planned or unplanned, but the fact the move was called 'a clarification' suggested it was unplanned.

Conference Convenor Major-General Myo Nyunt told the 699 delegates they would reassemble in Yangon on

February 1. The break, starting Tuesday, was to allow delegates "sufficient time for appropriate study" and because the SLORC, as the ruling junta is officially known, felt delegates representing 10 political parties "may need time to consult," he said.

Myo Nyunt said all members would be provided with transport to their home region.

The SLORC, the State Law and Order Restoration Council opened the conference, Saturday with massive internal publicity. But the meet was

boycotted by the European Community, which saw it as an attempt to legitimise the mili-

tary's grip on power. No timetable was given, but Myanmar government sources said at the time that they expected the conference to last from a month to six weeks.

Myo Nyunt's announcement of the 20-day adjournment was greeted in the convention hall with a buzz of surprise from the delegates, and observers said it appeared they had not been forewarned.

Lower level officials and foreign diplomats present at the hour-long session Monday said the abrupt adjournment appeared to show that SLORC was, in the words of one Asian Diplomat, "in no hurry".

Before the announcement, Chief Justice Aung Toe told the delegates -- who came from all regions of the country as well as the 10 political parties -- that there was no time

"I would like to remind you that no time limit has been set, so that panel discussions may be carried out by the distinguished delegates to their hearts content," Aung Toe said.

Japan to rely on US military umbrella: Miyazawa

BANGKOK, Jan 11: Japan, which has shunned military forces since its defeat in World War II and is constitutionally bound to avoid aggression, will not rearm and become a regional policeman, Prime Mi nister Kiichi Miyazawa said recently, reports AFP.

Instead, Japan will continue to rely on the US military umbrella for its defence even though Washington is reducing its forces worldwide following the disintegration of Soviet armed might and the end of the Cold War, Miyazawa said.

He made the statements in Tokyo in an interview with Bangkok Post Editor Paisal Sricharatchanya. The Post reported the interview on Monday.

Paisal asked Miyazawa if Japan would expand its re-

gional military role il President-elect Bill Clinton reduces US strength even further. Under outgoing President George Bush, Washing ton has given up its bases in the Philippines and is pursuing a 10 per cent across-the-board cut in its forces stationed in

Japan "will not walk the path of a military power". Miyazawa replied. He said the role now played by the US military is irreplacable and is unlikely to change in the foreseeable future.

The United States has some 50,000 military personnel and some of its latest hardware stationed at dozens of bases in Japan, which is close to the tense Korean peninsula, Russia and strategic trade routes.

An identical explanation

came from the Indian External Affairs Ministry Saturday after talking the Bangladesh officials the previous night that Rao would not be able to attend due to a volatile internal political scenario caused by

"communal disturbances" However, the explanation did not satisfy their Indian counterparts.

"Well, this explanation was given by senior Bangladesh officials ... we accept it but there is a normal courtesy that a minister or the special envoy of the Indian Prime Minister should receive".

On the meeting between the two ministers, Bangladesh Foreign Ministry officials said that they discussed matters related to the SAARC. They did

not give details. The Indian official said that Bhatia explained to Foreign Minister Rahman the situation that prompted Rao to cancel his trip to Dhaka for the second time.

This reversal of earlier postures has not been well received by the diplomatic and political circles in Bangladesh.

The Indian External Affairs Ministry statement also refused to acknowledge that the postponement of the originally scheduled summit was also made at the request of India, in the wake of bloody communal riots across the country after the demolition of a centuries-old mosque by Hindu militants.

Termination of Quereshi: Rule issued on **BDRCS** Chairman

A High Court Division bench of the Supreme Court has issued rule on the Bangladesh Red Crescent Society and its Chairman to show cause why the termination of its Secretary General Major (Rtd) All Hassan Quereshi not be declared to have no legal effect, reports UNB.

Justice Anwarul Haque Chowdhury and Justice K M Hasan gave the ruling on Sunday upon a petition of Quereshi challenging the letter of termination issued on December 31.

The petitioner alleged that the Managing Board of the society suddenly terminated him with effect from January 1 1993 without assigning any reason although he, appointed on regular basis, had been discharging his duties to the satisfaction of all concerned since the appointment on March 19,

The court also directed the respondents to allow the plaintiff to continue to live in his official accommodation.

The rule has been made returnable within six weeks and stay order granted for three months.

5 feared killed as boat capsizes in Isamati

SATKHIRA, Jan 11: At least 5 people were feared dead after a boat, loaded with smuggled goods, capsized in the Isamati river near bordering area of Basantapur in Kaliganj Sunday night, reports

A military spokesman here said six soldiers were killed and three more wounded in Sunday's firefight at Ampara where he claimed killing at least 12 guerillas of the Liberation Tigers of Tamil Eelam (LTTE).

"We recovered eight of the terrorist bodies and our technical sources confirm that four more were killed. We have recovered four automatic rifles and about 10 magazines," the spokesman said.

The attack was the worst against security forces in the new year. The military has lost four soldiers in two other at-

ICIMOD to provide \$ 2.46 lakh for CHT development

The international Centre for Integrated Mountain Development (ICIMOD) will provide Bangladesh 2,46,600 US dollars for financing four socioeconomic development programmes in the Chittagong Hill Tracts region, reports BSS.

Four separate memorandums of understanding were signed here yesterday between Bangladesh and the ICIMOD.

Of the amount, 2,01,600 US dollars would be spent for Mountain Environment and Natural Resources Information System (MENRIS), 10,000 US dollars for Sloping Agricultural Land 'Technology (SALT), 18,000 US dollars for holding a national workshop to frame a future guideline for the development of the Hill Tracts region and 9,000 US dollars for strengthening farming infrastructures.

The memorandum of un derstandings were signed by Dr. Tej Protap on behalf of the ICIMOD. On behalf of Bangladesh government, three of the memorandums were signed by the Director General of the Special Affairs Division, H M Nuruddin while the other one by Zafar Karim.

The ICIMOD was formed in 1983 at Kathmandu with eight countries - Bangladesh, India, Myanmar, Nepal, Bhutan, Chi na, Pakistan and Afghanistan.
