the Election Commissioner, came after the Awami League hotly disputed the results announced by the Returning

Officer. Though the Awami League welcomed the recounting as a victory, its candidate's chief polling agent K M Jahangir MP filed another petition with the Election Commission urging repolling in the constituency.

In his petition, filed just before the recounting of the ballots, Jahangir urged the Chief Election Commissioner to order a fresh poll "rejecting and ignoring the ballots manipulated from the control room set up at Mirpur."

In a joint hearing of the petition the Chief Election Commissioner and the Election Commissioner rejected the plea. They said "the Returning Officer on behalf of the Election Commission under Article 42 of People's Representation Order 1972 retained the sealed bags containing the sealed packets of the election materials in the double lock of the Dhaka Treasury. The Secretary of the Commission visited the Treasury and found these materials under proper custody and full care.

"The petition is disposed of accordingly," they said in their verdict.

In his reaction K M Jahangir told waiting reporters "the Election Commission is an independent body and it has given its independent opinion. We have nothing to say about

But he said "if there is any legal scope we will consider."

In his 11-page hand-written petition Jahangir alleged that local people (of Mirpur) have recovered ballot papers from a heap of ash only yesterday which indicated that ballot papers showing the casting in favour of the Awami League nominee had been taken out of the box and it is learnt that ballot papers were sealed in favour of BNP nominee and stuffed in the ballot box with the conspiracies of the presiding officer with connivance of the Returning Officer.

In contrast to previous violence the recounting went off smoothly barring occasional exchange of arguments by the representatives of the BNP and the Awami League.

A strict Chief Election Commissioner presided over the recounting of the ballots as officials were pouring them onto seven tables manned by election officials and representatives of the candidates.

Justice Chowdhury who sat almost throughout the recounting process made it clear at the beginning that no disorder would be allowed.

"If any one has anything to say about the counting please submit it in writing. By the grace of Allah we want to complete this process in a disciplined manner," Justice Chowdhury said as the Returning Officer ordered the ballots to be placed on the tables around 11:03 am.

Justice Chowdhury said. The ballots were inside seven sealed jute bags. Each bag contained 18 packets of enveloped and sealed packets for 18 candidates, a result sheet signed by the presiding officer and another sealed envelop for cancelled votes.

Earlier, when the ballot bags were brought to the counting room the Chief Election Commissioner personally checked them.

The ballots for the two main contenders (of BNP and the Awami League candidates) were pushed aside to make way for the counting of the votes received by 16 other candidates It took little to finish re-

counting the ballots of the 16 candidates that also included the contestant from the Jatiya Then began the recounting

of BNP and AL ballots. Each envelope took an average of 20 minutes to recount.

However, the start of the recounting was briefly delayed as Tofael Ahmed, the Awami League spokesman, wanted to know about the procedure Works Minister Barrister Rafiqul Islam Miah protecting the BNP interests was not happy.

Like they do during parliamentary debate the Works Minister said there was no scope given to the BNP candidate to register his complaints with the Election Commission as the Awami League did. The Chief Election Commissioner quickly took control of the situation and made the two leaders quiet He said every candidate had enough time to lodge complaints with the Election

Commission. But then entered K M Jahangir, MP, the chief polling agent of the Awami League candidate Kamal Ahmed

As he tried to make a point Salahuddin Ahmed MP, the BNP candidate's chief polling agent, objected. This dust also settled down quickly with both parties saying they have complete faith in the Election Commission.

At this stage to make things smoother the Chief Election Commissioner asked the BNP and the AL to nominate their spokesmen so that too many voices did not disrupt the re-

counting process. Thus Information Minister Nazmul Huda became the BNP candidate's spokesman and Tofael Ahmed MP, the Awami League candidate's.

During the recounting the Chief Election Commissioner aided by Election Commissioner Justice Meshbauddin Ahmed summarily disposed of more than 100 objections from both parties.

A major objection was to the ballots where voters put the stamps twice. A total of 16 such ballots, eight each for the BNP and the AL candidates. were found. The Chief Election Commissioner used magnifying glasses and torch-lights to examine the validity of these ballots. All of them were found valid as they did not cross the

But it took at least 45 min utes to decide the fate of these ballots.

The BNP leaders who were present at different stages of the recounting included Nazmul Huda, Barrister Rafigul Islam, Quamrul Islam MP. Lt Gen(retd) Mir Shawkat Ali Sarder Shakwat Hossain Baku MP. Salahuddin Ahmed MP and Amanullah Aman MP.

The Awami League side was represented also by Shamsul Huq, Matia Chowdhury, Abul Hasan Chowdhury, Mirza Azam, Shahjahan Khan and ASM Peroz. all Members of Parlia ment. The Awami League leader K S Nabi, lawyer for the party's candidate, was also

40 hurt as JCD, BCL resume feud in Sirajganj

SIRAJGANJ, Feb 15: Some 40 people were injured, seven seriously, as the student activists of ruling BNP and opposition Awami League resumed their feud here today, reports

Witnesses said Police fired 5 teargas shells to disperse the militants as the activists of Jattyatabadi Chhatra Dal and Chhatra League clashed with dao, iron rod, cocktail and handbomb on the Mujib and Victoria roads. The seven seriously injured were identified as Sukhen Kumar Das, Abu Masum Rana, Jahid and Rafigul of JCD and Aurun and Alauddin of BCL. They were admitted to Sirajganj General Hospital.

The clash erupted as a sequel to Sunday's fighting between the two groups that left at least 19 injured in Saydhangara area in the town.

To retaliate yesterday's alleged attack on them, JCD. workers reportedly swooped on the bastion of BCL on the Victoria Quarter road at 11 this morning.

Our Narayangani Correspon dent adds: Police fired rubber bullets, lobbed teargas shells and charged batons to disperse several thousand agitated workers of Adamjee Jute Mills near Shidhirganj power station, injuring more than 40 workers, six seriously, witnesses said.

The workers pelted stones and made their way towards the Kanchpur Bridge but were unsuccessful in their effort in the face of stiff police resistance, they said.

After more than one hour of clashes four bullet injured workers were rushed to Dhaka Medical Hospital and two others were admitted to Narayangani Sadar Hospital sources said.

Police alleged that the workers had hurled cocktails at them.

Near the Kanchpur Bridge several thousand workers from Latif Bawani and Ahmed Bawani Jute Mills barricaded the Dhaka-Chittagong highway and clashed with police who went to clear the road.

At least 30 people were infured in clashes before the workers left the place.

Communication became normal in these routes after several hours of disruption,

witnesses said. In Adamjee Jute Mills production was almost normal on the day despite the barricade programmes, official sources said. Leaders of the Adamjee Collective Bargning Agents (CBA) reportedly urged the workers to resume duties at around 10 am, mill sources

On the Dhaka-Aricha Highway, textile workers put barricades near Nayarhat but they were removed by police. The workers stoned and damaged a number of vehicles during the clashes and afterwards.

There was no agitation in Tongi area, a traditional stronghold of the textile workers, and road and rail com-

munications stayed normal Railway sources said that there were minor disruptions in the Dhaka-Chittagong, Kishoregani-Bhairab and Khulna-Jessore routes, but that

train services were normal Clashes were also reported from Khulna and Jessore where more than 50 people were injured

Later in the evening, lead ers of the Jute and Textile Workers Action Committee claimed at a press conference in the city that the programmes were completely ob-


served across the country. They accused the government of breaching a previous agreement with the workers and said that their agitation would continue until the de mands were met

They told reporters that police and BDR action on the workers at Kanchpur Siddhirgani, Kishoregani and Savar left at least 300 wounded, some with bullet Police also picked up a number of leaders and workers enforc ing the blockade, the leaders

Convenor of the Jute Workers Action Committee Abul Bashar, textile workers leader Igbal Majumder and other leaders including Lutfar Rahman, Shah Alam, Anwara Begum and Badrul Alam Khan were also present at the press conference.

Staff Correspondent from Chittagong adds: Rail and road communication from Chittagong with other parts of the country were snapped during the programme being observed by jute and textile mills workers and employees at Barabkundu point under Sitakundu thana on Dhaka-Chittagong highway

Witnesses and police said about 2000 workers and employees put up the barricade there demanding enhanced wages.

Referring to the Constitution of the high pow-"Local Government Review Commission," Begum Zia said as per the recommendations of the Commission the Union Parishad had been made the basic unit of the local structure in Bangladesh.

Union Parishad has been given the status of administrative unit, its term been raised from three to five years, she said adding steps are being taken to place 14 specific areas under union parishad jurisdiction for raising taxes. Necessary laws and rules would be framed soon, she added.

The conference was also addressed by LGRD and Cooperatives Minister Abdus Salam Talukder, Deputy Minister for LGRD and Cooperatives Abdul Hye, Secretary of Local Government Division Mushfigur Rahman, Joint Secretary of Local Government Division Nazmul Alam Siddiqui One Union Parishad Chairman from each division of the country also spoke on the occasion. They were Habibur Rahman of Melandaha under Jamalpur district from Dhaka Division, Nurul Alam of Jhalakati district from Barisal Division, Nazim Uddin Ahmed of Magura from Khulna Division and Abdul Momin Talukder of Char Ghat from Raishahi Division and Golam Kibria Chowdhury of Sandwip from Chittagong Division. Anil Tong Chonga Chairman of Chandrogona Union Parishad also

addressed the conference. The Prime Minister said her government had initiated a new wave of rural-based and people-oriented development programme and the responsibilities of Union Parishad Chairman have increased manifold as the entire development of the country depended on their effective role. Referring to the various programmes taken up by her government including poverty alleviation, mass education, compulsory primary education, expansion of female education, free female education upto class eight in rural areas, Begum Zia asked them to motivate girls in rural areas to make use of the new educational opportunities and bring all the children under compulsory primary education. In her motivation speech, the Prime Minister said the UP Chairman should set up examples by involving themselves in the task of ensuring pollution-free environment healthy living and use of pure drinking water, controlling population growth, and tree plantation programmes.

The Prime Minister underlined the need for encouraging the people to set up cottage industries, small dairy, poultry and pisciculture farms, adopt modern agricultural methods and pursue rapid income-generating and employment-oriented activities.

Begum Zia felicitated the newly-elected chairmen, who hold the leadership at the grass root level, and told them that the prolonged colonial subjugation was the main cause of our present extreme poverty and dependence.

She said every nation has its own development tradition and it can neither be imported or exported. The people are the driving force behind development, she said and stressed the need for effective coordination between people and the soil for uplift.

The Prime Minister rem ined the chairmen that Shaheed President Ziaur Rahman had perceived the idea of "Swanirvar Gram (selfreliant village)" and carried out various programmes for building representative and development-oriented leadership at the grass-root level.

About the problems of the Chairmen, the Prime Minister said these would be solved in phases. "Let us first solve the problems of the people one by one and then all other problems will be taken care of," she

Salam Talukder, in his speech, said the government would consider to fulfil the demands of the Chairmen of increasing their honorarium among other things.

The general cargo ship caught fire as the dock workers were engaged in unloading the cargo, port officials said.

Meanwhile, Chittagong Port Authority constituted a threemember enquiry committee to assess the incident and extent of damage. The committee has been ordered by the Authority to submit a report on the incident within the next ten days

The local agent of the vessel Progati Shipping Ltd sources said that MV Horn arrived Chittagong Port February 13 with 2516 metric tons of general cargo including chemicals from a South Korean port and was scheduled to sail tomor row for Calcutta port. But due to the fire incident its sailing will be delayed, sources said.

The 106-meter-long ship with DWT 6542 MT captained by a Korean national Choi Dae Jull has about 25 crew members on board, agent sources said adding that they were all safe. However it could not be known whether the victims dependents would be provided with any compensation.

very short time." He added that the World Bank would "seriously consider a 136 million dollar project for the power sector, if "further improvement" could be

He noted that the Bank also asked the government to reduce the system loss in the water supply networks in the

On private sector participation, the Finance Minister agreed that they should be allowed in the power, telecommunication and the energy

"We should seriously look into the four or five private sector proposals in the gas sector and also allow private sector participation in the telecommunication sector." He added that private sector participation in the power sector similar to those undertaken in neighbouring countries could also be considered.

Describing his visit as an excellent" one, the Finance Minister said: "The purpose of the visit was to review the progress of the ongoing World Bank funded projects and to set a stage for a fruitful and productive aid consortium meeting" in Paris in April.

The Finance Minister said that the World Bank is seeking optimum utilisation of aid with "more emphasis on effective implementation", rather than making big pledges.

This, he added, would most likely be reflected in the upcoming aid consortium meet ing. "Attention this year would be on aid disbursement rather than on pledges.

Saying that "sufficient" improvement would be made to create conditions for higher disbursement, Rahman added our disbursement level next year will be much higher than

He said that the Bank may disburse about 700 million US dollars during the next fiscal year (1993-94) and added that donors had given indications of a volume that can help the country in sizing its annual development budget to the tune of Taka 10,000 crore, in line with the government's projected growth rate of five per cent. Rahman noted that the World Bank had endorsed a Bangladesh proposal to reallocate Bank funds from least absorptive projects to priority

The Annual Development Plan for the current fiscal year stands at Taka 8,600 crore while the total aid disbursement including that from the World Bank is likely to reach

1,200 million dollars. Because of a bumper production this year, the Finance Minister said, the 'country would not seek food aid at the next Aid Club meeting.

World Bank, he added, that the country would not accept any conditionalities from the denors that did not conform to the development needs of Bangladesh. "We will only receive com-

modity assistance that con-

forms to our development

He made it clear to the

programmes in poverty reduction, employment generation and in the health and education sectors. As an example, he cited that during his visit he rejected the proposed Bank credit on agriculture sector on condition of withdrawing the government decision on waiv-

ing farm loan uptô Taka 5,000

The proposed amount credit was to the tune of 70 million dollars. On the jute sector restructuring programme, expected to be initiated from July next, Rahman said that the World Bank has accepted a government proposal and that a bank mission led by its country director was expected in the

capital soon to hold further

discussions. He said that the Bank had offered 150 million dollars for the programme, but he added, the government had asked

"for more" The Finance Minister said

that the jute mills would be provided with "interim support consistent with their financial viabilities and with the resources of the banks."

He cautioned that continued wage hikes would render the restructuring programme ineffective. Quoting World Bank Vice President Joseph Woods, as having written in a recent letter, Rahman said further wage increases would undermine the (jute sector) reform programme and the staggering losses in the sector would continue."

Overall, the Finance Minister noted that the World Bank identified Bangladesh as a success story" in the economic reform programmes undertaken by many countries around the world.

"But we are not getting the results because of the continued political unrest in the country." Referring to a series of re-

cent hartals, which he termed

as "most discouraging and a

disgrace", Rahman noted that the International Finance Corporation President Sir William Ryrie, who was visiting at the time, expressed "serious disenchantment" about the developments. "We seem to have a hartal, non-cooperation and boycott

phobia," he said, "hartal is economic suicide, it's blocking all the prospects of the country to moving towards development by deteriorating the climate." He added that if the "polit-

ical divisiveness" in the economic arena could be contained for at least three years "we could go a long way as fund is not a problem but it's the climate which deters our
