Move to disinvest 16 sugar mills underway

A move is underway to sell out the country's 16 sugar milis under Bangladesh Sugar and Food Industries Corporation (BSFIC) to the private sector as prescribed by the World Bank and the Asian Development Bank, reports

Official sources said that as part of the disinvestment prescription, the banks have suggested abolition of the corporation's cane development and expansion programme.

The state-owned mills are already threatened with closure due to liberalisation of sugar import. Some 57,000 tons of imported sugar are reportedly in the market and Letters of Credit have been opened for import of another two lakh tons.

The mills should be denationalised as the government has to bear the staggering losses incurred by them due to increase in production cost. the banks said

BSFIC had undertaken the cane development and re-

search programme to solve the problem of non-availability of adequate sugarcane for the mills. Production of sugarcane has doubled to 20 metric tons per acre last fiscal (1991-92) from 10 metric tons in 1972-

After the expansion programme was undertaken, some 257 lakh metric tons of sugarcane worth about Tk 3,600 crore was produced. But this aspect was completely ignored in the Morris report that suggested that the expansion programme be withdrawn and the mills denationalised, the sources said.

Patrick Morris, a foreign consultant was appointed by the government according to an agreement it signed with

Implementation of the report will lead to the closure of 16 public sector sugar mills, rendering 30,000 people jobless. Over five lakh farmers' families and thousands of farm labourers are directly dependent on the sugar industry.





Sharee traders want tough action against smugglers

By Staff Correspondent The Bangladesh Sharee Businessmen Association has urged the government to take immediate steps against smugglers to protect the country's powerloom sector.

Speaking at a press conference yesterday, the leaders of the association threatened to take to the streets if the authorities did not take measures against the smugglers in a week.

"If the government fails to halt smuggling, our movement will take political shape ... we will take to the streets ... we will wage movement against the government," said General Secretary M Kaikobad Bhuiya.

"Every year, during Eid smugglers become more active .. and this year it has gone beyond all proportions," they said calling for immediate gov-

ernment intervention. Dwelling upon various problems including the duty structure that affect the raw materials, the sharee producers alleged that "mysterious" inactivity of the concerned government departments and law enforcing agencies had made Bangladesh an "open market"

of smuggled Indian sharee. "If this goes on, about one crore people directly or indirectly involved with this sector

will bear the brunt," they said. They suggested enactment of tougher laws such as the anti-terrorism act to deal with the spate of smuggling, saying that the existing ones had proved ineffective.

"None has been punished, even though goods worth Tk 3.36 crore were recovered from shopping centres and different places in and around Dhaka since last July," Bhutya alleged.

High rates of duty on raw materials, they said, had led to high production cost, making local sharees, although better in quality, uncompetitive.

"If tax is withdrawn right now, we will be able to create two million new jobs in next two years," they claimed.

The sharee producers gave a list of major shopping centres across the country where smuggled Indian sharees are found in abundance. The list included several
