Dhaka's Street Children

By street children we mean the rootless, wretched children in the urban areas. They form a miserable part of the city's poor and take recourse to various means to carn a living for survival. Their multitudinous numbers include those working in markets, staying at juvenile detention centres, living at railway stations, bus terminals and launch ghats and doing various odd jobs. According to estimates of the World Health Organization (WHO), there are 100 million street children in the world, of whom 20 million live in devel oped countries, 40 million in Latin America, 25 to 30 million in Asia and nearly 10 million in Africa.

There are no dependable statistics as to the total number of street children in Dhaka city. But judged by their ubiquitous presence in all areas of the city, it seems that their total number may run into a few lakhs. And their number may be steadily swelling owing to economic reasons. The WHO has noted that in Bolivia they are called 'Moths', in Cameroon 'Chicks', in Vietnam 'Children of the Dust' and in Colombo 'Bed Bugs'. In Bangladesh they are known as 'Tokat'.

As everywhere, they have a precarious existence, always in search of food and shelter. They are particularly at risk for drug and sexual abuse. They do not seem to have the least of social security.

Though quite a large number of them are found to be begging, not all of them seem to be resourceless. Most of the latter take to one form of odd job or another to keep their body and soul together. Some of the jobs they are found engaged in include carrying small loads at city bazars where they are known as "mintis," shoe polishing at important road corners, vending a variety of wares, ranging from matchboxes to peanuts, and doing various chores in small shops,

Associated with the plight of the street children is the problem of child labour. Official statistics suggest that 25 per cent of families of Bangladesh are dominated by mothers who have no alternative means but to depend on whatever earnings their children manage. Thus many of the children at early age get involved in the struggle for-existence and some of them even minor crimes. It is inevitable that in this grim struggle for existence they get undernourished and become victims of various diseases. making the prospect of their turning into useful citizens a bleak one.

Rehabilitation of the street children is admittedly a gigantic task. It is understood that no survey of the street children was ever made. The government Department of Social Welfare has tried to address

the problem, though in a small way. It has established a rehabilitation home for distressed ehildren at Konabari under Gazipur district. Limited to a capacity for about 300 children, it had admitted a total of 754 children from 1984 to 1992, of whom 477 children had passed out with general. technical and vocational educa

Under the previous regime, a rehabilitation scheme for such children was initiated under the "Pathakali Trust". In this respect, according to observers, the large number of non-governmental organiza tions (NGOs) operating in the country may also make significant contribution. Along with their many projects on health, education, environment, selfemployment, etc., they may also take up projects for rehabilitation of street and underprivileged children.

The discouraging aspect of the problem is that though 'unfortunately concerted national effort to ameliorate the lot of the street children is lacking, the problem is compounded by the rising trend of population increase. In this perspective, it is the opinion of knowledgeable quarters that unless the population explosion is contained within a tolerable limit along with coordi nated efforts made for rehabili tation of street children, no meaningful progress can be expected in the future.

Indian army chief orders more troop deployments on Kashmir border

JAMMU (India), May 7: Indian Army Chief Sunith Rodrigues toured forward areas on the Kashmir border with Pakistan today and ordered additional troop deployments, a defence ministry spokesman said here, reports

Rodrigues ordered army reinforcements at all strategi cally important and vulnerable forward areas and higher mountain passes to prevent infiltration by Muslim militants following the thaw, the spokesman said.

India says Muslim militants are trained in the Pakistan held northern third of Kashmir. It accuses Pakistani troops of helping the militants infiltrate the Indian zone to continue a guerilla campaign for secession.

Wijetunga kept for himself the key ministries of defence and finance. He also took over the portfolios of higher eduction, Buddhist affairs and policy planning held by Prema-

Wijetunga described his philosophy of life quoting a Buddhist scripture: "I will do what I say and will not say anything I cannot do," and called for opposition support to "stamp out violence and other negative and evil forces."

He said the unanimous approval of his candidacy brought to mind a William Shakespeare quotation: " ... some have greatness thrust upon them." "I will endeavour to estab-

lish a new social order in which there will not be even a trace of arbitrariness and intolerance. I invite you to join hands with me in working for the achievement of these ideals," Wijetunga said. In his first address to the

nation today, Wijetunga said his administration was committed to continuing Premadasa's liberalisation policies but cautioned that he would not hesitate to implement changes where necessary.

"My approach will be pragmatic and not dogmatic. Where new direction is found to be in the national interest, necessary modifications or changes will be effected," Wijetunga

He said maintenance of

discipline, law and order, and respect for human rights will receive the "considered attention and support of my government." He said Shri Lanka looked

forward to support from the international community to strengthen democracy and maintain economic stability.

A solution must be found urgently, he said, to the 'unfortunate' conflict in the island's northeast where the Liberation Tigers of Tamil Eelam (LTTE) is battling for a separate state for minority Tamils.

"What we have is not a Tamil issue. But a terrorism problem. The LTTE is an illegal army on our soil and we will have to disarm them, Wijetunga told reporters carlier in the day.

Asked if Colombo would make a fresh move to initiate a dialogue with the LTTE, he said, "It is for them to come and talk. We have done everything possible."

Shri Lanka police had earlier blamed the LTTE for the slaying of Premadasa but Wijetunga said investigations were still continuing.

Wijetunga's election as Shri Lanka's third executive President was greeted by table thumping on both sides of parliament but the euphoria was somewhat drowned when a leftist firebrand demanded the government's resignation.

hardly ever used for the set tlement of industrial disputes."

Again Section 43 provides that "no industrial dispute shall be deemed to exist unless it has been raised in the prescribed manner by a collective bargaining agent or an employer."

However, the FIAS report points out, "The prescribed manner in which the parties must act to render a dispute an industrial dispute within the meaning of the IRO, in effeet, greatly reduces the scope of the provisions relating to control of industrial disputes."

Similar problems, it says, and anomalies exist with respect to conditions of association and registration of a trade union, conciliation of disputes and the effective operation of labour courts.

The labour courts, set up under provisions of the IRO, consist of a chairman appointed by the government, and two members to advise the chairman, one representing the employers and the other representing the employees. Whatever may be the theo-

retical merits of the membership system, the FIAS report notes, in practice it works to create abnormal delays as the absence of one of the members results in the day's scheduled cases being adjourned.

"Such absence of members is quite common, thus delays are built into the system over and above the usual delays which are common to litiga-

Noting that the membership system was abolished in Pakistan in 1973 and that labour courts in both Pakistan and India consist of only one person, the FIAS suggests that a similar approach can also be followed in Bangladesh.

The labour appellate tribunals, formed under the IRO, hear appeals from decisions of the labour courts. However, their jurisdiction is limited to hearing appeals from awards relating to industrial disputes and sentences passed while trying offences under the IRO. Since the single member tribunals consist of persons who are or have been High Court judges, the report suggests that they should be competent

to hear appeals from all decisions, awards or sentences of the labour courts.

"Only minor amendments would be required to Section 37 of the IRO and Section 25 of the Standing Orders Act to effect this change," it notes.

Rather than enact piecemeal adjustments to correct the anomalies, the FIAS report recommends formulation of a new comprehensive labour code which could provide an integrated framework for establishing the rights and duties of the both employers and employees and also provide speedy and effective access to justice for aggrieved persons.

"The code should incorporate all the necessary special provisions for the operation of the labour courts, as well as adequately specifying their jurisdiction."

The government last year formed a national labour law commission headed by Justice Abdul Quddus Choudhury. which also includes representatives of employees and employers, to review the existing labour laws and to recommend ways to bring about necessary changes.

The 35-member commission is expected to submit its report later this year. Four committees have been found under the commission relating to trade unions and industrial disputes, wages and terms and conditions for employment, labour administration and work environment.

The FIAS report suggests that consideration of the commission's recommendations and appropriate legislation should be introduced as early as possible.

Moreover, it adds "the recommendations should be reviewed to ensure that they adequately address the various issues and anomalies in law and practice identified above." A joint service of the International Finance Corporation (IFC), the Multilateral Investment Guarantee Agency (MIGA) and the World Bank FIAS completed and presented the report to the government in November last. The study was conducted at the request of the government to identify major constraints to invest ment in the country.

Non-racial polls in South Africa within 12 months

JOHANNESBURG, May 7: South Africa's first non-racial elections will take place within 12 months if the political transition proceeds smoothly, negotiators agreed at multiparty talks here today. All but two of the 26 groups from across the political spectrum participating in the talks signed a carefully-worded declaration of intents stating that an exact date for an election, to take place "not before the end of April 1994," should be set by negotiators within the next four weeks, reports AFP.
