Raushan's counsel refutes abetment charge

Sharfuddin Khan Mukul, defence counsel of Begum Raushan Ershad, yesterday stated before the Special Judge's Court that his client is not guilty of the charges brought against her, reports BSS.

"The prosecution has failed to prove beyond all shadow of doubt" that the former First Lady had abetted her husband former President H M Ershad and others in any illegal action or criminal activities, the counsel claimed in the court of the Second Additional Sessions Judge and Special Judge Ansaruddin Sikder yesterday.

Deposed president Ershad, his wife and 18 others are accused in this case involving the Janata Tower. The hearing began early last year.

After lengthy depositions by 35 witnesses, the arguments began on May 11. Yesterday was the fifth day of arguments which remained incomplete when the court rose for the day to meet today.

Counsel Mukul told the court that his client, by her own merit and activities, was a separate entity'. He said it would not be fair to make her responsible for alleged excesses done by Ershad just because she is his wife. Begum Raushan Ershad did enjoy certain privileges as the wife of the President, which was certainly no fault of hers, the counsel noted.

Counsel Mukul said not a single word was said by scores of prosecution witnesses in support of the prosecution's charge of abetment against his client. Instead, the counsel argued, the witnesses had established the JPL as a valid company which was duly registered with the Registrar of Joint Stock Companies, contrary to the prosecution's accusation that it (JPL) was a company having no legal basis.

The defence counsel said it has been proved in the court that the contract for construction of the Janata Tower was awarded to Nirman International Limited by JPL under an

The Janata Tower does not belong to any individual but to the JPL, the counsel said.

Mukul read out a Supreme Court observation in a quashment petition. "The abetment would be proved only after criminal activities of the principal accused were established," the SC had observed. He said criminal activities of the principal accused are yet to be established, so the question of his client's offence does not arise at this stage.

Mukul said his client entered the scene only after Plot 49, KCA was sold and a prayer for mutation made. He said neither the allotment of plots to Sukkur Pradhan and others nor the transfer of Plot 49, KCA were questioned by Rajuk. None said those acts were illegal, he added.

As, for the charge of abetment, Mukul said there was no valid proof to that end. He said no witness had made such remarks, nor was there any document to support the prosecution's contention. He said even the investigating officer, in his deposition before the court, did not bring an abetment charge against Begum Raushan Ershad.

Entrepreneurs accuse NBR of double standards

Entrepreneurs of the country are accusing the National Board of Revenue (NBR) of maintaining double standards in providing bonded warehouse facilities to the deemed exporters.

It is alleged that although in December, 1992 the NBR had decided to stop issuing bonded warehouse facilities to deemed expe ers and cancelled all such previous facilities, it had violated its own decision by allowing the facility to some deemed exporters recently. Last month the NBR al-

lowed the facilities to two packaging companies. On the otherhand, two

thread manufacturing companies - Tootal Thread Bangladesh Ltd and ETA Fill Ltd — both deemed exporters, are still enjoying the facility of bonded warehouse. In view of the recent NBR

decision the country's sewing thread manufacturing companies are now also demanding the facility. Seven thread companies of

the country are capable of producing 64.80 lakh cones of thread while the country's demand for the export-oriented garments industries is 2.01 crore cones.

The thread manufacturers now feel that given the bonded warehouse facility, they could supply thread at a cheaper rate to the garments industries and save up to Taka 80 crore a year in foreign ex-

Moreover, since two manufacturers are already enjoying the facility, other units were facing uneven competition, sources claimed.

Meanwhile, NBR sources said that the two packaging industries had been given the warehouse facilities because these two projects were designed keeping in view the fact that they would enjoy the facil-

"If they were not given the facility, they would have become unviable," NBR sources

The NBR had stopped the bonded warehouse facility after many deemed exporters had abused the privilege and evaded a huge sums of duties. As many as 198 such ex-

porters still owe Taka 228 crore in duties to the NBR. The NBR had taken actions

against them and the companies are now paying their dues in 60 instalments.

The FAP looks forward for a comprehensive water management policy for the country seeking long term solutions to the flood, erosion and other natural disasters

The plan is composed of 33 separate components, of which 16 are main components or their derivatives, 14 are supporting studies while the rest three 'non-numbered' FAP components.

Of the total, 24 components are regional studies.

Opening the conference Monday, the Agriculture Minister assured that the government had no intention of walling up, or erecting structures on all the rivers of the country.

Pointing out that the FAP studies were still under thorough analysis, he said that its implementation largely depended on consideration of all the aspects.

"The democratically elected government has taken up such a giant step forward for the first time in Bangladesh which would last many years."

Dispelling the fears vented by the FAP critics, Huq said, "We believe in transparency and openness ... we go by reasons and only by what is beneficial to the people."

Refuting the anti-FAP allegations point by point, the Minister asked the skeptics to raise their voices against the on-going desertification process in the country's southwest region and intrusion of salinity because of the withdrawal of water which resulted in epidemic of diarrhoea and

On the accusation of peoples' rejection of the FAP, he said that the studies have been consulted will the people at the local government level as well as with the MPs.

On the allegation of consultants taking away chunk of the funds, Majid-ul-Huq assured that so long the present government remained in power "not a single penny will be spent unnecessarily."

"We are quite conscious that the Ershad era has gone and it is a new era," he added.

The Irrigation Secretary said that the fears of the adverse effects caused by the FAP "were preemptive, if not imaginative."

"It is unthinkable that the democratically elected government will allow a planning outlook that will jeopardise the interest of the people," he commented on the criticism against the Flood Action Plan.

Scrutiny of the annual confidential reports (ACRs) of the BCS Economic Cadre officials could not be completed even after six sittings of the departmental promotion committee, sources said.

The slow procedural process has already caused a backlog of promotions in the cadre. About 54 posts of deputy chiefs of the cadre remain vacant.

Disgruntled officials said that they would stage a sit-in on May 25 when Prime Minis ter Begum Khaleda Zia comes to preside over the National Economic Council (NEC) meeting unless authorities complete the promotion procedures by then.

Sources said a meeting presided by the Planning Minister in December last year set the criteria for promotion of the economic cadre officials. Following this, 26 deputy

chiefs were promoted to the post of joint chief. As a result, 54 posts became vacant.

Meanwhile, those officials who passed the senior scale promotion examination as far back as 1989 could not yet be promoted to the posts of assistant chiefs due to administrative bottlenecks, sources said.

JU students end hunger strike By JU Correspondent

Some fifty activists of the Jatiyatabadi Chhatra Dal (JCD)

broke their 36-hour fast yesterday evening after the Vice Chancellor of Jahangirnagar University rescinded an order expelling two of their com-

VC Kazi Saleh Ahmed used his special powers to cancel the punitive measures taken by the JU Syndicate last November against JCD local unit organising secretary Moazzem Hossain and SM Abu Yousuf for their alleged misconduct with a hall provost.

The hunger strike by the JCD members was ended following nearly two hours of talks between the university authorities including the VC deans, the provosts and the proctor and the leaders of the JU Central Students Union (JUCSU) . Information Minister Barrister Nazmul Huda was also present during the negotiations.

The end of the hunger strike should bring back normally to the campus where the situation had become highly charged following the start of the agitation by the ruling party's students win demanding the cancellation of the punitive actions against Moazzem and Abu Yousuf.

Earlier Monday things took a dramatic turn following the en masse resignations by the member of the JUCSU and hall students unions in support of the hunger strikers' demands.

Four of the fasting students - Yousuf, Alamgir, Siraj and Zakir had to be hospitalised Monday afternoon following deterioration of their conditions. Many others were given IV saline.

An earlier attempt at peacemaking on the day by the VC had gone in vain since the students refused to accept his assurances of a reconsideration of their demands.

The fasting students had taken position in front of the university's administrative building.

for UN meet on Bosnia

WASHINGTON, May 17: The United States has rejected Russia's call for a UN ministerial meeting on Bosnia Friday to discuss peacekeeping operations in the event of a peace settlement, the State Department announce today. "We don't think that meeting should be this week," said spokesman Richard Boucher. "We fully support a properly prepared ministerial meeting on peacekeeping, one that can build on the agenda for peace that the (UN) Secretary General has come out with," he said, reports AFP.

Mazari's appeal to **Arab militants**

ISLAMABAD, May 17: Prime Minister Balkh Sher Mazari pleaded Monday with Arab militants, who use Pakistan as a base for their Islamic holy wars, to "please leave us in peace." The Algerian Embassy charged Sunday that the outlawed Salvation Front was publishing material in Pakistan urging its followers to wage a jihad, or holy war, against the Algerian government. Mazari said Pakistan has cracked down by giving all Arabs except students, diplomats and humanitarian aid workers with residency permits until May 31 to leave, reports AP.

Movement of security forces in Khagrachhari relaxed

From Staff Correspondent CHITTAGONG, May Authorities have relaxed movement of security forces in the frontier areas of Khagrachhari district, five days ahead of the 3rd round talks with the Shantibahini.

The relaxation of security movement, due to take effect from tonight, was a precondition laid by the Shantibahini to hold peace talks on May 25.

The talks will be held at the Khagrachhari Circuit House.

Officials said, authorities have ordered to withdraw eight camps of security forces and turn five others inoperative at the bordering villages of Panchhari thana. All military operations will

remain suspended during the talks, the officials added.

Hasina's call to unite against 'BNP-backed terrorism'

Awami League President Sheikh Hasina yesterday urged all the conscientious people to stand unitedly against terrorist activities "backed by the BNP government," reports UNB.

In a statement, Hasina expressed her grave concern at the killing of Chhatra League leader Rashedul Islam Ranzu, allegedly by pro-BNP elements, in Pabna yesterday (Sunday). Although this government

speaks of democracy, in practice it patronises identified goons for petty party interest, Hasina alleged. "The situation has reached

such an alarming state that none is safe. The whole nation has been held hostage in the hands of terrorists," the Opposition leader said.


