Six people were killed ar id 46 others injured in separate road mishaps in and outside the

capital yesterday. Narayanganj Correspondent reports: Two people were killed and 20 other's injured when a truck collided with a minibus at Simrail on the Dhaka-Chittagong highway Monday morning.

The victims were identified as Shamsul Haque, 30, and Imran, 28 -both passengers of the minibus - died at the Narayanganj Sadar Hospital.

The injured others were admitted to the hospital, sources said.

At 9 am on the same highway near Mograpara a pedestrian was crushed under the wheels of a speeding bus.

The victim was identified as Abul Hashem and his body sent to the Dhaka Medical College Hospital morgue for autopsy.

Our DMCH Correspondent adds: One Majeda Begum, 25, was admitted to the DMCH at 7 am Monday following an acci-

She succumbed to her injuries at 2.30 pm in the hospital, but details of the accident were not available.

UNB adds: Two people were killed and 26 others injured in two separate road accidents on the Dhaka-Aricha highway yes-

Police said truck driver Abdul Malek, 30, died on the spot and six people were injured as two trucks collided at Baliapur in Sadar thana at about 5 am.

The injured, who could not be identified, were rushed to different hospitals in Dhaka.

A minor boy, identified as Shujan, was killed and 20 peop.le were injured when a Dhakabound bus from Aricha fell into a roadside ditch near the Military Farm in Sadar thana at about 11.30 am.

Of the injured, Abdul Malek, 30, Rahim, 30, Qader, 35, and Siraj, 40, were rushed to Dhaka in critical condition.

From Page 1 Col 3 counsel Khondkar Mahbub Hossain for handing out the punishment concurrently, but granted the verbal petitions of the defence lawyers to get certified copies of the judgement.

Sarfuddin Ahmed Khan Mukul, defence counsel for Begum Raushan Ershad, prayed for granting division to his client. Similar prayers were made by Khan Saifur Rahman for his clients M A Sattar, Abdul Wadud Khan, a former MP and three others. A Malek, attorney for Rahmatullah, also prayed for better arrangements for his client in the jail.

Special Judge Ansaruddin Sikdar handed down the sentence at 2:45 pm in the Janata Tower case' after examining prosecution witnesses since February 5, 1992.

Of the witnesses, Ershad's former private secretaries Brig (Rtd) Sharif Aziz and Lt Col (Rctd) Saiful Hag had corroborated the prosecution charge of payment of Tk 10 crore, including Tk 6.5 crore in cash from Ershad's possession to Nirman International for construction of the Janata Tower.

Earlier, Ershad was brought to the court under heavy guard from the adjacent Dhaka Central Jail at 12-10 pm. Wearing a full-sleeve cream safari suit, he smartly entered the courtroom and smilingly sho-ok hands with both prosecution and defence lawyers. He looked quite fresh and healthy despite his age and solitary life in jail.

Begum Raushan Ershad was sitting beside Ershad on the dock. Wearing a white sa ree with borders of embroidered black flowers, she appeared grim and pale, looking blankly - hardly talking to her hus-

Part of the 91-page judgement was read out in the makeshift courtroom packed with prosecution and defence lawyers and security personnel.

The court premises were guarded by plainclothesmen and steel-helmeted riot police.

Ershad's brother Golam Kader Selim and his wife, and Raushan Ershad's sister Gulshan Ara and Ershad's 12-year old adopted daughter Jabeen had come but were not allowed to enter the court, ostensibly for security reasons.

The judgement came after the court examined 35 proses cution witnesses in 72 days.

General Ershad, who had grabbed power and ruled the country for nearly nine years, is facing 18 more cases, involving corruption and abuse of

"It's a triumph of the rule of law over the rule of force, fair play over a rough game," observed Attorney General Aminul Haq who was the prosecution counsel in all the three eases

that Ershad was convicted. He further said: "This suggests that Bangladesh has an impressive judicial system and within a record time we had been able to prosecute former President Ershad and others in three cases wherein nearly 100 witnesses and several hundred documents were examined. It

was a very tough task." It is easy to hold trials in a court established under martial law but not so easy to prove a case in a court of ordinary criminal jurisdiction, the Atto-

rney General added. He pointed out that Rajiv Gandhi of India was killed two years ago but the trial could not be started even now in the

court of law. On question of fairness of the trial, the Attorney General said the trial was held before a free press and many had ac-

cess to witness the proceedings. Even the High Court interfered eight times upon defence applicationis, but all the petitions were found frivolous and were

Commenting on the judgement, Khandakar Mahbub Hossain, chief counsel for Ershad, said they will move the higher court against the verdict.

"We hope the High Court will correctly evaluate the judgement and the accused will be set free", he said.

Hossain said political victimisation after changeover of the government was not unknown. He recalled that Sheikh Mujibur Rahman was convicted by a lower court in a similar case after the fall of the United Front government in the late 1950s. But the High Court had set aside the judgement.

The Attorney General was assisted by Deputy Attorney Generals Hasan Arif and Amirul Kabir Chowdhury and Advocates Obaidur Rahman Mustafa, Mir Hashmat Ali and Masud Ahmed Talukder.

Ershad was defended by an eight-member team headed by Khandakar Mahbub Hossain and Begum Raushan Ershad by Sharfuddin Khan Mukul, M A Sattar by Khan Saifur Rahman and Mohammad Rahmatullah by Abdul Malek.

Khondakar Mahbub was assisted by Yusuf Hossain Humayun, Mafizur Rahman Majumder, Nitai Roy Chowdhury, Sudhir Kumar Hazra and Sheikh Rezaul Kartm.

Overthrown from power by a mass upsurge in December 1990, Ershad (63) is already serving 10 plus 3 years in jail for possessing unauthorised arms and about Tk 2 crore which was beyond his known sources of income.

25935 Rohingyas repatriated so far, JS told

Foreign Minister ASM Mostafizur Rahman yesterday said total of 25,935 Rohingya refugees have so far been repatriated to Myanmar, reports

Replying to Sharfuddin Khasru (JP-Sylhet) in the House during question hour, the Foreign Minister said 2,50,877 Rohingya refugees took shelter in Bangladesh.

In reply to a question from Shah Md Rafigul Bari Chowdhury (JP-Sherpur) the Foreign Minister said the issue of stranded Pakistanis in Bangladesh was a bilateral one between the two countries.

The repatriation process started in January last after 18 years and since then 325 stranded Pakistanis have been repatriated, he added.

Mostafizur Rahman told Prof Rafigul Islam (AL-Jessore) that 3017 Bangladesh citizens are now in the prisons of 18 countries of the world. Of them, 2000 are in Malaysia, 361 in Pakistan, 258 in India, 115 in Saudi Arabia and 40 in Thailand.

Efforts on for realising share of assets from Pakistan: FM

Foreign Minister A S M Mostafizur Rahman yesterday told the Jattya Sangsad that the government was making every effort for realisting Bangladesh's due share of assets from Pakistan, reports BSS.

Replying to a question from Mohammad Shamsul Huq of the Awami League, the Foreign Minister said that the present democratic government was giving importance to the national interests above everything.

He pointed out that the issue of due share of assets had come up for discussion during the visit of Prime Minister Khaleda Zia to Pakistan. The two sides agreed to take steps for resolving the issue, the Foreign Minister said, and added that communication with the Pakistan government was con-

tinuing. The Foreign Minister pointed out that the issue of determining the due share of assets from Pakistan was a complicated task. However, such a complex issue could be solved through discussions and negotiation, he

The Foreign Minister said it was decided during the visit of Shaheed President Ziaur Rahman to Pakistan in 1977 that the question of sharing assets between Bangladesh and Pakistan would be scrutinised at the Foreign Secretary-level.

In 1980, the two Foreign Secretaries met in Dhaka and agreed that a working group comprising inter-ministerial representatives and experts of the two countries would examine the issue and submit a report to the Foreign Secretaries.

He, however, said despite repeated reminders from Bangla desh there was no progress in this connection.

Environment Minister Abdullah Al-Noman yesterday said that a new fisheries policy was underway which would include extension of lease period of the water bodies of the country.

The minister was addressing as chief guest, the inaugural function of the day-long World **Environment Day programme** organised by the Environmental Coalition of NGOs under the auspices of the ADAB at the Institution of Engineers yesterday morning.

The minister said that the lease period of the water bodies, now fixed at two years, would be extended to seven years.

The minister also said that the current forestry scheme of the government would be further strengthened and in future the masses would be involved in the forestry scheme.

The programme, presided over by the chairperson of the environmental coalition NGOs Kazi Faruk Ahmed, was also addressed among others by Director of ADAB Rasheda K. Chowdhury, Deputy Director of ADAB Prof Abdullah Al-Amin and Rokeya Kabir of the Nari Pragati Sangstha.

The minister said that the government would ensure people's participation in development programmes such as the Flood Action Plan (FAP). He pointed out that poverty

remained a strong barrier to the preservation of the environ-Kazi Faruk Ahmed presented a declaration of the NGOs in which they pledged to continue

their activities for developing the living standards of the poor and for a better environment. The day-long programme in-

cluded an exhibition of books. posters and videos on the environment. It was followed by a cultural programme in the evening organised by NGO staffers.
