

Labour Minister at FBCCI discussion

Growth of industry needs people's buying power

Minister for Labour and Manpower Abdul Mannan Bhutyan Thursday said the country's industrial sector cannot be made profitable unless a larger local market is created through increasing the purchasing capacity of the people.

He said real wages of the workers and employees did not increase in accordance with the increase in the productivity, although wages had increased several fold in amount.

The minister was addressing as chief guest the fourth session of the two-day National Convention of Businessmen, organised by the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI), yesterday at Hotel Sonargaon.

Expressing his optimism about an immediate improvement in the industrial relations in the country, he said labour problem was not the only problem of industrialisation. There were some more acute problems which were affecting the profitability of the industrial units, he added.

Mannan Bhuiyan also termed the existing labour laws 'defective' and said that a law commission had been set up comprising representatives from the government, employers and employees to amend the labour laws. The commission had met several times and a draft of the law would be prepared soon, he

for us to believe him." They were not against CIS border guards, including Russians, protecting the Tajik side of the border with Afghanistan, but felt a stronger CIS military input simply bolstered the present regime, "which is using Russian bayonets to eliminate its own adversaries."

Addressing a public meeting at the Dainik Bangla crossing in the city, he termed August 15 as 'victory day' for the nation. The Bharatiya Dalal Protirodh Committee organised the meeting demanding ban on the politics of the 'identified Indian agents and Awami axis.'

The NDP leader observed that Sheikh Mujibur Rahman was killed because he himself had killed thousands of political opponents, snatched the political rights of the people, buried democracy and sold out the country's independence to

He said the August changeover in 1975 gave Sheikh Hasina the opportunity to demand trial of Mujib's killers, but none, including the parents of Siraj Sikder, could come up

with similar demands. Jamaat leader Abdul Kader Mollah speaking at the rally dubbed the government 'subservient to India' and accused it of providing all help to India for turning the country into its market.

Freedom Party leader Major (retd) Bazlul Huda alleged that when the Pakistan Army cracked down on the people of this country, Sheikh Mujib had surrendered to the Pakistani authorities while the other AL leaders fled away. Nigerians start civil disobedience

LAGOS, Aug 12: Security forces patrolled near-empty streets Thursday and helicopters hovered above Lagos, which was a virtual ghost town as people stayed home to protest the military dictatorship's refusal to relinquish power, reports AP.

Human rights groups called the three-day general strike, beginning Thursday, to oppose the government of Gen Ibrahim Babangida, who voided the June 12 presidential election that was to return Nigeria to civilian rule after a decade of military dictatorship.

Businesses were closed and streets were deserted in the nation's biggest city, home to more than 6 million people and a normally bustling place with allday traffic jams.

Thousands of police and troops combed the city and guarded highway bridges, but there was no immediate repeat of the ferocious rioting that broke out last month during a similar three-day protest. More than 100 people reportedly died in Lagos during the unrest.

At least three people carrying anti-government signs were arrested early Thursday after they tried to set fire to a pile of tires, but no other incidents were immediately reported.

Government-controlled radio threatened people by reporting in its morning newscast that several companies planned to fire employees who took part in the strike. But compliance appeared to-

tal, although some people might have stayed home out of fear of more violence. Even federal government buildings were deserted. Foreign embassies also were closed. The situation was similar in

Ibadan, a city of nearly 1 million people about 60 miles (100 kilometres) to the north. But it was unclear whether people were participating in the strike in other parts of the nation, where tribal rivalries usually transcend political disputes. Lagos and Ibadan are hotbeds of anti-Babangida sentiment.

"This is just the beginning." said Clement Nwankwo, head of the Constitutional Rights Project, one of the 41 groups that called the strike. "If President Ibrahim Baba-

ngida does not leave as he has repeatedly told the world he will, then he should be ready for a full challenge from civil soci-

The French newspaper Humanite reported Thursday that Babangida is having his Riviera villa spruced up in anticipation of self-exile in France. Two swimming pools and a tennis court are being built at the villa north of Cannes, the Communist Party newspaper

The French Foreign Ministry said Babangida has not requested a visa.

Rallies banned at Jinnah's mazar

KARACHI, Aug 12: Karachi authorities today banned Independence Day rallies at the mausoleum of Pakistan's founder Mohammad Ali Jinnah, reports Reuter.

Former Prime Ministers Nawaz Sharif and Benazir Bhutto, the chief rivals in elections scheduled for October 6. had both planned to stage rallies there on Saturday.

Call to resist communal, terrorist groups

TUNGIPARA (Gopalganj). Aug 12: Speakers on the third day of a week-long series of discussions in observance of Bangabandhu Sheikh Mujibur Rahman's 18th death anniversary here called for resisting the communal and terrorist groups with a view to establishing rule of law in the country.

For the establishment of rule of law, they said, the Constitution must be free from all kinds of black laws, including the Indemnity Act.

Held at the G P High School ground under the chairmanship of Sheikh Abdullah, the meeting was addressed by former Justice K M Sobhan, Prof Kabir Choudhury, Abdul Kader Siddiqui BU, Prof Strajul Islam Chouhury and others.

K M Sobhan, in his speech, remarked that the communal forces were holding the government hostage and were disturbing communal harmony in the society. These evil forces had emerged soon after Bangabandhu was murdered by 'the state-backed terrorists, he said adding "Since then the law had not been allowed to take its own course."

Prof Kabir Choudhury said that the process of denying Bangabandhu's contributions started soon after his assassination. But none can suppress the fact that Bangabandhu is the architect of independent Bangladesh, he commented,

In this first special drive of 1993-94 financial year, total 01 industrial, 06 commercial, 401 domestic (982 kitchens) connections have been disconnected up to 11-8-93.

All esteemed consumers are requested to pay the arrear gas bills immediately and show the payment receipt to the disconnection squad on the place of gas use. On production of the bill payment receipt by the disconnected consumer at the concerned zone/office of the company by 7-00 pm on the day, steps will be taken for immediate restoration of his line.

If the reconnection is not taken within 3 (three) months of disconnection, the gas line will be permanently disconnected with cancellation of gas supply contract.
