Polls under caretaker govt unconstitutional

B Chowdhury tells Jubo Dal rally

Deputy Leader of the House Prof A Q M Badruddoza Chowdhury yesterday termed the Awami League demand for holding parliamentary elections under a neutral caretaker government as unconstitutional and said it did not conform with the democratic norms and practices, reports

He was speaking as the chief guest at the conference of Dhanmondi thana branch of the Dhaka City Jatiyatabadi Jubo Dal at Dhanmondi ground

Prof Chowdhury said a demand for holding the election under a caretaker government could only take place if there were a military government in the helm of affairs or a government that came to power by toppling an elected one.

"Ours is a democratically elected government and it was voted to power by the people of this country," Prof Chowdhury said.

The Deputy Leader of the House was critical of the Awami League government and said they were doing politics on the shoulders of the Jatiya Party. He said how the Awami League and the Jatiya Party could put forward identical programmes.

He urged the Jatiya Party leaders to beg apology for their misdeeds during their nine vears of rule. He wondered how could Jatiya Party demand release of their leader on the day when they killed Noor Hossain.

Presided over by Abu Saveed Khan Khokan, convenor of the Dhanmondi thana Jubo Dal, the function was also addressed, among others, by Mayor of Dhaka City

Chanpa murder . No eyewitness, IO tells court

BARISAL, Nov 17: CID Inspector Bimal Kumar Das was cross-examined on the last day of the second-phase of trial in the sensational Chanpa murder case at the District and Sessions Judge's court today (Wednesday), reports UNB.

Bimal told the court that he had investigated the case from October 16, 1989 to May 24. 1990 and according to information from accused Kamal, it appeared that housewife Faujia Rahman Chanpa was killed by a group of people

He had filed the chargesheet against the accused persons on May 24, 1990 under Sections 302, 307, 201 and 34, he said.

Replying to cross examination of Advocate Serajul Haq. Bimal informed the court that he did not get any eyewitness of the murder, but in the chargesheet said that the accused persons had entered the room of Chanpa by breaking the

From Page 1 Col 7 refrained from approving the technical assistance and appointing the consultants since it considered the action plan as unacceptable.

The reasons for disagreement with the action plan, as stated by some concerned government officials, include the possibility of labour unrest due to retrenchment of 2200 workers of the BIWTC under the manpower rationalisation plan and the adverse effect of trimming down the fleet size and withdrawal of non-profitable river transport services provided in the fleet restructuring plan.

The officials also felt that the interest rate on the credit (11.5 per cent) is too high and would further burden the debt-ridden corporation.

On the contrary, the World Bank argues the reforms are imperative if the BIWTC is to attain financial viability. Regarding reduction of the fleet size. the WB believes, this would not materially affect the people at large since one of the main ob jectives of the project is to encourage development of the country's boat sector

Regarding the objections concerning the rate of interest the WB expressed its surprise. saying that it was not clear why the BIWTC's management deemed it more beneficial to borrow funds for its rehabilita tion at an interest rate of 15 per cent from the commercial banks rather than from the govern-

ment at 11.5 per cent, as provided under the SLA (subsidiary loan agreement).

A concerned official observed that the action plan relating to organisational restructuring would affect the interests of some corrupt officials of the ministry and the corporation and that's why they were opposing the plans even at the cost of cancellation of the project itself.

However, the government being insisted by the Ministry of Shipping, requested the WB to rationalise the action plans. The WB refused to go for any formal rationalisation saying that if needed it might be done 'during the course of implemen-

tation of the project. The International Development Agency (IDA) credit for the project is about 45 million dollars while the Finnish International Development Agency (FINNIDA) and Japan agreed to provide 5 and 0.7 million dollars respectively as grants for the project. The government's own contribution was fixed at

13.5 million US dollar The project, IWT-3, was aimed at improving waterway safety and environmental controls, strengthening the inland water transport infrastructure. streamlining the financial and operational aspects of the BI-WTC and BIWTA and encouraging development of the country's boat sector among other


During the meeting the members of the committee after detailed discussion on the privileges of the Jatiya Sangsad Members observed that a specific law would have to be enacted in this regard.

3 JCD activists held from DU campus

Three Jativatabadi Chhatra Dal (JCD) activists were held vesterday from the Dhaka University campus when they attempted to evade police arrest by firing at them.

Police also recovered a revolver and six rounds of ammunition from the possession of one of the arrested trios. They were identified as: Md Tareguzzaman Utpal, 24, Sarwar Ahmed Litu, 24 and AKM Solaiman Ami 25.

Campus sources said that the three arrested belonged to the Ilias group of the JCD and were students of the Dhaka University.

The trouble erupted following an assault on a TSC employee, Din Mohammad Dilu, vesterday afternoon, witnesses said. Students present at the scene instantly protested the at-

tack on Dilu, allegedly for a trivial matter. A heated exchange between the two groups followed, witnesses added.

Some students, reportedly belonging to the Bangladesh Chhatra League (M-I), beat up one of the attackers who was later handed over to the patrol

Two other comrades of Utpal tried to flee the scene through the Suhrahwardy Uddyan, opposite the TSC, but were pursued by police.

A police handout said that the fleeing students shot at them twice but failed to avoid arrest since policemen from the nearby Police Control Room instantly cordoned off the whole

A case was lodged with the Ramna police and the trio was being interrogated, police said.

From Page 1 Col 7 the victim himself. Sikder had arrived at ZIA at around 1:00 pm on a Thai flight from Singapore. He was accompanied by two foreign buyers.

They said while passing through the green channel of the ZIA Customs, a Customs official indecently pulled the bag of one of the two foreign ladies accompanying Sikder on the pretext of checking it.

The lady, of Singapore nationality, was taken aback by the manners of the Customs man who, she said, had also brushed her Breasts with his elbow. At this Sikder intervened, and an altercation ensued with some other Customs

At one stage, a Customs offi cer hit Sikder on his face and chest and other colleagues also joined the fray and kept assaulting Sikder. They also ignored his CIP card. An Assistant Collector held Sikder from behind while two Customs sepoys severely roughed him

Soon afterwards, a civil aviation security man. Zakin Hossain, unlawfully put hand cuffs on Sikder, dragged him to a room and tied him to a chair. Sikder, who received bruises on different parts of his body was also bleeding through his nose and mouth. Two of his

teeth were also damaged. Sikder's wife, who had gone to receive her husband, witnessed the whole incident from outside the glass doors. All her screaming protests went in vain. She wasn't allowed to see her husband inside the restricted enclosure until around

3:30 pm. "While she was begging the Customs officials to let her husband go," Redwan said, "they kept on laughing and making unkind remarks. They would not even allow him go out and seek treatment for the bleeding."

Finally, Additional Collector of Customs Hafizul Kabir arrived and Sikder was allowed to go - but only after forcing Sikder to sign a blank paper, at around 4 pm. "They made him sign in the blank piece of paper so that they could make out a false statement for their own defence," Redwan added.

"I have known Sikder for quite a long time and I have never seen him drunk," Redwan told the journalists. "But the Customs men tried to portray

him as a reckless, drunk person, which simply tantamounts to an assassination of his

CIP members of the BGMEA about 16 in all, as a token of their protest, surrendered their cards to the government during the press conference. "This incident only proves these cards are not worth anything," one of

The BGMEA president, placing his charter of demands. said there was a bad reputation of the Customs and many foreign buyers and investors were losing interest in Bangladesh after visiting the country and encountering such harassment.

He urged the government to ensure good and courteous behaviour by the Customs offi-

He also said that since exporters and other businessmen dealing with international clients had to make frequent foreign trips, a special channel on counter should be introduced at the airport. At least, there should be some provision for special handling of such

travellers, Redwan said. "We have taken this incident seriously. If the government fails to meet our demands by Saturday, the BGMEA would announce its next course of ac-

tion Sunday evening." Redwan also said he and his association members had also held discussions with the Home Minister and the State Minister for Civil Aviation and they both assured prompt action. A fourman probe has also been constituted. Redwan said.

More than fifty leading garments manufacturers and exporters were also present at the press conference.

Ambia apprised the Prime Minister that she had applied for the loan to HBFC in 1981 to construct a house. After failing to get any loan from the HBFC. she borrowed some money and constructed a one-story building on her own.

But one morning in January 982, some HBFC men came to Ambia and wanted to know why she did not construct her house as per the plan of the HBFC. The HBFC officials also told her that she had taken money from the corporation.

Later, it was found that one Bulbul Ahmed of West Razabazar had fraudulently withdrawn Taka one lakh 53 thousand sanctioned against Ambia's plot

Bulbul Ahmed, after being caught, confessed his guilt and promised to the concerned authority that he would repay the

money with interest. Ambia said, in the mean time, the HBFC filed a case against her asking to repay the loan and the interest, which now stood at Taka three lakh 25

From Page 1 Col 4 The corporation decided to stop further distribution only after detailed tests at the Atomic Energy Commission and in the US in April confirmed beyond doubt that the consign-

ment contained excessively high

levels of the toxic substances.

However, even after that a sack of the toxic fertilizer, in its original pecking, was purchased by a visiting US Greenpeace activist during a field investigation to Dinajpur late last year. The probe body recommended legal actions against

the Washington-based suppli-

ers, MS Transcontinental Imex,

and punitive actions against the

officials involved in the import and subsequent distribution of the hazardous material. It also suggested initiating a long-term study to look into the

environmental health effects in areas where it was used. On November 1 last, the US Federal Court in South Carolina 'fined Stoller Chemical Company, for processing the industrial wastes, and Southwire Corp for manufacturing the toxic fertilizer, according to US government sources, familiar with the proceedings, here. The case was filed by the EPA and was prosecuted by the Assistant

US Attorney. The judge ordered the two companies to pay a penalty of one million dollars, of which, six lakh dollars was set aside for the return, treatment and disposal of the toxic fertilizer.

Observers feel that immediate steps should be taken to implement the probe body recommendations and safety measures should be put in place so that such incidents do not recur in the future. The government should also

look into the option of suing the US companies in American courts seeking monetary damages, they added.
