

Hasina threatens to resign

The Speaker allowed a twohour discussion on the issue on November 30.

"If my clarification is not accepted. I am sorry to say that ! will resign from Parliament, Hasina said to the Speaker. demanding the withdrawal of

his ruling. The / Speaker, however. strongly refused to entertain Hasina's demand for reconsideration of the ruling, saving, "I cannot change my decision and you cannot challenge the Speaker's ruling under the JS rules of procedure."

Tk 80cr okayed for second TV channel

A meeting of the Executive Committee of the National Economic Council (ECNEC) yesterday approved a Tk 80 crore project for setting up the country's second national television channel in Dhaka, reports UNB.

The project involving Tk 40 crore in foreign exchange is expected to be completed by December, 1994.

The new TV channel will telecast 18 hours programmes. mainly education-oriented. The BBC and CNN programmes will also be shifted from the present channel to the new one.

An official handout said country's 90 per cent area will be brought under the coverage of the second channel. The present channel also covers 90 per cent area of the country.






