



This, however, does not constitute an official suspension of World Bank (WB) credit to the key public sector agency in irrigation, flood control and water



Biman may drop Tokyo flight in December

Biman Bangladesh Airlines is likely to suspend its flights to Tokyo, a loss-making sector from next month. This will coincide with the inauguration of the New York flight, scheduled from Dec 17, Biman officials hinted.

"The route is now a white elephant for Biman which has been incurring losses since the operation started in 1980," a senior Biman official told The Daily Star.

The source said that the Tokyo flight was suspended from time to time but later resumed in the hope the route would become a viable one eventually.

The national carrier started flying to Japan on May 28, 1980 but the sector was suspended on June 1, 1981. The route was resumed again on November 1,1990 but continued to be most unprofitable for

Biman's market research wing identified the once-aweek frequency and the expensive cost of living in Japan - for which the airline has to pay higher bills for its crew in the form of allowances- as the major causes for the losses in this sector.

"Most of the businessmen cannot afford a one week's stay in Japan because it is an expensive city. So they avail other airlines for an early re-

ADB to fund study for rly reform

The Bangladesh Railway (BR) and the Asian Development Bank (ADB) are jointly undertaking a one-year technical study from January next to form the basis of structural reform of the railway, to be introduced in 1995.

According to official sources, the US 1.4 million dollar studies - funded by the ADB - will be carried out by high railway officials and ADB experts to gather details of the railway administration with a view to turning the BR into a more commercially viable organisation from its present bureaucratic set-up.


