Romania celebrates Nat'l Day Dec 1

Romanians across the world

will celebrate their new National Day on December 1 marking the ouster of the communist regime and transition to democracy. Romanian Ambassador in Bangladesh Dumitru Mocioiu said in Dhaka yesterday. Since the ouster of Nicolae

Ceausescu by a popular revolt in December 1989, the Romanians observe December 1 as their National Day which earlier used to be celebrated on August 23, Mocioiu told newsmen at a press briefing at his office ahead of the occasion.

The Embassy in Dhaka will also celebrate the day, he

He said that Romania witnessed massive changes since the 1989 revolt after which more than 80 per cent lands were returned to the former

He said that ties between Bangladesh and Romania are good but there remain many prospective areas to be explored.

Currently there is about five million dollar trade both ways between the two countries. Bangladesh exports raw jute and leather and imports textile machinery from that country.

"Romania is now a democratic country like Bangladesh and both countries established democracy in almost a similar way," the Ambassador said, adding: "Crises in the two countries are also common."

"Romania is still passing a transitional period after years of totalitarian communist rule." Mocioiu remarked.

The volume of trade between the two countries can be higher if the entrepreneurs from both sides avail the simplified economic policy.

Ukraine dismisses Russian threats

KIEV, Nov 27: Ukrainian officials dismissed Russian threats to stop servicing former Soviet missiles on their territory as irresponsible and defended their parliament's stiff conditions for getting rid of nuclear weapons. given effect through promulgation of an ordinance," said a source in the Ministry of Finance.

The Act, enacted in 1990. was aimed at expediting the loan recovery activities of the financial institutions and the nationalised banks. All such banks and institutions were covered by the Act except the BKB and the RKUB. These two banks have been pursuing their loan recovery activities through the Public Demands Recovery (PDR) Act of 1913.

According to authorities concerned, the need to bring these two banks under the ambit of the Financial Loan Courts has become imperative for streamlining and establishing disci pline in the loan recovery systems. "This will help to improve the loan recovery situation. they said.

The BKB is the major financial institution that provides loans in the agricultural sector while in the Rajshahi division, the RKUB is the only such bank that offers agricultural loans.

The BKB's loan disbursement programme in the fiscal 1992-93 was for Tk 601.41 crore while the RKUB had a target to provide loans amounting 130 crore taka. Unrealised loans of the BKB
