

Parliament becomes vibrant again

The Jatiya Sangsad returned to its normal tenor and pulsated with its vibrant vigour as normal proceedings dominated a packed House yesterday.

The five-day stalemate that loomed over the Sangsad and ended through a consensus between the Opposition and the Treasury benches late Sunday night was reflected in yesterday's proceedings when it was business as usual. The Jatiya Party MPs who did not return on Sunday night after the understanding also came back in full strength.

The House which sat after 4 pm continued till 9:15 pm with the usual recess for prayers.

Leaders of the Opposition Sheikh Hasina did not appear in the House, while Leader of the House and Prime Minister Begum Khaleda Zia entered the Sangsad at 8 pm. She, however, did not seek the floor.

The cabinet yesterday approved the draft of the Companies Act-1993 by repealing the Companies Act of 1913, reports

The approval was given at the regular weekly meeting of the cabinet held at the Bangabhaban with Prime Minister Begum Khaleda Zia in the chair The step has been taken in

line with the declaration of the Prime Minister to modify the Companies Act of 1913 to make it more amenable to the principles of market economy The previous BNP-govern-

ment had initiated the re-structuring of the Companies Act of 1913, an official handout said adding, but no progress was made in this regard during the ast regime. The new Companies Act is

aimed at making the law more effective and updated to suit the demand of the hour.

Besides, it will help avoid unnecessary bureaucratic control in running companies, create more profit and ensure accountability and transparency in the management of the companies. It will also facilitate private foreign investment in the companies and strengthen the share-market. The cabinet also approved



SAARC FMs' meet to focus on poverty alleviation

Poverty alleviation among member states of South Asia is likely to dominate the two-day SAARC Council of Ministers meeting beginning in Dhaka on December 4.

The conference, which will be inaugurated by Prime Minister and current chairperson of the SAARC, Begum Khaleda Zia, will also deliberate at length on collective measures for economic development of the region. The participating foreign ministers will also discuss the Integrated Programme of Action (IPA) and other related issues.

Briefing newsmen on the eve of the SAARC Council of Ministers meeting yesterday Foreign Secretary Reaz Rahman described the conference as 'very significant' and said that it was being held at the mid-point of the last summit held in Bangladesh and the next one that will be held in India.

"Poverty alleviation is a crucial and common element of the SAARC countries and poses the greatest challenge to the member nations," Reaz affirmed. He also said the conference shall endeavour to reach broad-based understanding for greater economic cooperation.

Reaz said that all the foreign ministers of the SAARC countries will be attending the conference, which will be the 13th such meeting since the incep-

Senior officials of the SAARC countries who have already started arriving in the city will begin their meeting in the Bangladesh capital from today. The officials shall prepare the ground for the foreign secretaries meeting under the aegis of the standing committee just ahead of the foreign ministers' conference. The standing committee in turn will prepare the

meeting. The Foreign Secretary told newsmen that among other issues, the report on the South Asia Commission on Poverty. endorsed at the last summit the progress of the South Asian Preferential Trade Agreement (SAPTA) and the South Asian Development Fund (SADF) will figure in the SAARC Foreign Ministers meet.

Biman may open flight to NY via Moscow

Biman Bangladesh Airlines is planning to operate its second flight to New York via Moscow as talks with KLM on traffic rights failed. Biman sources said.

KLM, the Dutch national carrier, demanded four slots from Dhaka when Biman requested operation rights for two more flights from Amsterdam, which stalled the discussion The KLM, executive left

Dhaka without signing any agreement despite Bangladesh authorities' offer to the Dutch carrier three flights from Dhaka against the two flights for Biman. But KLM demanded rights to operate four weekly flights from Dhaka.

The Dutch airlines which was the maintenance agency for Biman for several years lost last year's contract bid to Alitalia. Biman officials said that this could be one of the causes of KLM's rigid stance during talks.

"Traffic movement to and from Moscow has increased considerably following the collapse of the Soviet Union which is now a potential aviation sector," a Biman executive told The Daily Star.

The national carrier Biman has the traffic right from Moscow to New York since 1972 but Biman did not so far operate on this route.

Biman starts operating to New York via New Delhi-Dubai-Amsterdam from December 17.

"The authorities will try again for the second slot in Amsterdam as at least two flights through the same route are more viable," another Biman official said adding 'Moscow will be our second choice."

Russian international airlines, Aeroflot, is currently operating to six American cities including New York, Washington, San Francisco, Miami, Anchorage and Chicago. Considering the increasing traffic Aeroflot authorities are planning to start flights to Los Angeles, Seattle, Orlando, Dallas and Houston.

In 1991 Aeroflot's flights to New York from Moscow were only seven which now have risen to 27 a week, they said. "This indicates the growing

traffic between Moscow and New York," an official of a travel agency who has been monitoring the passengers movement told The Daily Star. Meanwhile, Biman will re-

Fatah activists announce armed struggle in Gaza

KHAN YUNES (Occupied Gaza Strip), Nov 29: Guerillas from Yasser Arafat's Fatah Movement announced today they were taking up the armed struggle in Gaza again after Israel stepped up the hunt for them, reports AFP.

Arafat ordered a ceasefire following the signing of the September 13 PLO autonomy accord and his Fatah Hawks had observed it until today.

"We are announcing this be-

cause Israel has broken the agreement and as revenge for Ahmad Abu Rish," a masked militant told a press conference. Abu Rish, one of about 30 Fatah men who turned himself

to the Israelis and was taken off

the wanted list, was killed along with a bystander Sunday night. Two other fighters, who are still wanted, came to his house in Khan Yunes refugee camp chased by elite Israeli undercover troops, Palestinian sour-
