

Some other sources said that BCL along with other left leaning parties may contest the DUCSU elections under the banner of the Sampradayekota Birodhi Chhatra Samaj.

Meanwhile, some unidentified gunmen fired a gun shot near the administrative building on the university campus yesterday noon.

Tk 100cr allocated in ADP for uplift of thanas: JS told
