Legal Notice for the flat owners of Concord Tower situated at 113, Kazi Nazrul Islam Avenue, Dhaka

It is hereby notified to all the flat owners of Concord Tower situated at the above address that on 9.4.90 the original owners of holding No. 113, Kazi Nazrul Islam Avenue, Mr. Mukarram Husain Khan and others cancelled an Agreement dated 9.5.80 by which they have taken back 2' feet wide strip of land contributed by them from their portion of holding adjacent to 8' feet wide Ejmal road situated on the south side of their property. Thus except for using the 8' feet wide Ejmal road for the purpose of visiting the graveyard, Mr. Mukarram Husain Khan and others have lost their right to use the road for any other purpose. As such the owners of Concord Tower accepted the position of the 8' feet wide Ejmal road situated on the south side of holding No. 113 and approved a plan from Rajuk showing the entrance road to the Tower from the northern side of their holding. This was amply clarified by Concord to the prospective flat owners when they distributed a printed brochure clearly indicating the entrance from the northern end of the holding No. 113, Kazi Nazrul Islam Avenue, so that there is no confusion about the entrance road. Whereas my client Mrs. Saecda Khan retained her right to use the 8' feet wide Ejmal road with her contributed 2' feet land given from her holding No. 112, Kazi Nazrul Islam Avenue for the purpose of entrance to her private property as well as for visiting the graveyard. When it became known that Mr. Mukarram Husain Khan and others were trying to use this 8' feet Ejmal road for their entrance into the Concord Tower along with other flat owners, my client had no alternative but to seek the relief from the Court and a case No. 84/94 was filed in the Court of 1st Sub-Judge, Dhaka seeking an injunction to restrict the flat owners from using this road for their entrance into the flats of Concord Towers, the decision of which is still pending in the court of 1st Sub-Judge. Under the above circumstances, if any flat owner uses this road under litigation, they will do so at their own risk as they will also be liable for legal prosecution and will have to pay any compensation that may be awarded by the Court.
