COMILLA, Sept 21: Phen sidyl syrup, a banned item, has flooded the markets of the district raising the number of addicts, reports UNB.

Local people alleged that smuggling of Indian phensidyl has increased alarmingly by a section of organised gangs.

About 40,000 bottles of phensidyl syrup have been seized from the border areas of the district by the task force and law enforcing agency from the month of January to August this year.

Youths and teenagers, who can not afford costly drugs, are addicted to Phensidyl. A bottle of syrup cost Tk 40 in the town and Tk 50 in the villages.

The contraband is being smuggled from India through different routes of the border in and around Comilla in the code name of "Dail". local people complained.

A section of dishonest drug traders in the town are involved in the smuggling of Phensidyl which is sent to the remote areas through their agents, they alleged.

Besides drug stores, the syrup is available in stationary shops. Some people are engaged in supplying the drug to the door steps of the addicts to earn additional profit,

Local people urged the au thorities to take necessary steps to check the smuggling and selling of Phensidyl syrup.

3000 fire incidents

Property worth Tk 8 cr gutted in Kushtia

KUSHTIA, Sept 21: Over three thousand fire incidents took place in Kushtia district during last 15 years causing losses over Taka eight crore. Out of six thanas in the district five thanas have no fire stations. Fire incidents taking place in those thanas can not be controlled immediately. Fire Brigade teams can reach those places from Kushtia town but at much slower pace due to bad communication system. The thanas which have no fire Brigade services are Daulatpur, Bheramara, Mirpur, Kumarkhali and Khoksa. The fire Brigade services of Kushtia sadar are pretty old and not equipped properly to cope with any mammoth fire incidents. With inadequate man power and other logistics the fire Brigade of Kushtia can do little when messages come from Daulatpur or Khoksa which are situated about 30 miles and 15 miles from Kushtia town

The fire Brigade source here confirmed 1348 fire incidents causing losses of properties worth Taka one crore 16 lakh 25 thousand while the workers of fire Brigade services claimed to have saved properties from fire worth over Taka two crore 40 lakh 20 thousand. However, according to

unofficial reports, number of fire incidents taking place in the district during last 15 years were over three thousand and/losses of properties were estimated to be about Taka eight crore. Kushtia Fire Brigade Source

said, due to bad communication they can not reach remote areas of the district. A source from Kumarkhali said that all formalities for setting up of a Fire Brigade at Kumarkhali was completed in 1980 but till now the proposed fire brigade station could not be established. A source from Bheramara said that Prime Minister Begum Khaleda Zia assured of setting up of a fire Brigade station some where between Bheramara and Daulatpur thanas

Sharp rise in price of fertilizer

SUNAMGANJ, Sept 21 Price of urea fertilizer in the district has shot up abnormally owing to artificial crisis in the market causing untold sufferings particularly to the marginal farmers, says UNB.

Urea is now being sold at Tk 235 per bag instead of government price of Tk 176.25.

Dealers said, a section of dishonest fertilizer traders have created the artificial scarcity to earn extra profit. They alleged that four cargo ships loaded with fertilizer bound for Sylhet was sent to Bogra. As a result of this severe crisis of fertilizer is prevailing in greater Sylhet.

A source said six fertilizer factories of BCIC set a record by producing 22 lakh metric tons of fertilizers. 90 per cent of which is urea. These factories produce 6.000 metric tons of fertilizer every day on an average.

40 per cent people suffer from various diseases in Jamalpur

40 per cent people are suffering from various diseases in seven thanas of the district according to official sources.

Different sorts of diseases like goitre, diarrhoea, chicken pox, polio, titenus, Dysentery, Malaria, Penumonia, hooping coup, blindless, skin diseases, grave, liver cancer, and others affect hundreds of people. specially poor, every year. Due to shortage of iodine in

salt and water most of the women in Jamalpur district have developed goitre, a disease which can not be cured but can only be prevented through regular intake of iodized salt with food. Leprosy. another deadly disease attacked about five per cent people of the district, according to health officials. Malnutrition, a common disease has attacked a large number of people of the district. Due to malnutrition, children die mostly due to lack of proper treatment. When contacted, a source of the district Health Department informed this correspondent that families who live below poverty line can not afford minimum balanced diet.
