The last people to be executed for treason were during World War II, "and that was for collaborating with the Germans," said Terry Charman, a historian at the Imperial War Museum.

Bangladesh Polytechnic Teachers Association (BPTA) has called off their strike following a satisfactory discussion with Education Minister Jamiruddin Sircar yesterday, reports BSS.

The teachers of the Polytechnic Institutes of the country will join their duties on October 8, and take extra classes to compensate the losses due to strike, according to an official handout.

Govt refutes Hasina's allegation

The government yesterday described as "baseless" a recent statement of Awami League chief and Leader of the Opposition in Parliament Sheikh Hasina about irregularities and misappropriations of funds for checking erosion of the river Padma in Louhajang under Munshiganj district, reports BSS.

An official handout said tha Sheikh Hasina's allegations about corruption, sanction of an amount of Tk 19 crore and an expenditure of only Tk three crore against it and misappropriation of the fund were "baseless". How could there be misappropriation of Tk three crore when the government had not made any allocation of funds, the government asked.

The handout said river ero sion is a regular phenomenon in the country but of late the extent is growing high. No government has the financial capability to check such erosion when all the gates of the Farakka barrage are opened during the monsoon.

It said the government is fully aware of the erosion prob lem of Louhajang and in December last year the Prime Minister had visited the erosion-hit areas and gave orders to check it. Following the directive of the Prime Minister Tk 59 crore "preservation of the left bank of the river Padma in Louhajang of Munshiganj" project brief was prepared. The implementation of this project can come only after approval of the Planning Commission, and availability of fund from the donors.

The handout said the Water Resources Minister and concerned officials and engineers had visited the site of erosion and taken steps for approval of

the project expeditiously. Besides, the minister reviewed the erosion situation at a meeting at the Secretariat on September 17 and gave directives to the Water Development Board to start work within three days as an emergency measure.

The minister also sanc tioned immediately an amount of Tk one crore for the project to face the calamity.

The Water Development Board has already formed a committee and issued directives to take all possible steps. Apart from this, an amount of Tk 27 lakh was sanctioned in the last year while another amount of Tk 50 lakh this year to save Munshigani town from river crosion.

Therefore, the government said such comments made by the Leader of the Opposition without verifying facts is "really unfortunate". It urged the people not to be misled by such a statement which is far from the reality ...

No new death from plague in India

NEW DELHI. Oct 4: For the first time in two weeks, no deaths were reported today in India's plague, and the government and the World Health Organisation said the epidemic will soon end, reports AP.

The country will be free from the plague problem by mid-October, Health Secretary MS Dayal told reporters.

Although the pneumonic plague has killed at least 61 people, Dayal said that nearly 95 per cent of the people being treated for plague symptoms across the country have tested negative.

"The pneumonic plague will almost be nil by mid-October, said Dr. Navrayan Keshary Shah, WHO's representative to India.

However, Shah also said in an interview that it will probably take longer to stop the bubonic plague.

She hit her several times with the kitchen tool before slashing her throat. She then dragged the lifeless body to the girl's bedroom and hid it partially under the bed. Thereupon she went about cleaning the house of all traces of blood, even using detergents to sweep and mop the floor absolutely clean. She also washed

Unmoved by her crime, she went about her daily chores as if nothing had happened Several hours later, around 2 in the afternoon. Shoma's mother Nilufar Chowdhury returned from her college. When asked about the daughter's whereabouts. Romena told Mrs. Chowdhury that she had gone out.

Then Romena carried hot water to the bathroom for Mrs. Chowdhury to bathe.

After this Mrs. Chowdhury sat down for lunch. At one point she called Romena from the kitchen and rebuked her about the quality of the fried fish, one of the dishes. Atonce, Romena rushed to the kitchen, picked up the boti and hit Mrs. Chowdhury. Soon afterwards, the mother, too, had died the way her daughter did

some hours earlier. However, after the second murder Romena realised that she had done something wrong and that she should escape. But before fleeing the scene, she felt she should take way the gold ornaments and/ money kept in the chest of di wers in Mrs. Chowdhury's room, lest someone else

should come and steal those. When asked by this correspondent-in the presence of

many top police officials-Romena said she knew that she would be caught. She also said that she neither had any regrets nor did she once feel any remorse.

The gold ornaments recov ered from Romena's possession by police included at least three expensive necklaces, several gold chains, bangles, a Janua set, three rings, several earrings and a ladies watch. The recovered cash, about Tk. 7000, was mostly in Tk.500 and fresh Tk 100 notes.

Police also brought one of Romena's relatives from Char Govinda with them to the DB

After committing the two murders, Romena had gone into hiding and took shelter in the house of her step sister at Char Gobinda village under Shibalaya thana in Manikgani. She hails from village Khasbogila under Nagarpur thana of

She was arrested at around 10:30 pm.

Earlier, police raided Romena's house in Khasbogila and picked up her two brothers-in-law - Hashem Ali and Nabu Sheikh — and a cousin. Dilip Sheikh: in the interest of investigation and to know the whereabouts of Romena. She is known in her village as Nomi

According to a message received in Dhaka from the Spanish capital, he pointed out a lack of coordination mechanism among the major industrialised countries had been responsible for their macroeconomic imbalances and structural rigidities.

"It is both just and desirable that the cost of adjustment is shared equitably by both the developing and the industrial nations," Rahman said stressing that the major economic powers should strengthen their fiscal and monetary poli-

In the interest of stabilising the international economic situation, he added, the Fund should exercise a more effective surveillance over the macroeconomic policies of the major industrial countries.

Noting the private equity flows to developing countries increased recently. Rahman said the poorest among those countries which need official assistance for investment in infrastructure and social sectors are yet to see such resource flows.

"I, therefore, strongly urge that IDA resources be allocated solely for the poorest and least developed countries with weak institutional and technical capabilities," he told the meeting attended by the Spanish king,

Bank and the Fund.

He also stressed careful consideration of the specific socio-political and cultural dimensions of individual, countries in providing policy advice by the Bretton Woods institutions in the effort to combat world poverty.

Provision of adequate social safety nets for the vulnerable groups and improvements of health, education and investment in human capital development also got emphasis in his statement.

The WB-IMF chairman noted with satisfaction that the world economic activity, stimulated by the successful conclusion of the Uruguay Round, represents an opportunity for all nations to push ahead with solid economic programmes.

A police spokesman told the news agency that the factory in the industrial town of Jhansi was levelled by the powerful blast and several nearby buildings were damaged, reports AFP.

140 hurt in Japanese quake

TOKYO, Oct 4: Northern Japan was rocked by a strong undersea earthquake Tuesday night, shaking buildings as far away as Tokyo. Tidal wave warnings were issued for the Pacific. The Central Meteorological Agency estimated the magnitude of the quake at 7.9, making it the strongest to hit Japan in 26 years. A total of about 140 people were injured. almost all in the northernmost main island of Hokkaido, Kyodo News Service reported. Police reported some minor damage but no deaths, reports AP.
